## RE: Non-Market Housing at Little Mountain

I am writing on behalf of Vancouver City Council to thank the Province of British Columbia for the funding that B.C. Housing has committed to making the housing located at the Little Mountain site as affordable as possible.

The immediate funding requirements and need for non-market housing in Vancouver are substantial, and City Council is grateful for the 282 units of social housing planned for Little Mountain, including the replacement of the 224 public housing units, the 48 new social housing units that will be owned by the City of Vancouver, and the 10 units that will be owned by the Musqueam Indian Band. Building these new homes will help ease some of the tremendous pressure low-income earners are faced with when trying to find safe and secure housing in Vancouver.

Vancouver City Council appreciates the provincial government's support for building more non-market housing in Vancouver. Both City Council and staff are committed to working with B.C. Housing and Holborn Developments to increase non-market housing at the Little Mountain site.

Housing has allocated and committed to making the housing on the Little Mountain site as affordable as possible, and for the 282 units of social housing planned for the site, including the replacement of the 224 public housing units, the 48 new social housing units that will be owned by the City of Vancouver and the 10 units that will be owned by the Musqueam Nation;

FURTHER THAT this letter will also express the City of Vancouver's ongoing commitment to work with B.C. Housing and the landowner to increase affordable housing in the city of Vancouver.

Dear Members of the Riley Park—South Cambie Community Vision Committee:

### Re: Transparency and Accountability at Little Mountain

I am writing this letter on behalf of Vancouver City Council to affirm our support for the Freedom of Information application submitted by your citizens' advisory group to have the Little Mountain Housing site contract between BC Housing and Holborn Developments made public. City Council shares your belief that disclosing the documents is in the public interest.

On February 12, City Council passed a motion stating that the disclosure of the contract between BC Housing and Holborn Developments would make available relevant information that serves the public interest related to demonstrating sound financial management by government agencies and transparency in financial dealings. Additionally, City Council believes the information in the contract will be instructive to the City of Vancouver in the consideration of future land sales and housing developments.

All levels of government are mandated to conduct their operations as transparently as possible so that members of the public can evaluate performance and hold their elected representatives accountable. The withholding of information, such as the contract and agreement for the sale of the Little Mountain Housing site, makes it difficult to evaluate if the terms of the deal were in the public interest, which in turn erodes public trust in government institutions.

For the reasons outlined in this letter, City Council supports the members of the Riley Park—South Cambie Community Vision Committee in their ongoing pursuit to have the contract and agreement for the sale of the Little Mountain Housing site made public.
