Re: **Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")**

I am responding to your request of October 16, 2020 for:

Record of confirmation that on November 23, 2016, parking restrictions were in place for northbound traffic preventing any stopping or parking along the northbound curb lane from 16th Avenue to 10th Avenue between 7:00 am – 9:30 am.

All responsive records are attached.

Please note that the Parking Operations & Enforcement Branch has provided photos before and after the date specified in your request, but cannot provide photos for the exact date as no tickets were issued at that location on November 23, 2016. The Parking Operations & Enforcement Branch confirms there was permanent signage in place, before and after November 23, 2016, with the restrictions noted in your request, as well as noted on every meter and meter post on the metered blocks.

Under section 52 of the Act you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your request. The Act allows you 30 business days from the date you receive this notice to request a review by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number assigned to your request (#04-1000-20-2020-559); 2) a copy of this letter; 3) a copy of your original request for information sent to the City of Vancouver; and 4) detailed reasons or grounds on which you are seeking the review.
