
My w fe and I strong y objected th s app cat on as Schoo and commun ty Center are nearby. No su tab e ocat on for cannab s shop.

Having a cannabis store where our young children can see members of society who are chronically addicted to marijuana (whether for medical reasons or not) is not appropriate for our elementary schoolic children.

He o, as a resident of  $\frac{s.22(1)}{1}$  I would ke to pitch n my objection regarding the development of a cannabis store at 220 Davie St. Looking at city by-aws, a cannabis store is not permitted within 300 meters of another cannabis store, school, or community centre. There are all three light ment oned within 300 meters of this new proposed location and that is unacceptable. A new cannabis store that is open 7 days a week, until 11 pm provides nothing of value to the people who live right in that building as it attracts a lot of unwanted individuals who could be intoxicated. 





#### Dear Board of Variance members,

I am writing to express my concern regarding Appeal No. Z35769 - 212 (220) Davie Street. I live a block from the location of this proposed Cannabis Retail Store. This location is entirely unsuitable for a cannabis retail store.

- 1. There is an elementary school, community centre, and a child care centre right down two blocks from here.
- 2. There are already FOUR other stores selling cannabis within a block and a half of this location. In fact there's one marijuana store (Hotgrass) that is literally less than 75 metres away at 1231 Pacific. That's an extremely high concentration of pot shops in one very small neighbourhood. We need stores that contribute to the community, this store doesn't.
- It is adjacent to a public plaza hidden by columns and plantings, which raises safety and noise concerns for the many young families with children and seniors that live in the building above and in my neighbourhood.
- 4. We already have issues with drunk and high people from the clubs and restaurants gathering outside on Mainland and Hamilton to smoke, scream, rough house, and honestly get into fights. Police are constantly having to deal with these issues. It's all very annoying and a great disturbance and nuisance to those of us who live in this community.
- 5. The proliferation of plastic and metal vape garbage from marijuana littering the street is already disgusting. I would hate to imagine how much more we will have to deal with if another store opened in the community.
- 6. Finally this appeal is a waste of taxpayer resources from an entitled private business that didn't do their homework (seriously how do you not know there are already so many marijuana stores or maybe they just didn't care) or don't like being told NO. Now they're throwing a fit because they aren't being allowed to go and do wherever they please. In fact, the Train Engine 374 Pavilion annexed to the Roundhouse Community Centre is a favourite visiting place for kids and their parents throughout the week, particularly on weekends and holidays. It's entrance located at the junction of Davie Street and Pacific Blvd is literally within a stone throw from the proposed store – less than 80 m!

2. City bi-laws 11.6.2(a) states a cannabis store is NOT permitted within 300 m of the nearest property line of a site containing another cannabis store.

Two existing cannabis stores are less than 300 m from this store:-

i) Yaletown Cannabis Store at 1078 Mainland Street which operates daily from 10 am to 10 pm (Friday & Saturday to 11 pm);

ii) HotGrass at Suite 388, 1231 Pacific Boulevard which opens 24 hours and offers online and pickup service.

Please note that HotGrass is located just around the corner from this new proposed cannabis store. 

Thank you for the opportunity to provide input on the application to locate yet another Cannabis Store in Yaletown. We reside at s.22(1) Vancouver, s.22(1) so this is less than s.22(1) s.22(1) s.22(1)

First, we accept that retail marijuana is legal and in turn, the applicant must should accept that regulation is the price of legality. My understanding is that a marijuana store must be at least 300 meters from schools, community centres, youth facilities and other marijuana shops.

An important objective of the regulation is to minimize marijuana access by youths. Youth should not be exposed to second hand marijuana smoke and youth should not think, by seeing it used on the streets of their neighborhood, that marijuana smoking is "cool or normal" behavior. Hence, the City of Vancouver prohibits pot shops from locating within 300 meters of a community recreation center. The roundhouse which serves as a recreation center and day care and has youth facilities is within 300 meters. I know firsthand that it is impossible to police the public use of marijuana near residential buildings and assume that is enough to dispose of the application.

In addition, within 300 meters of 220 Davie Street are the following cannabis shops:

Yaletown Cannabis 1078 Mainland in the Yaletown Galleria

Choom Cannabis 1391 Richards Street

Hot Grass #388-1231 Pacific Blvd

Crop King Seeds # 62-1146 Pacific Blvd in the plaza of nations (might exceed 300 meters)

To stay on the theme of youth influence, I want to point out that the Yaletown restaurants and coffee shops (like our Starbucks) are all frequented by families, patios are now the norm, and a marijuana store next to them encouraging use in the neighborhood is likely not acceptable to our commercial neighbors.

Another object of regulation is to minimize over-intoxication and drugged use. Pairing up marijuana and alcohol increases the level of intoxication and acute health effects and other harms relative to using either substance alone. Concurrent use should be avoided as noted. Placing this shop in the

middle of a zone which has so many liquor licenses within a few feet is a thoughtless approach.

Let me close by saying that most of the residents in the two block area of historic Yaletown purchased their real estate for approximately \$900 – \$1000 a square foot. We like to keep it cultural and safe. When we made those decisions to purchase, we were relying on the City of Vancouver to enforce its by-laws to protect the considerable investment we made in our homes.

What is the need of opening another cannabis store? Why? Why is our city becoming more and more unliveable place day by day? Why?


There are children who are growing up and walking to their schools and kindergartens every day and will pass by this store with a large neon sign that reads INSPIRED CANNABIS ?? Really?

I would like to pass on my feedback for the Development Application Notice - DP-2021-00021 at 220 Davie Street. I am a close neighbour to this property and would like to share my thoughts. I have seen these Cannabis dispensaries show up in other parts of the neighbourhood and the predominant thing I notice is that they don't add much value to the community. They often have windows that are completely covered, obscuring the view inside, and leaving the outside store front cold and uninviting. An example of this is seen at Royal Vape on the corner of Davie and Seymour (https://goo.gl/maps/ztKVQ3x8zVEkzVba9 [goo.gl]) and at Choom at the corner of Richards and Pacific (<u>https://goo.gl/maps/ztKVO3x8zVEkzVba9 [goo.gl]</u>). They have "mirrored" windows which make for an uninviting cold experience in the neighbourhood. Yaletown is a vibrant part of the city with store fronts open to the public, patios with lively conversations and streets that have families on them. Unfortunately, the standard for most of these Cannabis shops is the opposite. They are closed off, private, and often an evesore to most residents. I honestly would much prefer that this Development space be a hair salon, restaurant, retail store or something that adds value and contribution to the community. A space where people come together to create connections, not hide away to purchase Cannabis. I understand that Cannabis is legal and that there needs to be places to purchase it, but I am not convinced that this prime space in Yaletown is best utilized for a store like this. If anything, we need more OPEN store fronts in Yaletown to keep the community vibrant and welcoming. Also, there are no shortage of Cannabis shops around Yaletown! There are 5 within a 5 minute walk. Dear City of Vancouver, I am a Yaletown resident and mother writing to urge the City of Vancouver (the "City") to reject an Inspired Cannabis store application (DP-2021-00021) at 220 Davie Street. The application appears to break the City by-laws for being less than 300 metres of: - School - Elsie Roy Elementary School ~ 220 m (Section 11.6.2.b) - Community centre - Roundhouse Community Centre ~ 100 m (Section 11.6.2.b) - Another cannabis store at 1078 Mainland Street - 200 m (Section 11.6.2.a) I also understand there is a further one or two more cannabis stores that may open in the neighbourhood. One cannabis store has a building permit application BP-2021-00054 in review for 1120 Hamilton Street. Because of cannabis' harm to the developing brain, the Canadian Pediatric Society says governments must rigorously enforce regulations to prohibit dispensaries from being located close to schools and community centres. It therefore urges limiting the marketing of cannabis to children. But the presence itself of Inspired Cannabis would seem to be advertising the idea of cannabis to young passers by. The proposed store is steps away from shops that the children frequent, including Dairy Queen, Fresh Slice Pizza, Jugo Juice and a convenience store. The retailer's other Inspired Cannabis stores on Robson St. and Broadway feature large signs that I believe are not congruent with our kid-friendly neighbourhood. They feature a large lit up storefront sign of the the word "CANNABIS" and marijuana leaf signage - and this store would be in the same residential building where many children live and go to school, it will stand out to all the children in the neighbourhood, as well as from elsewhere with the SkyTrain station across the proposed location. I am very concerned the Board of Variance will overturn a rejection of the Inspired Cannabis application by the Director of Planning as it has in the past. Inspired Cannabis had its 1032 Robson St store approved upon appeal (DP-2020-00705). And a cannabis store at 999 Denman St won its application (DP-2020-00629) on appeal, even though it breaks the by-laws for being less than 300 metres from King George Secondary School and The West End Community Centre. Allowing a cannabis store to be located near our local elementary school, steps away from a community centre should not be allowed. Why do we have cannabis by-laws only to see them overturned by the board? Is there any limit to cannabis retail? There doesn't seem to be, and that must change. We want a family-friendly community. Pot stores should be in locations more suitable to legal-age pedestrian traffic and away from children centres. I am also concerned that the community was not engaged with proper notification. A public sign about the development application went missing for several days after a complaint to the city that it was not placed properly. A much smaller sign was then put up that seems barely noticeable. Some stores have successfully appealed that the by-law would impose "unnecessary hardship'. In this case, it does not seem to apply. From their website, Inspired Cannabis currently has 6 stores and 5 more opening soon, plus the recently approved 1032 Robson St store. And given the location across the SkyTrain on a street with heavy foot traffic, surely we could find a business that

meets the needs of children in the neighbourhood. Finally, a Health Canada 2020 Canadian Cannabis Survey shows only 3% of Canada's population who claim using cannabis for medical use "say they did so with a document from a healthcare professional". The majority of cannabis use seems to be for non-medical, recreational use. Needs of the customers can be met with the other stores in Yaletown or at another more suitable location. The City's by-laws set forth to protect children, need to be adhered to. Please consider the needs of our children first. Thank you.

I am a long-time resident of Yaletown, a mother s.22(1)

**s.22(1)** and an active member of the community writing to urge the City of Vancouver to reject an "Inspired Cannabis" store application (DP-2021-00021) at 220 Davie Street and stop the approval by the Board of Variance through an early appeal process.

The store's location is too close to our neighbourhood children. The application appears to violate the City by-laws for being within 300 metres of:

- A school Elsie Roy Elementary School 220 m (Section 11.6.2.b)
- A community centre Roundhouse Community Centre 100 m (Section 11.6.2.b)
- Another cannabis store (Yaletown Cannabis 1078 Mainland Street) 200 m (Section 11.6.2.a)

Yaletown already has 2 cannabis stores: Choom Dispensary at 1391 Richards St and Yaletown Cannabis Store at 1078 Mainland St. I also understand there is a further one or two more cannabis stores that may open in the neighbourhood. Lightbox Enterprises Ltd. (Dutch Love Cannabis) has building permit application BP-2021-00054 in review for 1120 Hamilton St.

I am deeply concerned as my family and I walk through Yaletown daily and already have to pass by the above cannabis stores to access our regular shops. We also frequent many of the family-friendly shops at this high traffic corner, including Dairy Queen, Fresh Slice Pizza and Jugo Juice and would have to pass yet another shop to access the Canada Line should this store be approved.

These by-laws were enacted to protect our community, including children. The Canadian Pediatric Society says cities must "rigorously enforce regulations on the cannabis industry to limit the availability and marketing of cannabis to minors." But the presence itself of Inspired Cannabis would be marketing cannabis to young passersby who walk down this busy street daily with their families or by themselves to catch the bus or board the Canada Line with its very flashy and brightly lit advertising. With the popularity of edibles such as brownies, cookies and candies, it is even more worrisome about how this will be regulated to most effectively protect children. Furthermore, the Canadian Pediatric Society recommends that governments enact and rigorously enforce regulations to prohibit dispensaries from being located close to schools and community centres. There are many children that live in the surrounding towers that go to local schools, frequent the Roundhouse Community Centre and take public transit.

It has been a challenging year with COVID. Homelessness, mental health and opioid issues were already on the rise before the pandemic. Although these concerns are separate from the opening of yet another cannabis store, Yaletown is still recovering from having the Roundhouse used as a shelter for the homeless. s.22(1) when many incidents of petty thefts and trespassing were happening in s.22(1) as the guests moved into the

Roundhouse. The people that broke into s.22(1)and through a common courtyard to access s.22(1)safe exiting from the s.22(1) when many incidents of petty as the guests moved into the needed to go through a locked gate During this time, I did not feel where I encountered strangers in

the courtyard and found needles and other drug paraphernalia. I had run-ins with people trying

barricade still remains as we still encounter people in the alley, in the parkade and in our gated courtyard who now know Yaletown so well.

So, as I learned through the community about the Inspired Cannabis' application and its working relationship with The Pharmacy, I felt a need to exercise my civic duty and share my opinion as having a cannabis store within 300m of many child-friendly public gatherings is not a priority. A third cannabis store is not aligned with a neighbourhood of young families. As I explored the process of sharing my feedback, my general feeling was that any feedback I/we have to share is moot and as the process makes it difficult for citizens to have their voices heard. First off, the public sign about the development application is small and located high up and with small print. I'm also recognizing that this system is not as transparent as I thought or following correct procedure. It appears cannabis retailers have overcome these by-laws by appealing to the Board of Variance. Inspired Cannabis successfully had its 1032 Robson St store location approved upon appeal (DP-2020-00705). And the board seems to have a member whose Linkedin says she is a "policy consultant working in cannabis and medicinal mushrooms." The board also approved in January the Muse Cannabis store at 999 Denman on an appeal, despite it being less than 300m from King George Secondary School and the West End Community Centre (DP-2020-00629). I was shocked to find out that Inspired Cannabis has already filed an appeal (No. Z35769) to the Board of Variance, when the Director of Planning hasn't even ruled yet, and the 21-day public input process hasn't been completed. The deadline for the Development Application public input is March 29, 2021 yet the City has already mailed a notice of appeal on March 19 with a deadline for input of April 5.

The by-laws set forth to protect children, especially in a high-density neighbourhood, need to be adhered to, period! What is the purpose of having them only to be overruled? It is unfair how much drug exposure there is to our children. They see it and smell it being smoked at David Lam Park, around the Roundhouse where my children go to attend their activities and, on the seawall, where we walk our dog. There seems to be many Vancouver Animal Control officers enforcing bylaws in our neighbourhood. Who regulates public smoking of cannabis in prohibited public places especially where children gather daily? My **s.22(1)** know to look for needles at the playground and outside our home. Although we are supposed to call the hotline to have a needle/s removed, many members of our community feel they need to take the risk to dispose of them because of the number of children and pets in our neighbourhood. Now we need to be more tolerant of not 1 more cannabis store, but possibly more stores?

I ask you to please take the concerns of Yaletown residents into serious consideration. Please respond and indicate how an early appeal can be made without the public's feedback or the Director of Planning's decision be considered.




