This is a quick reminder of the upcoming **BC Hydro Power Outage at Stanley park**, scheduled for **December 19th, 2020 from 9am to 7pm** as a part of their **Phase 1** update.

Based on our record drawings the following locations are expected to be out of service -

- **Malkin Bowl**
- **Pavilion restaurant near the Rose Garden**
- **Stanley Park service yard along with the horse carriage and the RCMP mounted police**
- **Stanley Park information booth and adjacent washrooms**
- **The Stanley Park miniature train area**
- **Lumberman's Arch concession and washrooms**
- **All of Prospect Point area including washrooms**
- **Prospect Point picnic shelter with washrooms and the adjacent fieldhouse**
- **Metro Vancouver (GVWD) Pump House**
- **Street lights on Pipeline road**

**PB Rangers** will close off all the washrooms located in these locations. As per our record drawings other locations and washrooms should be operational.

Hello All,

Thank you all for taking the time to review our proposed event. Although a date has not yet been 100% solidified, we are hoping to secure the 2nd Sunday in July for the next 3 years (July 10, 2016, July 9, 2017 and July 8, 2018). This annual event, branded as an IRONMAN 5i50 (Standard distance triathlon) is expected to attract 2500-3000 participants from across the world. Showcasing all of what Vancouver has to offer, the event will start/finish in Coal Harbour with a 1.5km swim. Athletes will then begin the bike course which travels through Coal Harbour, up the Causeway before entering Stanley Park. Athletes will be doing 2.5 laps of Stanley Park along with a short out and back section along Beach Ave before returning to the transition area in Coal Harbour (40km distance - map attached). The run course travels along the seawall before finishing in Jack Poole Plaza.

This marquee event would be one of 15 IRONMAN 5i50 events throughout the world and one of over 130 IRONMAN events worldwide. In a typical IRONMAN event, athletes travel with 3-4 family/friends which would bring between 10,000-12,000 visitors to Vancouver during the event. We have seen an average of 22 countries represented at our events throughout Canada, and a large focus of our competitor recruitment would be the growing Asian market.

We understand that this event will greatly impact your businesses and organizations during your peak season and would like to work with each stakeholder to offset this impact as much as possible. In other events across BC and Canada, we have worked with stakeholders to provide access to advertising to athletes, opportunities to host /cater events throughout the race week, etc. I have attached an event timeline that outlines the road impacts based on a 7am event start time. Based on our knowledge of athlete abilities, the first athlete is scheduled to arrive in Stanley Park at 7:23am. The very slowest athlete would be exiting the east side of Stanley Park for their final loop at 11:00am and would be fully clear of the Park at 11:36am. As per our experience at prior events, our slowest athletes usually finish the course well before our anticipated cutoffs, however this timeline presents a worst-case scenario in terms of road closure times. At many of our events, including IRONMAN Canada in Whistler this summer, we open roads ahead of our expected timeline.



I would be happy to discuss our event in further detail with each of you and discuss how we are able to offset our impact. As Dave mention, I live locally and would be happy to meet in person at your convenience.

I wanted to share the event presentation shown at the Stakeholder Meeting last Wednesday. Ironman Canada is proposing a triathlon in Vancouver on a Sunday in July (3<sup>rd</sup>, 10<sup>th</sup>, or 17<sup>th</sup> under consideration). This event is one of a number of triathlons that Ironman produces internationally. The event would draw about 2,500 athletes, and their families. The triathlon would start downtown, with the cycling and run portions coming through Stanley Park. The organizers are requesting closing Stanley Park roads until 11:30am, and would like to begin outreach to Stanley Park stakeholders to understand and minimize the impacts of this closure.

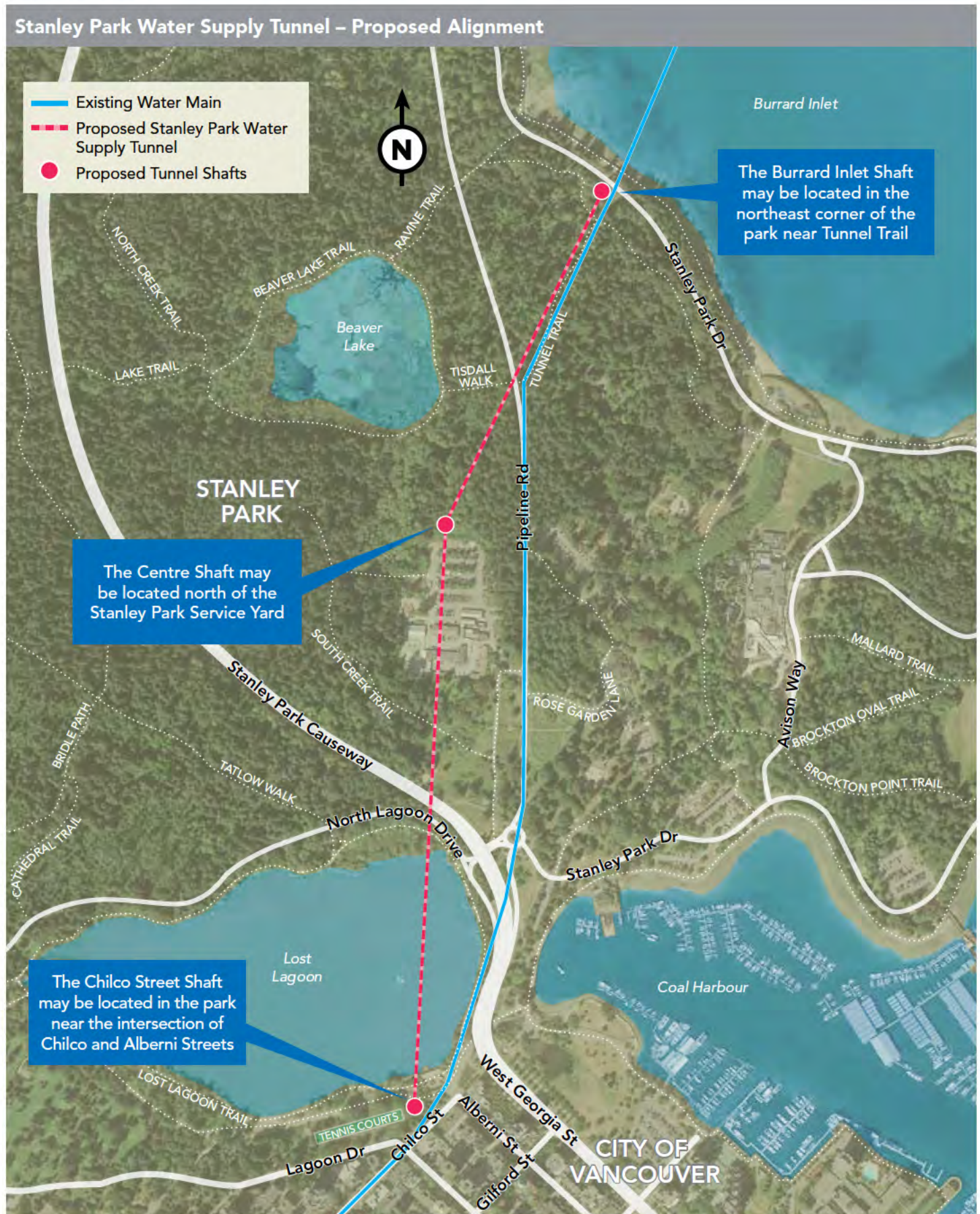

To excavate the proposed tunnel, install the water main and build the valve chambers, three shafts will be constructed in Stanley Park. At all three shaft sites, the construction areas will be restored to equal or better condition.





## Minimizing Project Impacts

The Stanley Park Water Supply Tunnel is critical for the safe and reliable delivery of drinking water. We are sensitive to the impacts that construction will have and are taking steps to minimize them, wherever possible.

The majority of the work will take place deep underground and park businesses and visitors are not expected to experience significant disruptions to regular activities.

Key considerations during the planning stages of this project include:

- Limiting impacts to the natural environment and First Nations cultural sites
- Maintaining access for park users
- Protecting the park's public amenities
- Minimizing construction duration and impacts

Residents near the Chilco Street Shaft will experience construction impacts such as noise and dust while crews build the shaft and valve chamber. However, the construction schedule will be designed to complete the work as quickly as possible while ensuring local residents receive a break from construction activities at night and on Sundays.

A temporary re-routing of the bike path near the Chilco Street Shaft will also be required throughout construction of the shaft and the valve chamber.

Metro Vancouver will notify residents, park businesses and park users of any disruptions well in advance and be responsive to any concerns raised about project activities.



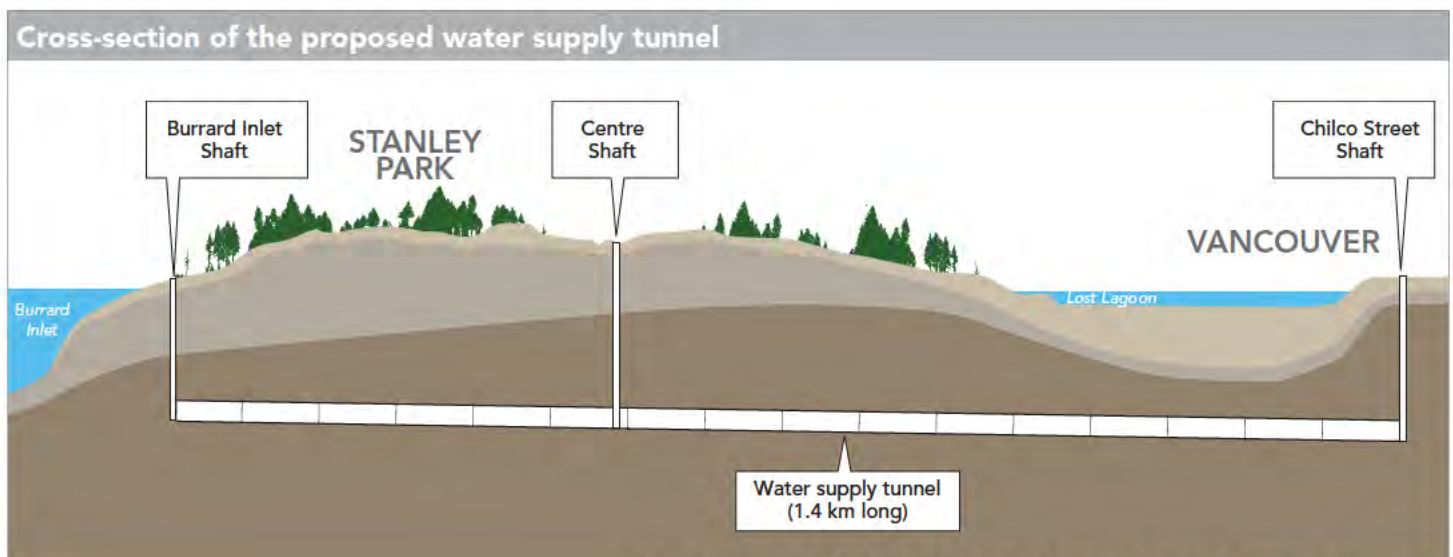

## Metro Vancouver's Role in Water Supply

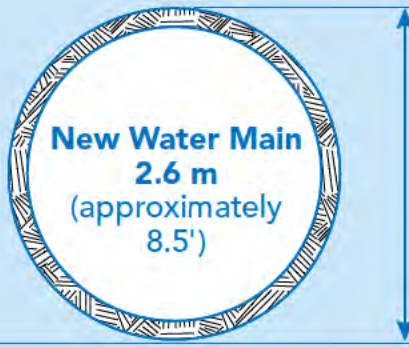
Metro Vancouver provides a reliable source of safe, high-quality drinking water to its Member Municipalities at a reasonable cost. This includes acquiring and maintaining supply, as well as treating, testing and delivering water to members. In turn, the members are responsible for conveying water to residents and businesses.

Metro Vancouver uses a system of watersheds, dams, treatment plants, water mains, pump stations and reservoirs. To maintain the quality and reliability of these systems, and of the supply, improvements are constantly underway.

## How Big is the Water Main?

There are all different sizes of water mains in our region's distribution system, but the water main being installed for this project is approximately 2.6 m (8.5 feet) in diameter.

On Saturday, March 14 the annual St. Patrick's Day 5K Run will take place within Stanley Park. ### Traffic Impacts to Stanley Park during First Half, Half Marathon on February 5, 2017

On Sunday, February 5 the annual First Half, Half Marathon is taking place in Stanley Park. It is expected that approximately 2,000 athletes will participate in this Half Marathon. The runners are normally contained to the seawall, but because of the weather uncertainty over the next 72 hours, and the icy conditions, the seawall is closed until further notice between Second Beach and Pipeline Road. If the seawall remains closed Sunday morning the following alternate route will be implemented.

In the event of a seawall closure the southbound lane of Pipeline Road will be closed to traffic from approximately 8:30am to 11:30am. Vehicle access to the east side of the Park will be maintained, so there would be minimal impact to the Aquarium /HMCS Discovery/Totem Poles/Yacht Club/Rowing Club, etc. Northbound vehicles on Pipeline Road would have unimpeded access to the Stanley Park Pavilion/Malkin Bowl/Trainyard complex. Northbound vehicles on Pipeline Road would have

intermittent access to the Stanley Park Service Yard/Mounted Squad/Horse Drawn Tours complex, managed by the Vancouver Police.  
The west side of the park is unaffected by this lane closure.

Hi All,

The City Ride Proposal has been updated. There will not be a Night Ride component this year. The Georgia Street entrance at the roundabout will not be closed. The plan for the riders arriving from Georgia Street is to turn right (north) on Denman Street, cut through the Devonian parking lot onto Devonian Seawall. The seawall section will be closed to both bike and ped traffic and will be re-route much like the Rock and Roll ½ Marathon. The Chilco Plaza area will be managed. (plan to follow). The riders will use the overpass and the pathways and re-enter Pipeline Road via the road to the Pavilion (Malkin Bowl). Northbound Pipeline will still be closed to vehicular traffic but access to the east side of the park will

remain open.

Tour buses will be notified of the closure.

Public buses will be allowed through.

The start of the ride could begin at 5:00pm instead of 5:30pm and the last rider would be out of the Park by 6:30pm.

This will still impact TUTS, the Pavilion and the Stanley Park railway and the organizers are willing to work with the groups to mitigate the impacts.

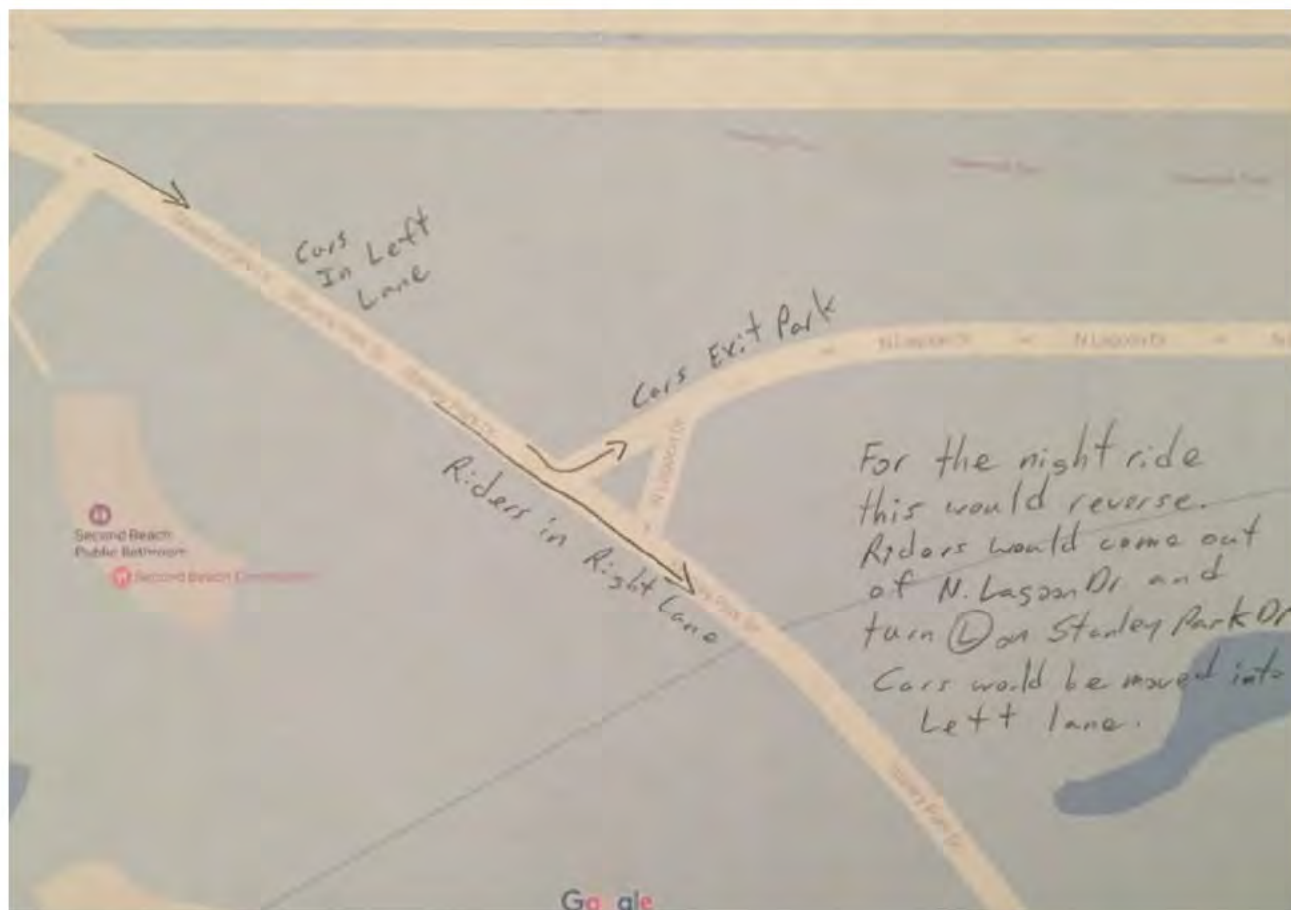

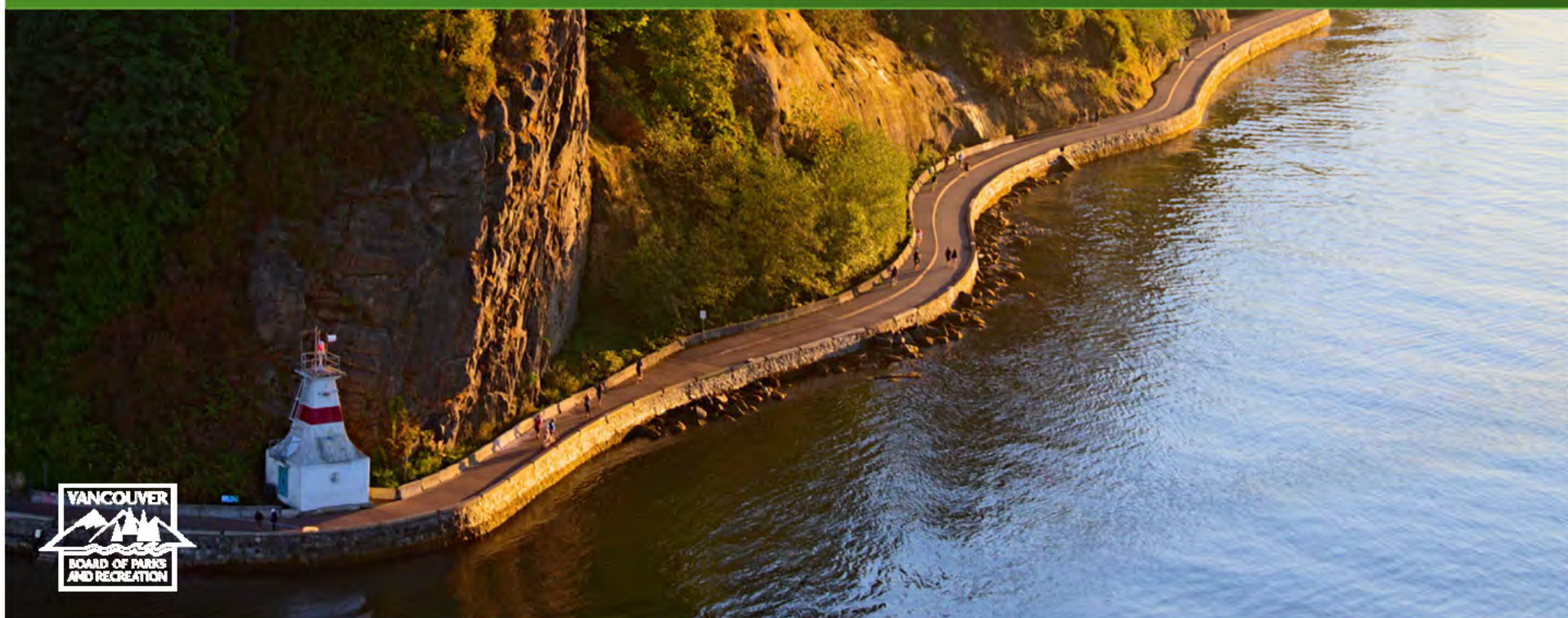

### Agenda Items

#### 1. Stanley Park Special Event Proposal

Supervisor of Special Events and Filming presented an overview of *Our Cityride Vancouver*, a special event proposal, in Stanley Park.

Our Cityride Vancouver will be an all-inclusive event that brings like-minded people together in mass participation rides. The inaugural rides will be a signature event for the Vancouver Park Board and City of Vancouver.

The event organizers have selected a route that incorporates key landmarks of the city including Stanley Park, Coal Harbour, Yaletown, Chinatown, Gastown, Downtown, Rogers Arena, BC Place, the Village (formerly Olympic Village) and Beach Avenue.



The proposed event date is August 19, 2017, Saturday, and will start at David Lam Park.

The proposed road closures include: the Georgia Street entrance; northbound Pipeline Road; and a portion of Beach Avenue between Second Beach and English Bay. For each closure, the vehicular traffic will be redirected to an alternate route.

Some of the stakeholders were concerned about reduced accessibility for their guests and staff during the road closures especially for the Night Ride. The organizers are considering moving the Night Ride to a different location.

One of the stakeholders suggested changing the route from Georgia Street to Beach Avenue, North Lagoon Drive via Second Beach to avoid road closure at the Georgia Street entrance. The event organizers will consider that option.

## 2. Seawall Renewal

Civil Engineer from Park Development presented an overview of the Seawall Renewal Project. Due to its age and environmental factors, the seawall requires regular maintenance and servicing.

This year's project will focus on servicing the surface line of seawall in two primary areas: area west of Lumberman's Arch, and area by Siwash Rock. Depending on funding availability, two additional areas at Second Beach Pool and English Bay Bathhouse will be serviced.

The project will start in June and continue throughout mid-November. Most of the work will be conducted at low tide during the day. Noise, vibration and traffic plan will be prepared in order to minimize the impact on visitors.

## 3. Park Safety

Director of Parks presented an update on park safety. The Park Board is developing a security plan for Stanley Park in partnership with Corporate Security and would like to engage the park stakeholders on its contents.

The murder investigation is still on-going and remains active. Please contact the Park Board for future updates. Stakeholders are encouraged to report any suspicious activities by using VanConnect app or by calling 311.

## 4. Prospect Point Café: Improvements and Spring Completion

Prospect Point Café is going through a major facelift resulting in a brand-new restaurant and café. The re-opening is scheduled around the end of June 2017.





## 5. Stanley Park Brewing: Improvements and Timelines

The lease for the former Fish House ended in October of 2015. Stanley Park Brewing has since signed the new lease. The space will be converted into a mini brewery/bistro, concession, and brand-new washrooms. The opening is scheduled for April of 2018. For the 2017 season, the tennis courts will remain open.

One of the stakeholders asked which washrooms are to be used by tennis players during the construction. The players are advised to use the pitch and putt washrooms or a porta-potti.

## 6. Stanley Park Information Booth

The Park Board is planning a public engagement process to rebrand Stanley Park Information Booth. Stakeholders are encouraged to provide feedback on the vision for the new Information Booth.

## 7. Roundtable Discussions

The floor was opened for roundtable discussions:

- a. A representative from the Teahouse enquired about the location of Mobi Bike stations that are coming to Stanley Park. The bikes will provide an alternative transportation for the Teahouse staff especially at night.

Details including timing of launch and locations will be sent out to all the stakeholders.

- b. A representative from the Stanley Park Lawn Bowling Club announced they were celebrating the 100<sup>th</sup> anniversary in 2017. The Club is ranked as the largest in its membership in the country. There will be a gala event in mid-June.
- c. Director of Parks announced the retirement of a long-time Park Board employee, Brian Quinn. Yann Gagnon will replace Brian as the Manager of Park Operations. In addition, Jeff Whitehead has been appointed as the Supervisor of Downtown Parks and Beaches including Stanley Park. John Odong will assume the position of Superintendent for the same area.
- d. A representative from the Legends of the Moon enquired about the location of AEDs in the park. AEDs are located in the Administration Office, Aquarium, Service Yard and Ranger Trucks.

The stakeholder also asked if smoke-free signs could be installed at the park entrance. Currently there is no plan to install additional signage at



the entrance, but a smoke-free logo will be printed on all Park Board totes in the park. The Park Board will consider printing smoke-free logo on EasyPark signs if there is sufficient space.

- e. A representative from the Ecology Society asked to be informed of any construction work planned in the park so they can coordinate their school programs in a timely manner. The Society is participating in the Bio-Blitz event on August 12 and 13 as part of the Canada 150+ series.

The stakeholder also enquired an update on the water main break by Lost Lagoon. Metro Vancouver is proposing to replace the water main with a double line, but the timeline is not yet clear. The Park Board will update the stakeholder as more information becomes available.

- f. Supervisor of Commercial Operations has announced that the pitch and putt would open in April this year. The delay is largely due to the unusually cold winter we had.

This year's Easter Train will be much larger than in the past. There will be Easter carnival, food trucks, bouncy castles, mini golf, and Easter egg hunt. The tickets will only be available on site and not available for online purchase.

The pond area at the Train is being renewed and beautified. The plaza will be refurbished as part of this project. The Park Board is also working to rebrand the Train program and rename it to Stanley Park Railway.

- g. A representative from Capilano Group requested an update on the signage program. The Park Board is working with the City of Vancouver to come up with a consolidated plan.
- h. A representative from the Aquarium enquired about the proposed changes to the busking program. The Park Board is waiting for the bylaw to be changed before the program can be revised.

The stakeholder also asked if they can call the rangers in presence of protesters. The stakeholders are advised to call 311 and seek assistance from the rangers.

Next meeting will be scheduled in the next 6 months.
