Please note that in the City's annual SOFI report, the City splits the disbursements between "Payment to Vendors and Suppliers of Goods and Services" and Grants disbursements. As the request specified "payments to suppliers of goods and services," any grants paid to these entities in 2020 have not been included in the records.
