This memo highlights Labour Force Survey (LFS) data published by Statistics Canada for the reference weeks from September to December 2021. The LFS provides estimates for the unemployment rate and employment totals by industry and occupation on a monthly basis. The



information presented in these memos illustrates the impact of COVID-19 on Vancouver's labour force and economy over the most recent 3-month period since the Pandemic began. This information is meant to be viewed in conjunction with other socio-economic and community statistics to form a cohesive picture of the City's current state and assist with recovery and resilience planning. This information is posted to the City's website and is shared with the business community.

Important notes about the data

The statistics presented in this memo are for the Metro Vancouver region as the Census Metropolitan Area (CMA) is the smallest geography level available for LFS data tables published by Statistics Canada. Throughout this memo, the term "Vancouver" refers to the Vancouver CMA. The LFS data used to create the statistics presented in this report are not seasonally adjusted¹.

Changes in employment totals and unemployment rate

Employment in Vancouver increased from 1,518,300 in September to 1,520,900 for a gain of 2,600 (0.2%) jobs. Between September and December, the unemployment rate decreased by 1.0 percentage point to 5.0% in Vancouver. In December 2021, the region had 32,500 (2.2%) more employed workers than in February 2020. This slight increase shows employment numbers have returned to pre-pandemic levels and are comparable to levels seen prior to February 2020. Peak job losses of 251,200 (-17.2%) were recorded between February and April 2020. Nationally, the unemployment rate decreased by 1.0 percentage point between September and December 2021 to 5.9%.

The fluctuations in employment levels from March 2020 to December 2021 reflect changes to public health restrictions and other measures, including increased limitations on some businesses under "circuit breaker" restrictions in late March 2021 followed by the gradual easing of some provincial restrictions May 25th and June 15th, 2021. The province moved to Step 3 of the Restart Plan on June 30, 2021, relaxing a number of major orders related to the COVID-19 pandemic preceding the reference weeks in July and August (July 11th to July 17th, 2021 and August 15th to August 21st, 2021). Subsequently, on September 13th, during the Census reference week (September 12th to September 18th, 2021), the province introduced proof of vaccination requirements at most indoor public spaces. It should be noted that the new restrictions the province brought in on December 19, 2021, to restrict the spread of the Omicron variant, and the subsequent tightening of these measures on December 22, 2021, occurred after the December census reference period (December 14th to December 18th, 2021).

Please see Figure 7 for a full list of announcements and orders made since the previous reference period. Appendix A shows all prior announcements and orders starting on March 12, 2020.

Regular Council reporting on regional employment trends was initiated at the onset of the pandemic. As the statistics have shown a sustained return of overall employment to prepandemic levels, this will be the final memo in the series issued by PDS. Staff will continue to monitor economic conditions and will report back to Council as needed.

¹ Seasonal adjustments to labour force data are done to eliminate the effect of seasonal and calendar influences (e.g. seasonal shopping or agricultural work).






Figure 1 – Unemployment rate and monthly employment change in Metro Vancouver

Changes in employment totals and unemployment rate – three-month moving average

The following sections highlight statistics related to employment change by industry and occupation that are published as a three-month moving average for Vancouver; therefore, data published for December is an average of October, November, and December. Using this three-month moving average data, employment in December was 1,519,000 and the unemployment rate was 5.5%. The following chart shows the monthly change of employment and the unemployment rate using three-month moving average employment data.

Industry overview

Employment in the wholesale and retail trade industry experienced the largest three-month gain in Metro Vancouver, increasing by 26,300 workers (10.9%). The second largest employment

sector increase was in education services, which gained 21,000 workers (22.5%). The third largest employment gain was in public administration, which increased by 7,500 jobs (11.6%). Between September and December, the largest employment decline was in the business, building and other support services sector, which declined by 21,100 people, a decrease of - 30.5% of its workforce. The second most losses were seen in professional, scientific and technical services, which declined by an additional 14,600 workers (-8.2%) between September and December. The finance, insurance, real estate, rental and leasing sector declined by 7,200 workers (-6.2%) over the three month period.

Occupation overview

Occupation employment data for Vancouver is published as a three-month moving average; therefore, data published for December is an average of October, November, and December. Employment in education, law and social, community and government occupations experienced the largest three-month gain in Metro Vancouver, increasing by 9,100 jobs (5.5%) between September and December. The second largest increase was in business, finance and administration occupations, which gained 4,900 workers (1.7%). The third largest employment gain was in trades, transport and equipment operators occupations, which increased by 2,100 jobs (1.3%). Between September and December and December, employment in natural resources, agriculture and production occupations experienced the largest decrease with 5,300 less workers (-23.3%). The second largest loss was attributed to health occupations, which experienced a decrease of 4,000 jobs (-3.1%). Occupations in art, culture, recreation and sport declined the third most, with a loss of 4,000 (-6.5%).




Figure 4 – Employment change by occupations in Metro Vancouver, June to September

The largest increase in employment by detailed occupations was for retail sales supervisors and specialized sales occupations, which increased by 17,500 (+32.6%) workers between September and December. Other occupations with the most employment gains from September to December include:

- Administrative and financial supervisors and administrative occupations (+8,200; +10.3%)
- Transport and heavy equipment operation and related maintenance occupations (+8,000; +22.6%)
- Sales representatives and salespersons wholesale and retail trade (+5,800; +7.0%)
- Professional occupations in art and culture (+5,600; +34.6%)

Figure 5 - Most employment gains by detailed occupation, September to December





The largest decrease in employment by detailed occupations was for service support and other service occupations, n.e.c., which lost 14,600 (-20.7%) workers between September and December. Other occupations with significant employment losses include:

- Technical occupations in art, culture, recreation and sport (-9,600; -21.3%)
- Supervisors and technical occupations in natural resources, agriculture and related production (-7,600; -71%)
- Finance, insurance and related business administrative occupations (-6,500; -21.5%)
- Service supervisors and specialized service occupations (-6,200; -12.6%)
