SUBJECT: Amendments to the Impounding and Vehicles for Hire by-laws – Towing Fuel Surcharges

The Insurance Corporation of British Columbia (ICBC) reviews its fuel surcharges quarterly, and staff have been advised that their rate will be increased to 26 per cent, effective July 1, 2022. The previous fuel surcharge was 21 per cent, effective April 1, 2022.

This Council report, agenda item 3 for July 5th 2022 Council meeting, proposes to update the towing fuel surcharges in the Impounding and Vehicles for Hire by-laws to 21 per cent, which was based on the ICBC rates at the time. In an effort to maintain alignment between the City's by-laws and the ICBC rates, this report has been updated to recommend that the towing fuel surcharge in the Impounding and Vehicles for Hire by-laws be updated to 26 per cent.
