Council approves groundbreaking UNDRIP strategy for Vancouver Calls to action are the first of their kind for a municipality in Canada

Today, Council passed the City of Vancouver's United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) Strategy that makes Vancouver a national and world leader in implementing a clear strategy towards UNDRIP and reconciliation.

In March 2021, City Council unanimously adopted a motion to create a UNDRIP Task Force. The task force, in partnership with Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation, developed the strategy and 79 calls to action outlined in the report.

Today, UNDRIP is the most comprehensive international instrument on the rights of Indigenous Peoples and is a framework for reconciliation to uphold and protect Indigenous Peoples' rights and their enjoyment of those rights.

As part of the City of Vancouver's UNDRIP Strategy, the task force identified specific calls to action under the four themes of the BC Declaration on the Rights of Indigenous Peoples Act (Declaration Act):

- 1. Social, cultural, and economic well-being
- 2. Ending Indigenous-specific racism and discrimination
- 3. Self-determination and inherent right of self-government
- 4. Rights and title of Indigenous People

Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation have generously come together to help guide the City in this important work. The establishment of the intergovernmental UNDRIP Task Force created a pathway to support Vancouver's commitment to improved relationships with the Nations, in recognition of their rights as title holders of these lands.

Acknowledging the important work that Musqueam, Squamish, Tsleil-Waututh and Vancouver have done, the task force celebrated the release of their strategy and calls to action at a cultural ceremony at the Museum of Vancouver on October 19.

Next Steps:

In consultation with the Nations and urban Indigenous populations, City staff will determine what is needed to implement each call to action and report back to Council with an action plan on how to implement findings, and a new inter-governmental committee will work to move forward the strategy's recommendations.

The task force is led by an intergovernmental steering committee composed of representatives from Musqueam Indian Band, Squamish Nation, Tsleil-Waututh Nation, and the City of Vancouver.

The UNDRIP Task Force engaged with urban Indigenous communities, and invited the knowledge and input of technical experts, academics, Traditional Knowledge Keepers, and Indigenous community members with unique insights and lived experiences. The Task Force has appointed Co-Chairs by consensus: Council Chairperson Khelsilem (Squamish Nation) and Councillor Boyle (City of Vancouver).

Musqueam have lived in the Fraser River estuary since time immemorial. We are a proud and culturally-resilient First Nation of over 1,300 members. About half of our their members live in a small portion of our territory known as Musqueam Reserve, located south of Marine Drive in Vancouver. Many of the remaining members live throughout Musqueam's territory, including Vancouver, Burnaby, Richmond, Delta, North Vancouver, West Vancouver, and New Westminster. Our lands and waters continue to support our cultural and economic practices, while serving as a source of knowledge and memory, encoded with our teachings and laws. The largest proportion of Squamish Nation Members live in several urban reserve communities in the present-day cities of Vancouver, North and West Vancouver and the municipality of Squamish, B.C. Over 47 per cent of the more than 4,050 Squamish Nation Members live on-reserve, and membership is determined by guidelines set out in the Squamish Nation Membership Code. The Nation has never ceded or surrendered title to its lands, rights to its resources or the power to make decisions within its territory.
