Purpose

This memo provides an update on the shared e-scooter pilot, as directed by Council in the Member's Motion "Moving Climate Goals Forward with Micromobility" on June 8, 2022.

Background

In June 2021, Council approved participation in the province's "Electric Kick Scooter" pilot, which legalized the use of *privately owned* e-scooters on local streets and bike lanes. As a part of this pilot, staff have been monitoring the use of private e-scooters to learn how they impact the safety and accessibility of streets and sidewalks, and how they can be best supported. Once data collection is complete, staff will report back to Council with the pilot findings in Spring 2023.

Building on the private e-scooter pilot, the June 2022 Council motion directs staff to deliver a *shared* e-scooter pilot. The motion specified that the pilot be delivered through a competitive Request for Proposals (RFP) process, be informed by feedback from Advisory Committees and best practices research, and integrate considerations for safety, accessibility and equity.



Work to Date

Staff had initial discussions with the Seniors, Persons with Disabilities, and Transportation Advisory Committees in September 2022, prior to the committees' dissolution. The committees recommended that the e-scooter system prioritize the needs of more vulnerable street users, by using a range of tools including device technology (ie. geo-fencing), station-based parking, on-street infrastructure, and education and enforcement. Staff will meet again with the committees prior to the RFP posting, when the committees are reformed.

Jurisdictional research corroborated the recommendations of the advisory committees, including the need to ensure a safe and accessible public realm through a robust system design, operating and management plan, and contractual agreement with the operator(s). Regional examples also show that municipalities that invest time in pilot planning, clarifying local needs, and scoping proponents' capacity prior to an RFP posting have more successful outcomes.

E-Scooter Pilot Approach

Vancouver's extensive experience with shared mobility and micromobility provides a strong foundation to build a shared e-scooter system that will meet Council direction and industry best practices. Based on work to date, staff anticipate that the successful proponent of the RFP will provide a system which will potentially be revenue-neutral or revenue-generating for the City, provide local living wage jobs, and include a Council-directed equity program. To protect riders and vulnerable users, the system is anticipated to be station-based and supported as much as possible by safe and separated All Ages and Abilities facilities.

Next Steps, Timeline and Resources

Staff will continue to engage with the Advisory Committees and other stakeholders to shape the pilot scope. The RFP will then be drafted to integrate engagement feedback and seek the best value for the City. The RFP is anticipated to be posted by fall 2023. A well-defined RFP will expedite the subsequent step of developing an agreement with the successful proponent(s) and defining the detailed program design, contract terms, and implementation plan.

The execution of the RFP and pilot will require staff resources. While the pilot may potentially generate revenues that partially or fully offset the cost of these resources, a funding source to launch the pilot is required. This funding is not currently included in the draft 2023 operating budget, but it will be listed as an additional option for Council's consideration.
