Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of April 19, 2022 under the *Freedom of Information and Protection of Privacy Act, (the Act)*, for:

Records regarding the Vaisakhi event held on April 16, 2022, specifically:

- 1. Request by Khalsa Diwan Society (Ross Street Gurdwara) provided to the Special Events office; and
- 2. Permits, notes, and correspondence to and from the Special Events office related to the no-parking zones and other arrangements for the event. Date range: July 16, 2021 to April 16, 2022.

All responsive records are attached. Some information in the records has been severed, (blacked out), under s.15(1)(I) and s.22(1) of the Act. Please note, the City did not receive any formal written correspondence or a supplementary application (temporary occupancy permit) regarding the event organizer's initial parking request with the Film and Special Events (FASE) department. However, FASE can confirm the organizer did verbally request assistance from the City between March 10<sup>th</sup> and 22<sup>nd</sup> for a small number of parking spots located across the temple on the 7900-8000 block of Ross Street.

Under section 52 of the Act, and within 30 business days of receipt of this letter, you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your FOI request by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number (#04-1000-20-2022-199); 2) a copy of this letter; 3) a copy of your original request; and 4) detailed reasons why you are seeking the review.

While, there is no actual parade-taking place, we recognize the religious and cultural significance of this event to our local South Asian community and as always, we will do our best to support. The on-going pandemic and

financial constraints have proven challenging for many of our annual event organizers this year and we want to be flexible as possible. We have been actively engaged in conversations with the organizers and have been supportive in all of their decisions throughout this process.
