Squamish wants to leave daily operational comms around the project and road to the Nch'kay Development Corporation and Westbank, Squamish will come in for major milestones only. ENG comms will stayb looped in with them for any signage and transportation updates and try to coordinate on messages out to the community, and on any engagement opportunities. A holding statement on the road sublicense will be developed by Squamish and then referred to Nch'kay. They will emphasize that it is reserve land but will keep the community informed.

Road development questions will be handled by Public Services and Procurement Canada (PSPC) with City looped in. Ditto for environmental impact assessment and tree removal regarding the road through the Park.

I asked about the Services agreement finalized date and he said whenever it is finalized their Council would have to determine how it is publically released. Not sure if you have any more info on that.

All to say not a huge role for the City over the next little while unless the Services Agreement is finalized very soon. s.22(1) but Kirsten Langan is covering PDS files and she knows where the issues note and comms plan is.
