- BMI to provide at NC QTY 10 HD and LD.
- It was noted that some low duty and high duty sides are "jamming" at start up after original installation. It was noted that the City of Vancouver has been performing proper flushing prior to installation.
- Ken is to provide a list of additional parts that should be on hand for regular servicing of meters.

I think that's it. I waited to send as I was hoping to have a list back from my engineering group but they wanted to look into it a bit further to make sure they have the correct range of meters.

The issues that the City had with Badger meters in 2016 and 2017 relate to register malfunctions. Of the brand new Badger meters purchased in 2016/2017 about 10% had register malfunction. Badger was made aware and acknowledged that there was a defect in a certain manufacturing period for those registers, but Badger still has not provided the City with a clear indication of what delivery period or serial numbers of registers that were affected. The City has some concerns in regards to continuing to add Badger meters to our inventory without a clearer assurance that the City will be receiving a quality product that will perform as required.

These are all for 1" or under meters, correct?

Badger says they have never had an RMI for sticking registers in Canada for compounds, but that is what the video is of – or is this just an example?

Also, they said those serial #'s don't match any meters in Canada - could this be?

Sorry, coming in blind to things means a lot of questions!
