## Background

Through this cooperative partnership, the VSB and the City identified an opportunity to establish an overarching relationship framework as it relates to joint planning, development, operation, maintenance, renewal and/or use of available publicly-owned spaces. Publicly-owned spaces include, but are not limited to, multi-purpose rooms, gymnasia, playgrounds, sport courts and fields, pools, ice rinks, libraries, and parking facilities.



## **UOM to weiview Of MOU**

The primary objectives of the MOU are to define shared principles for cooperative working ventures, and future joint, shared and reciprocal use of available land and facilities.

To achieve the objectives above, the partners have identified eight guiding principles:

- 1. Administrative Simplicity
- Collaboration for Community Benefit
  Equity, Reconciliation, Diversity & Inclusion
- 4. Good Governance
- 5. Taking a Holistic Approach
- 6. Keeping Each Other Whole
- Maintaining Each Organization's Primary Purpose
  Timely Communication

To implement these principles, the partners will leverage existing processes, templates, tools, governance structures and channels so as to eliminate unnecessary administrative requirements as a result of this MOU.

Staff will continue to sustain proactive communications with respect to current and future strategic opportunities, issues and challenges. This includes sharing respective planning processes, timelines, data, best practices and innovative strategies so the partners can optimize the use of spaces for the good of Vancouver's communities.
