That the Nomination Subcommittee consult with Type A and B Civic Agencies to determine whether external liaison representation is needed (Park Board, VPD, VPL, VSB), and prepare invitations accordingly.	Discussion to be included on agendas for first Civic Agency meetings in July.
That the City Manager assign up to two non-voting staff liaisons to each Type A and B Civic Agency.	City Manager has assigned all staff liaisons.
