The following memo is being provided at the request of Council as it relates to the City's land use policies, regulations and licensing requirements for establishing Arcades in the City. The memo has been organized into two sections, including zoning regulations, and licensing.

Zoning & Development By-law

Section 565A of the Vancouver Charter authorizes Council to make bylaws regulating the use of land and development. Council has passed the Zoning & Development By-law #3575, which includes Arcades defined as:

"The use of premises for 4 or more machines on which games are played for amusement or entertainment and for which a coin or token must be inserted or a fee is charged for use."

Arcades are a permitted conditional use in several of the City's Zoning District Schedules, including C-2, C-3A, FC-1, HA-1, HA-1A, HA-3 C, as well as in the area K2 of the Downtown Official Development Plan (ODP), as well as a various of site specific CD-1 By-laws. Council



has also adopted <u>Arcade Guidelines</u> to be used in conjunction with the district schedules of the Zoning and Development By-law or ODP for development permits for an arcade. These Guidelines seek to provide consideration relating to windows, access to sun light and seating requirements.

Licensing Bylaw:

Section 272(1)(r) of the Vancouver Charter authorizes Council to make bylaws regulating the presence of persons less than the age of eighteen in "poolrooms, arcades, public dance-halls, billiard-halls, or bowling-alleys" and defining any terms used in this clause. Council has passed the Licensing By-law 4450, which provides for Arcade machines, or "amusement machines" as defined as

"A machine on which a mechanical, electrical, automatic or computerized game is played and for which a coin or token must be inserted or a fee is charged for each use."

When referring to premises in the business of providing access to amusement machines, the License By-law currently has four separate business licence types, depending on the number of machines on the premises, and the co-location of other entertainment, retail or food and beverage services:

- Games Room (3 or less machines)
- Arcades (4 or more machines)
- Entertainment Centre (4 to 150 machines)
- Family Sports and Entertainment Centre (4 to 150 machines).

More information on the by-law definition, licence fee and current number of licences for each licence type can be found in Appendix A.

These licence types are subject to separate regulations in the License By-law with respect to operating hours, age restrictions, the sale and consumption of liquor, and patron misconduct. To summarize, no persons under the age of 18 are allowed at all times in Arcades. Persons under the age of 15 are restricted from entering and remaining in Games Rooms, Entertainment Centres and Family Sports and Entertainment Centres during school days and hours, unless accompanied by an adult guardian. Furthermore, the sale and consumption of liquor is strictly prohibited in Entertainment Centres and Family Sports and Entertainment Centres. Further details on by-law regulations can be found in Appendix B.

Family Sports and Entertainment Centres and Entertainment Centres were approved by Council as new business licence types in 1996 and 1999 respectively in order to accommodate new development proposals without changing restrictions on minors in Arcades. This was due to staff and Council reluctance at that time to change Arcade regulations. More information can be found in the staff reports from 1999.¹ Family Sports and Entertainment Centres and Entertainment Centres are subject to identical regulations in the License By-law.

Arcades and Games Room can be located within liquor-serving establishments that have a provincial Liquor Primary licence (i.e. bars and nightclubs) or a Food Primary licence (i.e. restaurants that serve liquor). The Province allows these liquor licence holders to offer arcade games, provided they comply with any terms and conditions on the liquor licence and local bylaws. In addition, if minors are permitted in the Liquor Primary establishment, the operator must not permit any licensed gambling machines or events during the times when minors are allowed to be present, with the exception of raffle tickets and bingo events. Gambling is prohibited in Food Primary establishments, with the exception of ticket raffles licensed by the provincial Gaming Enforcement and Policy Branch.

The multiplicity of business licensing types for arcade style businesses adds unwarranted complexity to the License By-law. Many of the regulations, including the prohibition of minors, the co-location of Entertainment Centres and Family Sports and Entertainment Centres with liquor-serving businesses, and rules on patron conduct (i.e. swearing) are antiquated and reflect societal mores of the past.

Staff are currently embarking on a multi-phase Business Licence Review (BLR) project to review and modernize the City's licensing regulations and processes. The first phase of the BLR project was focused on streamlining licence types and a cleaning up of the License By-law. On May 10, 2023, Council approved the streamlining of the City's current 570 licence types to 88, including for Arcades, Entertainment Centres and Family Sports and Entertainment Centres which are rationalized under one "Entertainment Facility" licence type. ² Council also approved the striking out of Section 15.3, which contains the regulations for Family Sports and Entertainment Centres, since they are verbatim to the regulations for Entertainment Centres in Section 14.2. The approved amendments to the License By-law, including the new streamlined categories, will come into force on April 1, 2024. Staff will also be reporting back in September 2023 with options and recommendations for raising business licence fees.

The next phase of the BLR project will include a review of the remaining regulations in the License By-law to ensure they meet a valid and current municipal objective, including public safety, nuisance control, consumer protection and alignment with Council priorities. This review will include arcade regulations, with the objective of modernization and potentially allowing new business types, including further opportunities for co-location with liquor serving businesses.
