This memo is intended to provide information on the progress of the Hospitality Sector Working Group.

In July 2023, DBL launched the Hospitality Sector Working Group, bringing together representatives from industry and City to explore ways to remove barriers, promote innovation, and help local businesses thrive.

Priorities

In collaboration with the working group, DBL is actively exploring innovative solutions to enrich Vancouver's hospitality scene. Priorities identified by the working group include:

- Consider ways to further improve licensing timelines.
- Review the City's year-round patio program.
- Evaluate options to simplify regulations related to lounges at breweries and distilleries.
- Explore ways to streamline approvals for Fire occupancy permits.
- Identify opportunities to streamline provincial and municipal liquor-licensing timelines.

Achievements

DBL has already implemented process changes based on the recommendations of the working group to enhance the efficiency of permitting and licensing reviews. These changes reflect our commitment to simplifying processes and supporting local businesses.



Process	Challenge	Solution
Liquor Primary	Sequential approach to process creates delays for permit and licensing timelines for new and existing bars and cabarets	Once approved by Council permit and licensing applications can now be submitted together and reviewed concurrently
Dual Licensing	New restaurants wanting to establish dual licensing are required to get their restaurant approval in place before moving to the next step	Developed a new process for dual licenses to provide more clarity for applicants and speed up permit and license reviews
Occupant Load	Timing and requirements for Fire occupancy load reviews were creating process and final occupancy delays	Collaborated with Fire to move the occupant load review ahead in the process and better align the steps to occupancy

Long Term Actions

While there has been notable successes, DBL acknowledges that there is still significant work to be accomplished. The upcoming actions will encompass more intricate, long-term priorities:

- Developing options to update the City's policy and guidelines on Liquor Establishment location and distancing is slated for Q4 2024. Options shared with key stakeholders include:
 - Reducing or removing distance requirements for Liquor Establishments to create flexibility and increase opportunity for new and existing businesses,
 - Increasing maximum person capacity of smaller licence classes to improve financial viability, and to support small establishments seeking to provide live entertainment,
 - Reduce or remove the Granville Entertainment District and Downtown Eastside moratoria to create opportunities for new establishments and increase vibrancy in the area,
 - Expansion of the Chief Licence Inspector's authority to approve liquor primary & dual applications.
- Pursuing an interim approach to ensure consistency on calculations of the 80m2 lounge/tasting area.
- Identifying opportunities to streamline provincial and municipal liquor-licensing timelines.
- Reviewing the year-round patio program.
- Reviewing requirements for public notification and costs.
- Reviewing washroom triggers.

DBL will provide progress updates about the projects the working group will be involved in through a new designated web page and periodic industry memos.

Together with the working group and other City departments, DBL is committed to finding practical solutions to challenges faced by businesses in the hospitality sector. In the three months since its establishment, the working group has already proven instrumental in creating tangible change.
