#### **PURPOSE**

This memo provides an update on the 2023-2024 winter response for people experiencing homelessness.

#### **BACKGROUND**

## Year-Round Shelter Spaces Currently in Operation

There are currently 1400+ shelter beds available 365 days a year in Vancouver.

### Permanent year-round shelter beds: ~900 beds

These shelters serve a range of community members (men, women, seniors, youth), and offer a range of services. These shelters are funded by BC Housing and depending on the operator, shelters may provide space for couples, pets, carts, meals and laundry and follow a harm reduction model.

### • Temporary year-round shelters beds: ~500 beds

Temporary shelters are opened through a partnership between BC Housing and the City of Vancouver. The City typically leases the space and contributes to tenant



improvements, and the Province provides operating funding and in some cases, also contributes to tenant improvements. Temporary shelter beds are in addition to the permanent shelter beds. There are currently ten temporary shelter sites which depending on the operator, provide space for couples, pets, carts, meals and laundry and follow a harm reduction model.<sup>1</sup>

In addition to these beds, the City and Province partner to activate additional spaces during the cold and wet winter months.

Of note, the City of Vancouver's Tiny Shelter pilot program is scheduled for completion in late November 2023. This unique pilot will add shelter capacity for an additional 18 individuals.

#### **DISCUSSION**

## 2023-2024 Winter Response Strategy

Through a long-standing partnership with BC Housing, additional shelter spaces are deployed between November to March to expand shelter capacity to ensure all residents have a safe, warm, place to come inside during the cold and wet winter months.

There are three main types of spaces that are activated as part of our winter response:

- 1. Temporary winter response shelters
- 2. Extreme Weather Response (EWR) shelters
- 3. Warming Centres

This winter, there will be an additional 373 spaces to ensure people can access a safe, warm place to come inside.

#### 1. Temporary Winter Response Shelters (67 spaces)

For the 2023-2024 winter season, there are two temporary winter shelters that will be open every night between November 2022 and March 2023, providing 67 additional shelter spaces.<sup>2</sup>

### 2. Extreme Weather Response (EWR) shelters (70 spaces)

EWR shelters are Provincially funded (through BC Housing) and delivered through partnerships with community-based service providers and faith-based organizations to provide additional temporary emergency shelter spaces during periods of extreme winter weather which threaten the health and safety of individuals experiencing homelessness.

These spaces are activated based on criteria including:

- Temperatures near zero with rainfall that makes it difficult or impossible for those experiencing homelessness to remain dry
- Sleet or freezing rain or Snow accumulation
- Sustained high winds
- Temperatures at or below 0°C, or "feels like" 0°C with wind chill

- Rainfall of at least 50mm in a 24-hour period
- EWR season runs October 15, 2022-April 15, 2023

It is important to note that the year-round shelter capacity has grown over recent years.

## 3. Warming Centres (236 spaces)

Funded by the City of Vancouver, Warming Centres are activated when temperatures reach -4 degrees Celsius (or feels like -4). Warming Centres do not provide beds or cots, but do provide a place for individuals to come inside, warm up and have a snack during periods of extreme cold. Warming centres are located in community spaces, drop-in centres, and/or other available locations.

This year, seven warming centre sites will provide up to 236 spaces when activated. It is important to note that people may come and go and staff work to ensure anyone who wants to come inside to warm up has an opportunity to do so.

### Summary of 2023-2024 Winter Capacity

In total, there are currently confirmed 373 Temporary Shelters, Extreme Weather Response (EWR) and Warming Centre spaces available this winter (See Appendix A for listings). This is in addition to the 1,400 permanent available year-round shelter beds available (see below).

Staff continue to work to identify and deploy additional sites and will update Council with the creation of any new spaces.

#### Communication Efforts to Bring People Inside

EWR and Warming Centre activations are broadcast to community service providers, government stakeholders, BC211, Translink, VPD and others. Staff also post activations via social media channels. The City's Homelessness Services Outreach team and multiple service provider organizations working with people experiencing unsheltered homelessness also encourage people to come indoors.

All EWR alerts, shelter and warming centre locations can be found on the <a href="www.vancouver.ca">www.vancouver.ca</a>. When an alert is issued, a banner will be present at the top of the page. Also, all Vancouver-owned social media channels post current information for where people sheltering outside can access a warm place indoors.

#### FINAL REMARKS

This year's Winter Response Strategy will provide an additional 373 spaces to ensure people experiencing unsheltered homelessness can access a safe, warm, place to come inside during the cold and wet winter months.

Staff will also continue working with senior government and non-profit partners to identify and activate additional spaces and increase services for people experiencing homelessness or at risk of homelessness.
