Good afternoon everyone,

Here is the compilation of Ranger reports pertaining to the encampment, dating back to April 2021. My apologies for the copy and paste. Our report generator was cutting the report off after 2 pages, for some reason.

April 22 2021 -- 12:00 hrs -- Rangers POETTER & MCTAGGART attended Rupert Park at 11:05 hrs to conduct a routine patrol of the park and to investigate a potential structure set up within the park limits. Rangers spoke to the pitch & putt staff who advised rangers that the location of the encampment is in the far SE corner of the park along the fence line. Rangers conducted a foot patrol of the area and located a collapsed tent, a tarp as well as garbage and other soiled items and material. The encampment did not appear to be inhabited or recently occupied. Rangers removed all items from the area, no additional follow up required.

Friday, May 21, 2021 - 13:40 hours - Rangers ANDERSON and SCHIOPU attended Rupert Park at 11:05 hours to inspect a report of tents in a forested area near Rupert Park. ANDERSON and SCHIOPU found a large encampment with a house, several structures, and piles of garbage in a forested area south-east of Rupert Park. **S.15(1)(I)**

With assistance from Dispatch, rangers confirmed the forested area is in Vancouver Parks jurisdiction using what3words app location: dwelled.imported.rooftop. The size of the encampment will require coordination between Vancouver Park Rangers, Sanitation, and Engineering to dismantle and clean up. Lead Ranger Setterlund notified about camp. Lead Ranger follow-up required.

2021-05-26 - 1412 hours - At 0945 hours, Rangers ADAMS and SCHIOPU attended Rupert Park for a report of an encampment on the SE side. Rangers entered the encampment on 1st Ave just west of the Highway 1 entrance. Rangers observed green tarp structure, a brown tent and a makeshift wooden cabin. Rangers also observed miscellaneous items scattered around the area. Rangers did not receive a response from the structures. Rangers took pictures on VPR I1 and departed from the area.

May 26, 2021 - 1249hrs. - Rangers MCTAGGART, NDAYISENGA and Lead Ranger SETTERLUND attended Rupert Park at approximately 1138hrs in regards to a large encampment on the South East side of Rupert Park. Upon arrival to the park rangers walked to the described area (What 3 Words - IRON.CROAK.GENDER) on the South East side of the park and found the entrance to the encampment off of 1st Ave. When rangers walked in we noticed a large wooden shack, a green tarp structure and a brown camo tent. Scattered around was an abundance of items including bike parts, propane tanks, clothes and garbage. Rangers approached the large wood shack and knocked on the door a s.22(1) s.22(1) Rangers asked if^{s.220} was in contact with and Outreach

s.22(1) Rangers explained to ^{s.22(1)} that Tent/Structures are not allowed in parks during the day or in forested area and that we will be checking back regular with Possibly VPD and will be passing on ^{s.22(1)} information to Outreach

workers but in the mean time to gather set is sentials and expect to depart, s.22(1) s.22(1) Rangers then moved to the tarp structure and spoke to s.22(1) speaking to s.22(1) said s.22(1) s.22(1) and s.22(1) Rangers explained to s.22(1) that tent and structures are not allowed during the day or in forested areas. We informed s.22(1) told Rangers that the camo tent belonged to s.22(1) when s.22(1) to pass the message along to s.22(1) that tents and structures are not allowed during the area to follow up at another time.

On June 8, 2021 at 1015 hrs Rangers SETTERLUND, MCTAGGART and LEE attended Rupert Park to check the ongoing encampment and s.22(1) progress in moving out. Rangers spoke with s.22(1) and s.22(1) who were at the outskirts of the encampment and told rangers that 2 weeks would be plenty of time to move out. Rangers will follow up consistently to keep the same message that s.22(1) may not stay at that location in Rupert Park after June 22, 2021. Rangers to work with cities sanitation crews on a plan of cleaning up the area.

October 17th, 2021 - 1318hrs - Ranger DON attended Rupert Park at 1049hrs for reports of a large camp in the SE area of the forest. Ranger DON was aware that a few months ago, there had been a camp in this location, but sanitation crews had supposedly removed it. Upon arrival, Ranger DON checked the same area as the previous camp was located, and found a massive, 2 house plus junkyard of items camp, in the location. Ranger DON took photos on his Lead phone, and forwarded to Superintendent DEJONG. The 2 wooden houses were about 20-25 feet tall, with windows, but you could not see in. There were multiple bikes, carts, trolleys, propane tanks (including a massive propane tank, likely used to fill other propane tanks, sinks, toilets, baby strollers, and a ton of other household items. Ranger DON disengaged as he was solo. Follow up will require VPD, Sanitation, and a demolition crew.

October 28, 2021 - 1044hrs. - Rangers MCTAGGART and SETTERLUND attended Rupert Park at approximately 0850hrs to check in on the encampment at Rupert Park along 1st Ave and Hwy 1. Rangers approached the structures identifying ourselves as Park Rangers however no one was home at this time. Rangers found and abundance of items spread around the whole area including propane tanks, clothes, metal, bikes and garages. Rangers departed with no further action taken at this time.

March 12, 2022 - 1340hrs. - Rangers MCTAGGART, SHEU and JUNG attended Rupert Park at approximately 1136hrs to check in on the Shack that is build near the corner of HWY 1 and 1st AVE. Rangers approached the area where the shack is and called out identifying ourselves as Park Rangers 5.22(1) answered and came to the door. Rangers conducted a wellness check on ^{5.22(1)} and ^{5.22(1)} but 5.22(1) but 5.22(1)

22-04-26 - On Tuesday, April 26-2022 at approx. 0902 hours Park Rangers 94 FLORES & 80 MCTAGGART attended Rupert Park in Vancouver, B.C. for proactive check on a unpermitted building at the south-west corner of the park. Park Rangers arrived in the C5662 and proceeded to call for a safety timer at 0918 hours; Rangers entered the forested area where the house was and found the area to be full of garbage occupying park space; approx. 15 propane tanks were found at the area; Rangers approached the house and introduced themselves as Park Rangers and attendance for wellness check on occupants within the dwelling; an individual by the name of s.22(1) then opened the door and engaged in a conversation with Rangers; it was stated that s.22(1) of the VPD regarding finding housing. Shortly afterwards, Rangers proceeded to leave the area after

finding the occupant to be coherent and responsive. No further action taken by Rangers.

On May 05th 2022 at approximately 1000hrs Rangers MCTAGGART and SETTERLUND attended Rupert park to attended the large wooden shack on the South/East corner of the park.

Rangers approached the structure and identified ourselves as Park Rangers asking if anyone was inside, $\frac{s.22(1)}{s.22(1)}$ answered and came outside of the shack. Rangers conducted a wellness check with $\frac{s.22(1)}{s.22(1)}$ as last time Ranger were their $\frac{s.22(1)}{s.22(1)}$ but $\frac{s.22(1)}{s.22(1)}$ but $\frac{s.22(1)}{s.22(1)}$

Rangers spoke to s.22(1) about the amount of items that are accumulating in his area and that that it seems to be growing every week. ^{s.22(1)} said s.22(1) Rangers let ^{s.22(1)} know that we will try to come

by every week to see progress and to check in with ^{5.22(1)} Ranger then departed from the area with no further action.

September 28, 2022 - 1251hrs - Rangers BUSH and LUONG attended Rupert Park at 1003hrs in response to a reported encampment within the park near the pedestrian underpass walkway.

Upon arrival at 1003hrs, Rangers BUSH and LUONG conducted a patrol of the park. Rangers observed 1 male sleeping near a tree at the South area of the park, near the underpass. Rangers conducted a wellness check and identified the male as 5.22(1) advised Rangers that advised Rangers that a tent, but decided to not have it erected, and found it more comfortable sleeping in a sleeping bag. Rangers inquired if the nearby items belonged to 5.22(1) to which 5.22(1) and claimed a previous camper had accumulated those items. Rangers continued patrol and checked the known nearby encampment with the wooden house, within the tree line. Rangers conducted a wellness check and observed a tent and several wooden items. The tent was found tent to be empty. A note was left on the entrance to the tent, advising the occupant 5.22(1)

s.22(1) Rangers noted the items to be well placed within the tree, requiring Rangers to traverse over several tree branches for removal. Rangers BUSH and LUONG cleared from the area and continued patrol. Rangers found no other issues within the park. Rangers BUSH and LUONG cleared from Rupert Park at 1015hrs.

Ranger follow up required.

2023-JAN-19 - 21:00 hours - On January 19th, 2023, at approximately 19:44 hours, Vancouver Park Rangers (VPR) PALAMOS 124 and SAMSON 104 attended Rupert Park to lock the gates. Rangers were in full uniform and were driving marked VPR vehicle 7500.

Upon arrival Rangers observed 2 unmarked VPD Dodge Chargers parked inside the gates, apparently in a debrief. Rangers approached the constables and informed them that they needed to lock the gate and asked how long they would be. The constables, 4 plain clothes, asked Rangers about the large encampment in the east end of the park. Rangers explained the encampment situation to the constables. The constables wanted to inspect the camp and determine the status of it and any occupants inside. VPD escorted Rangers into the camp. Rangers did not call a safety timer as they were escorted by 4 VPD constables and did not feel a safety risk.

Once inside the encampment, Rangers and VPD searched around and found the encampment to be abandoned. There are approximately 40 truckloads of garbage and other items in the camp. The main area has a 2 story enclosed wooden structure complete with a roof and a large amount of bike parts inside, as well as outside and strewn throughout the camp. Adjacent and north of the main area is a large tent/tarp complex. The openings of the tents were open and the contents inside were completely soaked. There was also a large amount of garbage in this area. The constables expressed an interest in the removal of the camp and were surprised at the size and scope of it. No police file is associated with this event. All officers were in plain clothes and no badge numbers were recorded.

Rangers cleared the park at approximately 20:09 hours.

January 25th, 2023 - 1424hrs - Rangers DON, OTHMAN and MCTAGGART attended Rupert Park at 0957hrs to check up on the large camp in the forest off 1st avenue. Upon arrival, Rangers noticed on the approach to the camp, there was a considerable amount of garbage compared to the last time Rangers were there. Rangers approached the wooden house and checked if anyone was home. There was no answer, and Rangers could see from a couple locations, that the inside of the house was unoccupied. Rangers moved along to the tents in behind the wooden house and checked to see if anyone was home, but both tents were open and abandoned.

Rangers proceeded to take videos and photos of the shock and awe size of the camp, and the amount of various items of garbage in the camp. There were countless bottles of propane, numerous jerry cans of fuel, lots and lots of metal, power tools, bedding, clothing, plastic furniture, piles of wood, drug paraphernalia and needles. Rangers sent the photos to Superintendent DEJONG and a future site assessment and coordination with other departments will be needed to remove.

Rangers were informed, at the homeless count meeting by an employee with the Union Gospel Mission, that the **5.22(1) had passed away**





Good Morning,

Just a preliminary update on the abandoned encampment at Rupert Park. I met with Mike Knoll(Park Operations west) and Evan Chapman (Superintendent 1- Sanitation Operations) on site and we assessed the area and determined the following plan of action:

- Open up fence along roadway Mike next week
- □ Connect with Troy (Urban Issues) to tree back trees and possibly remove one tree prior to clearing the site tentatively next week
- Bring in contractor to conduct flailing of blackberry's prior to clearing of the site next week
- Parks Operations to bring loader or backhoe into the site to bring debris forward and pile closer to the roadway – next week
- Engineering (Sanitation) to develop a plan, timeline for crew, equipment including track loader, roll off bins, roadway signage and traffic control.
- □ Collection of propane tanks and other flammables to be collected and stored on site until contractor can remove

Once the overall plan has been developed we will coordinate the crews to remove all hazards, debris etc. and clear the area. Restore fencing and close off the area.

At this point in time Park Operations is tentatively set to go into the area early next week to prepare

the site for mass cleanup. Evan Chapman will develop the plan from Sanitation perspective as they will be doing the majority of the work. Once the plan with dates is set, I will forward the it along with the timeframe for removal. Please let me know if you have any questions. Thank you


