## AMENDING AGREEMENT (NO. 2)

THIS AGREEMENT (this "Amending Agreement") is made as of the 29th day of July, 2022

BETWEEN:

PAYBYPHONE TECHNOLOGIES INC., Suite 403, 1168  
Hamilton Street, Vancouver, British Columbia, V6B 2S2

(the "Service Provider")

AND:

CITY OF VANCOUVER, 453 West 12<sup>th</sup> Avenue, Vancouver,  
British Columbia, V5Y 1V4

(the "City")

WHEREAS the Service Provider and the City entered into a Mobile Parking Payment Services Agreement (PS20160599) dated September 6, 2017 with respect to the supply of a mobile parking payments system (the "Agreement"); and

WHEREAS the Service Provider and the City wish to amend the Agreement;

NOW THEREFORE, in consideration of the mutual covenants and promises made by the Service Provider and the City and other good and valuable consideration, the receipt and sufficiency of which each of the Service Provider and the City acknowledge, the Service Provider and the City agree to amend the Agreement as follows:

**1. TERM**

Section 6.0 of the Agreement is amended by extending the Term through to September 6, 2023.

**2. FURTHER PROVISIONS OF THIS AMENDING AGREEMENT**

Unless otherwise defined in this Amending Agreement No. 2, capitalized terms used herein will have the meanings ascribed thereto in the Agreement.

**3. RATIFICATION OF TERMS**

The parties hereby ratify the terms and conditions of the Agreement, except as varied in this Amending Agreement No. 2, and agree that except as amended by this Amending Agreement, the Agreement will continue in full force and effect.

**4. COUNTERPARTS**

This Amending Agreement No. 2 may be executed in any number of counterparts. All counterparts, taken together, constitute one instrument. A party may execute this Amending Agreement No. 2 by signing any counterpart.

5. ELECTRONIC EXECUTION

Delivery of an executed signature page to this Amending Agreement No. 2 by either party by electronic transmission shall be as effective as delivery of a manually executed copy of this Amending Agreement No. 2 by such party.
