

Subject: Update: DTES market

Good evening Mayor and Council,

Please find below and update from Sandra Singh, General Manager of ACCS regarding the work to identify alternatives to street vending after the market closes:

- Staff continue to explore indoor vacant storefronts and vacant lots in the DTES for daily vending, however thus far there has been no willingness to lease space to the City for this purpose.
- Staff are now also looking to identify space to allow pop-up markets on the weekend – one day for women’s only vending and one day for elders only vending.
- Staff are also in discussions with the Chinatown BIA about the need for a vending site for Chinese-Canadian elders, ideally somewhere in Chinatown if feasible.
- Staff are also in discussions with several DTES community groups around low threshold vending, including different models such as donation-based thrift stores, etc. However, the current lack of storefront availability remains a limiting factor.

While there are various ideas being explored, there are currently no confirmed solution as of yet for the end of August. Staff will keep Council apprised of progress exploring the options above and any other that may arise.

Re: Marguerite Ford Apartments – 215 West 2nd Avenue, Vancouver BC

A lot of troubling news about BC Housing recently. Mismanagement, corruption, conflicts of interest, deaths at supportive housing buildings etc.

I'm sure you are aware that a very controversial supportive housing building was approved in Kitsilano. Despite well founded objections of the community BC Housing and the City of Vancouver rammed it through.

The residents near 7th and Arbutus pointed with good reason to the problems at an early project at 2nd and Cook near the Olympic Village, that being the Marguerite Ford Apartments (MFA).

. MFA opened in 2013. It was a disaster from day one and is still a disaster.

I attached two photos that encapsulate the problems at MFA. The first taken in the front of the building shows VPD responding to an assault in the building. The second taken in the back of the building shows how the operator, RainCity Housing deals with their used needles.

The building as operated by RainCity Housing is not safe for the residents or neighbourhood. In short they are incompetent and negligent and should be replaced.

Complaints to the City and BC Housing have no result. These two entities are engaged in denial and cover-up of the problems at MFA.

Please ask your staff to pull media reports about MFA and RainCity Housing (who also operates the OPS site in Yaletown which is another disaster). Further I suggest VPD be contacted about the problems at 215 West 2nd Avenue.

My knowledge of MFA comes from personal observation, media reports, discussion with VPD and residents of the building.

A few highlights of the history:

A Director of RainCity Housing, when I brought my concerns about problems in the neighbourhood that include fighting, thefts, public urination, drug use, etc. responded that she was not concerned about what the residents do outside the building.

There is a constant stream of police, fire, ambulance and restoration vehicles responding to assaults, fires, overdoses and floods.

Previously drug dealers would deliver to the addicts living there, now drug dealers have moved in. The building is a wide open drug market. There is no attempt at recovery. In addition a gang of thieves operates out of it.

Minimal staffing, no on site supports, staff lacking training to deal with residents with severe drug addictions and or mental illness. Not to mention the proportion of residents that are chronic offenders.

There is no curfew so residents wander around at all hours of the night screaming and fighting and doing drugs in addition to vandalism and break-ins. Damage to our landscaping, trespassing and graffiti are a constant occurrence.

In short the peaceful quiet enjoyment of our property has been ruined.

There has to be a public inquiry into the operation of this and other supportive housing. I requested that two different City of Vancouver Chief License Inspectors review the operating permit of MFA, both declined citing there were no problems at the building.

Thank you for taking the time to read my letter.

Dear Commissioners,

I am writing to update you on the unpermitted and unsanctioned Cannabis Day events planned for Thornton Park and possibly Sunset Beach Park on July 1, 2023. Unlike the annual 420 initiative which is positioned as a charter rights protest, Cannabis Day events are largely markets focused on the illegal sale and distribution of cannabis products. The Vancouver Police Department has clearly communicated to Cannabis Day event organizers that there will be consideration to enforce applicable laws, including laws governing the sale and possession of cannabis. Selling cannabis at any time requires sellers to be in compliance with the law, including the Cannabis Control and Licensing Act (CCA). VPD members will be present at all events and will be speaking with Cannabis Day vendors to advise of enforcement that will be taken for any violation of the CCA. The goal of the VPD will be to work collaboratively with event organizers and participants to ensure that these events occur in a peaceful and law abiding manner.

Park Board staff have attempted to contact the organizers of these Cannabis Day events but have not received any response. Accordingly, staff are working collaboratively with other supporting agencies, including the City of Vancouver, the Vancouver Police Department, and the Provincial Community Safety Unit (responsible for provincial enforcement of the CCA), to protect park spaces and ensure the safety of park users and the general public. The responses to these unsanctioned events will be site specific and as follows:
