I am responding to your request of December 9, 2023 under the ***Freedom of Information and Protection of Privacy Act*** for:

**Record of suicides that occurred at all SRA buildings as identified in Schedule A of the Single Room Accommodation By-law No. 8733, organized by location. Date range: January 1, 2018 to December 8, 2023**

All responsive records are attached.

Please note, the records reflect suicides in City-owned or -operated buildings only, which does not include lease holds with non-profit organizations operating SROs on City land or buildings, or private SROs, or SROs provincially funded that the City is not a party to.
