In April 2023, Council approved a motion to reduce green house gas emissions (<u>see here</u>) that directed staff to:

- 1. explore the establishment of an incentive-based pilot program for condos, rental apartments and care homes;
- 2. explore innovative retrofit solutions through a design competition; and
- 3. partner with other levels of government and BC Hydro to scale-up the incentives offered to multifamily building owners in Vancouver.

This memo provides an update on the progress made by staff and the next steps before bringing recommendations to Council later in 2024.

Following the Council motion City staff initiated a working group with counterparts in the BC Government and BC Hydro. A summary of progress made through the end of 2023 and next steps is provided below.

#### **Heat Pump and Complementary Retrofit Incentives**

The Province, through the CleanBC Better Buildings program, will be offering several incentives for installation of heat pumps in multi-family buildings. The incentives will allow for municipalities to offer top-up funding in their respective jurisdictions. The program details will be announced by the Province this March for the fiscal year starting April 2024. In advance, City staff are working



with their counterparts at BC Hydro and the Province to determine appropriate top-up amounts from the City and will bring this back to Council for direction.

## **Multifamily Retrofit Support Programs**

Through a collaboration involving CleanBC, BC Hydro, Metro Vancouver, City of Vancouver and the Zero Emission Innovation Centre (ZEIC), a province-wide multifamily retrofit support program is being designed and will be launched in Spring 2024. The partners will also develop a condo-focused support program. More details will be shared with Council as this work progresses.

### **Design Competition for Innovative Retrofit Solutions**

City staff have been in discussion with experts and stakeholders since Spring 2023 to develop a design competition aimed at catalyzing innovative solutions to retrofitting multi-family buildings and overcoming challenges faced by these buildings when looking to install heat pumps. A framework for this competition is being finalized being before bringing it to Council for consideration.

### **Next Steps**

Based on the March 2024 timing of the Provincial government approval of funding and program details and the additional work required to refine the design competition and identify potential partners, City staff are planning to bring a report to Council for consideration in Q3 2024.
