This memo is in response to a Council motion passed on July 19, 2022, directing staff to investigate and report back on a C40 Cities-supported workshop hosted by Vancouver on accelerating local climate action plans.

City staff have been working with C40 Cities (a network of nearly 100 cities focused on advancing climate action) to host a workshop in Vancouver on May 14-16 focussed on "green and thriving neighbourhoods". The workshop will include staff from 14 leading cities across North America and will focus on best practices to advance complete, walkable neighbourhoods. The workshop will feature a public event on May 15, which will include a keynote speaker and panel discussion (an invitation to Mayor and Council was circulated by email on March 15). This C40-supported workshop and public event is intended to help strengthen the connection between land use planning and climate action in Vancouver and elsewhere.

In addition to the C40 workshop, City staff presented at a Climate Leadership Symposium last fall hosted by the provincial Climate Action Secretariat and Thompson Rivers University that was focused on advancing local government and public sector climate action plans across B.C. The convening included staff from local governments and public sector organizations across the province. City staff shared our approach to climate action planning, monitoring and reporting, as well as our experience with



requiring zero emissions space and water heating systems in new construction. The symposium also provided a forum to learn more about progress in other B.C. cities as well as the provincial CleanBC roadmap, including opportunities to align our climate work and leverage funding.
