Dear Mayor and Council,

Please see the attached Council Memo from Lon LaClaire regarding **School Slow Zones on Arterials Pilot Results**. A short summary of the memo is as follows:

- This memo provides an update on the School Slow Zones on Arterials pilot
- In spring 2023, speeds were lowered at nine elementary schools to 40 km/h on non-MRN arterials and 30 km/h on collector roads.
- Speed data and parent feedback was collected to evaluate the pilot impacts. Overall, modest speed reductions were observed and parents expressed strong support for keeping the reduced speed limits.
- Based on the positive results, staff recommends expanding the speed reductions in school zones adjacent to non-MRN arterials and collector streets to all remaining schools.
- Using funds from the Growing Communities Fund, staff plans to implement 10 schools zone speed reductions per year for the next three years.

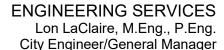

This memorandum is an update on the School Slow Zones on Arterials pilot and next steps.

#### **Background**

In spring 2023, staff implemented a pilot to lower the speed limits next to nine elementary schools. Arterial streets changed to 40km/hr 8am-5pm school days and collector streets changed to 30km/hr 8am-5pm school days for all pilot locations. The pilot included signage and paint changes, an education campaign, and data collection.

#### **Pilot Results**

Speed data was collected before and after the pilot to determine impacts on vehicle speeds. A complete list of pilot locations and their results can be found in Appendix A. A summary of the changes is below:

- Vehicle speeds at most locations reduced moderately. Average vehicle speeds decreased up to 13% and 85th percentile speeds decreased up to 14%
- Similar speed reductions were seen when the speed limit was reduced from 50 km/hr to 30 km/hr or to 40 km/hr



- Locations with higher initial speeds had greater speed reduction impacts
- Reductions in speeds were observed at all times of the day despite speed limits only being in effect during school hours.
- Speed reduction effects did not appear to reduce between the one month, six months, or one year mark of the pilot.
- Speed limit paint stencils six months into the pilot increased the speed reduction effects.

Surveys were also sent out to the parents of participating schools regarding their perceptions of safety. Over 380 families responded to the survey and the key findings are as follows:

- The majority of parents (92%) were in favour of keeping the reduced speed limits.
- About 70% expressed that the pilot had made the streets safer.
- About half of the parents felt more likely to use active modes when travelling to school.
- A key theme that emerged from the general feedback question was that there was a strong interest in more enforcement of speed limits around schools.

The total cost to implement the signage and paint changes was approximately \$10,000 per school. No major concerns regarding impacts to transit, goods movement or emergency services were raised by partner agencies after the pilot was implemented.

#### **Next Steps**

Given the positive results identified in this pilot and as part of the Vision Zero goals, staff will:

- Make the new speed reductions at existing pilot locations permanent.
- Expand the practice of reducing speeds in school zones on non-MRN arterial and collector streets to all relevant schools, prioritizing locations with higher existing speeds.
- Continue to monitor existing locations to identify and implement further speed management measures where speeding remains a concern.
- Using funding allocated from the Growing Communities Fund, implement speed reductions at 10 school zones per year for the next three years.
- As part of next phases for an update Vision Zero Strategy, develop policy around speed reductions on other types of streets in the City.





(a) 85th Percentile Speeds




(b) Average Speeds





Figure 3. Speed results by time of day at Sir Wilfred Laurier Elementary
