I apologize if it appears as if Commissioner Bastyovanszky and I have disappeared from this significant issue, however, I can assure you that this issue has dominated our agenda for the past six months.

As you can see, Park Rangers are constantly engaging with those seeking shelter outside the designated area and with those that have shelters within the designated area. The goal of their interaction is to connect those in the park(s) with temporary or permanent housing.

When we first met, I was buoyed by the multiple announcements of housing being created through partnerships with the Provincial and City governments. As we can see, more housing is needed immediately, and we are advocating to both levels of government for spaces to be made available. The decampment of Hastings Street has increased the number of individuals seeking shelter in parks, which is evident by the increase in tents and shelters in Oppenheimer Park.

I cannot agree more that we need those living in Crab Park to move to temporary or permanent housing and the park to remediated for the enjoyment of all. I like your suggestions and will share them with the General Manager.

Thank you for the reply Peter. It's good to see the city stepping up with shelter space but we all know that temporary shelter is not what is going to get this encampment cleared. Everyone living there has been offered and has refused shelter space repeatedly. Unfortunately, due to the mismanagement of the issue by the previous Parks Board and staff, what is now required is for all parties (City, Parks Board, BC Housing and the Province) to get together and commit a BLOCK of permanent social housing sufficient to accommodate <u>all</u> of the 20 or so squatters in the Park all at once. Dealing with this one at a time <u>can never work</u> because before you are back with the next offer someone has moved in and filled the spot in the park.

The solution is simple but requires coordination and political will that has been sorely lacking.

I cannot overstate my disappointment in the lack of progress I have seen since the election. Many others feel the same way s.22(1)

Council and Parks Board get together and accomplish this. It's why you were elected as a slate.

Here's what needs to happen:

- 1. Working together, Council, PB, BC Housing and the Provincial Govt need to allocate a block of housing sufficient to accommodate current Crab Park squatters. This is possible but will require a singular focus on this issue for a period of time, rather than piecemeal offers going out across the community... That approach has failed for three years and will continue to fail time for a new strategy.
- 2. Return to court and iterate that these are the people residing in the park, demonstrate that they have refused prior shelter/housing options and that there's is now a block of permanent social housing for them.
- 3. Secure an injunction requiring them to leave the park either to accept the housing offered or move elsewhere.
- 4. Fence off, clear and remediate the park
- 5 Return it to community use and implement a plan to prevent future occupation.

Thank you for the note and I share your concern over this action at CRAB Park today.

Our parks are precious neighbourhood assets for recreation and the enjoyment of all.

I am strongly opposed to encampments in city parks. Council is working hard to support staff in ensuring we fund and onboard additional shelter spaces and warming centres to bring people inside – and connect them to longer-term housing solutions, as well as healthcare outreach.

Here is some recent information from city staff on our growing shelter and warming centre capacity:

As we have discussed previously, I share your concerns over this ongoing encampment in CRAB Park, and understand the importance of this particular green space in a neighbourhood that is already greenspace deficient.

Scott and Brennan; Today there was an attempt to construct a permanent, insulated structure in the park. Arguably there are several non temporary structures in there already but this is clearly escalating. Your assurances to this group (Gastown Residents) seem to have completely disappeared. We were assured early in your tenure with the Parks Board that steps would be taken to clear this encampment and return the park to community use, we were assured that the area covered by the fencing would be expanded to prevent the expansion of the camp, we were assured that additional trees/hedging would be added to the southern boundary to mitigate the community impact... NONE of this has happened. Given we are three years in and every single person in that encampment has been offered housing on multiple occasions and have refused and are now attempting to build permanent homes.... Surely the time has come to return to the courts and secure an injunction. All of the original judge's requirements seem to have been more than met at this point. Please provide an update of the concrete steps you are taking to clear this encampment and return the park to the community.

Subject: Cold Weather Response - January 12, 2024

Good morning, Commissioners.

As we head into the cold weather, I thought we should share a bit more information about how public realm By-law enforcement is handled in relation to people without housing for whom we have heightened concern in relation to health and safety impacts of extreme cold. As well, below provides an update on the ongoing work at Oppenheimer Park.

Cold Weather

	Enforcement of Park Board and City By-laws is a necessary daily activity to ensure safety and access to the public realm, so this operational work	
con	nues. The only time we may pause is during an active snowstorm or other weather or public safety event where the work is not possible to do safe	ly.

□ In very cold weather, our focus is on urging people to come inside to Warming Centres or shelters. It is dangerous to be out in the extreme cold, both in terms of health risks (e.g., hypothermia) and the increased risk of fires due to heating attempts (candles, propane tanks, etc. have all caused tent dire deaths in the past).

☐ Engineering crews and Parks Rangers all have the Warming Centre & Winter Shelter information sheet so that we can ensure the most up-to-date information is shared and they share this information with people on the streets.

In very cold weather like this, impoundment is infrequent but if needed or appropriate, staff would proceed. They exercise discretion at these times.

☐ Engineering contractor Mission Possible, who supports our public realm cleanliness work along East Hastings St, is handing out emergency blankets to anyone that needs one.

ACCS has updated the EWR and shelter listings at vancouver.ca with two new EWR sites that they were able to secure, adding an additional 15 spaces in operations.

☐ ACCS continues to work with colleagues in Real Estate to identify other spaces to active as shelter and warming centres.

□ Carnegie Centre is going to open two hours earlier at 7:00 am on Friday the 12th and Saturday the 13th. They are exploring operational feasibility of an early opening on the 14th and 15th as well.

In terms of getting the word out, the Homelessness Services Association of BC issues the notice of EWR activation to government, VPD, TransLink, and community and social service providers (anyone can sign up for the email list: https://hsa-bc.ca/extreme-weather-notifications.html. 211 also has a daily list of what's open, and we add a yellow banner/ribbon across the City's website on the home page with a link to information. Communications also pushes out messages on the City's social media. All City-related street-based workers — Sanitation crews, Park Rangers, Outreach staff, VFRS and VPD have this information as well and collectively encourage people to come inside. There indeed may be some people in the community who are not aware of places they can go, but if they approach a City worker, non-profit provider or go to Carnegie Centre, the Evelyne Saller Centre, or any public library, those staff should all have information to share.

□ is a	Effective Saturday, Engineering Services will deploy a By-law enforcement team to the park in the afternoon on an as needed basis. Of note, this team redeployment from E Hastings St. We will monitor the impacts on E Hastings of this redeployment.
	As above, crews and team members will continue to encourage people to come inside from the cold where it is warmer, healthier, and safer.
IHO	As of this morning, there were 15 tents in Oppenheimer Park. All but one resident complied with the By-law. This person's tent was allowed to ntinue to remain because the s.22(1). OT team has been engaged and is monitoring the situation. Staff are very concerned about the s.22(1)

We recognize that seeing coverage of this work in media can often lead to questions and concerns about the City's response. Our Homeless Outreach team is actively engaged with individuals sheltering in parks and Rangers and Engineering staff make every effort to connect individuals with services, where they are interested to do so. We want to acknowledge that Park Rangers and Engineering crews are asked to play a very difficult role in maintaining the accessibility, vibrancy, and safety of our parks and the public realm. Until such time as there is a systemic solution to the homelessness crisis in the region, we will continue to do our best to balance the diverse demands and issues that arise and appreciate both Commissioner's and Council's support for the staff doing this difficult work.




