SUBJECT: Q3 2024 public engagement schedule

Dear Mayor and Council,

The purpose of this memo is to provide a high-level overview of upcoming City-led public engagement projects in Q3 2024, excluding stakeholder engagement activities.

The following table is meant to offer an approximation of engagement timelines for Q3; exact dates for each project are determined closer to the launch date. Generally, projects are open for input for three to four weeks from their launch date.

Week of	Project	Description
July 1	Stanley Park Mobility Study (PB)	This final phase of the Stanley Park Mobility Study explores six possible mobility options for Stanley Park, focusing on Stanley Park Dr.
July 15	Gastown Streets and Public Spaces (ENG)	Residents, visitors and businesses will be invited to share their thoughts on the Water Street pedestrianization pilot.
July 22	ACCS Community Centre Service Review (ACCS)	Ongoing engagement with Carnegie, Evelyne Saller and Gathering Place community centre users on services and programming.

Aug. 19	2025 Budget (FSC)	Residents and businesses will be invited to share their thoughts on the City's annual operating budget through a Talk Vancouver survey on priorities for City spending and managing tax dollars.
Sept. 9	Melville Complete Street Upgrades (ENG)	Engagement will gather input on transportation improvements along Melville St., including a bi-directional bike lane extension.
Sept. 16	Vancouver Social Housing Initiative (PDS)	An opportunity to provide feedback on proposed changes to the Zoning and Development Bylaw that will enable the development of new social housing projects.
Sept. 16	Healthy City Strategy - United Nations Social Indicator Survey (ACCS)	A survey to collect data on key quality of life indicators and perceptions across Vancouver's population.
Sept. 23	Climate Emergency Action Plan Refresh (PDS)	The public will be invited to provide input on the CEAP refresh and action plan to meet the Climate Change Adaptation Strategy.
Sept. 23	VEMA Emergency Preparedness	A survey to understand the public's level of readiness for an emergency and identify barriers related to emergency preparedness.

2025 Budget Engagement Update

Between August 19 and September 16, residents and businesses will be invited to provide input on the 2025 Budget, in English, Simplified Chinese, Traditional Chinese and Punjabi, using the City's Shape Your City engagement platform.

To encourage public participation, budget engagement opportunities will be promoted through social media, digital advertising and posters at civic facilities. 3-1-1 callers will also be able to take the survey over the phone as a means of enhancing accessibility.

As part of the engagement reporting and analysis, data will be weighted based on age, neighbourhood and size of business to align with Census demographics for the city.
