- 2. Correspondence to and from the Mayor's Office regarding plans to remove the elected Park Board;
- 3. Internal discussions regarding the motion to Council by Mayor Sim to amend the Vancouver Charter to remove the elected Park Board; and
- 4. Any drafts and discussion on press release issued by the Office of the Mayor on December 6 (https://vancouver.ca/files/cov/mayor-seeks-amendment-vancouver-charter-to-remove-the-elected-park-board.pdf).

Key Messages – PB

- This is a new era of parks in Vancouver.
- We are taking a long overdue step to ensure our parks and recreation facilities are able to serve our community to their fullest potential.
- Our parks are our city's jewels, and our commitment to preserving these green spaces remains unwavering. This change is about managing these spaces more efficiently, not about compromising them.
- We are the only major Canadian city with a separate park board structure, this has led to unnecessary duplication of services.
- Mayor Sim has a motion coming to council that if passed will request the Province amend the Vancouver Charter to eliminate the requirement for an elected Park Board, and bring the oversight of parks and recreation under City council.
- The proposed motion also asks that the Province amend the Vancouver Charter to increase protections for park land and green spaces.
 - Specifically the motion requests that the Province amend the Charter so that any land use changes for parks and green space would require unanimous support of council followed by a public referendum.
- The Vancouver Auditor General released a performance audit of the Park Board's revenue management practices earlier this year.
- The audit determined that the Park Board did not operate an
 effective framework for achieving revenue-related objectives,
 and that there was not enough proactive engagement with
 council to ensure priorities aligned with available funding.

Additional Park Board Key Messages:

Land Ownership/Park protection

- This change will strengthen protections for parks and greenspaces.
- There are a number of parks across the city that are currently designated as temporary parks or greenspaces under the custody, care and management of Park Board.
- We've asked staff to speed up the work being done to transition these parks and greenspaces to permanent park status and ensure their protection for future generations.
- In many cases there is City infrastructure on these lands, and designating them a permanent park can create challenges for upgrading and maintaining any critical infrastructure. Once the Park Board is folded this wont be an issue.

 consent.




















































Motion Introduction SNs (KEN): Amendment to the Vancouver Charter

- We are committed to making Vancouver's parks and recreation facilities the best in the world
- And we were elected to make bold decisions and take decisive action when necessary to support Vancouverites

Vancouver Mayor Ken Sim Seeks Amendment to the Vancouver Charter to Remove the Elected Park Board

Vancouver, **B.C.**, **December 6**, **2023** – Mayor Ken Sim announced this morning that he is bringing forward a motion asking the Province to remove the requirement for an elected Park Board under the Vancouver Charter.

To accomplish this change, Mayor Sim will be introducing a motion at next Wednesday's Council meeting requesting that the Province amend and repeal the relevant sections of the Vancouver Charter, and for the legal powers currently held by the Park Board to be transferred to City Council.

Mayor Sim's motion states that in recent years, "it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in the governance structure is not only needed, it is the only viable path forward to efficient and effective parks and recreation services for the people of Vancouver."

"Make no mistake about it. Vancouver's parks, recreation services, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved indefinitely for future generations," said Mayor Sim. "The commitment I'm making to the people of our city today includes establishing stronger protections around any changes to our parks. This will be a new era for parks and recreation in our city."

Vancouver is the only municipality in the entire country with an elected park board. In every other city in Canada, parks and recreation services are managed directly by a parks and recreation department under the direction of their respective city councils.

Recently, Vancouver's independent Auditor General released a performance audit of the Park Board's revenue management practices. The audit determined that the Park Board did not operate an effective framework for achieving revenue-related objectives. Moreover, it found that the Park Board was not proactively engaging with City Council to align its priorities with available funding, despite the fact that all Park Board expenditures require the approval of City Council.

Vancouver's park and recreation assets include 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sports playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas among other services and facilities.

Mayor Sim's motion also calls for the creation of a Parks and Recreation Transition Working Group to facilitate a smooth transition of responsibility for park and recreation services from the current oversight by the Park Board to the oversight of City Council. The working group would be in place for six months to coordinate ongoing engagement and relationships with park and recreation stakeholders. It would be supported by City staff through the City Manager's Office.

Motion:

Amendment to the Vancouver Charter

Submitted by: Mayor Ken Sim

WHEREAS

- 1. The City of Vancouver, including the Vancouver Board of Parks and Recreation ("Park Board"), is primarily created and governed by the *Vancouver Charter (VC")*, a provincial statute enacted in 1953 that incorporates the City of Vancouver;
- The VC sets out the statutory powers and authorities which govern the City of Vancouver, and provides a range of powers and responsibilities different from those of other communities governed primarily by the Community Charter ("CC") and the Local Government Act ("LGA");
- 3. The *VC* governs how the City operates, what by-laws Council can enact, and how budgets are determined. Under the *VC*, Council has the authority to enact by-laws to regulate such things as noise and land use, to buy and sell property, to collect certain taxes, to approve expenditures, and to take on debt, give grants, and hire and discharge employees;
- 4. The Park Board is established by section 485 of the VC (Part XXIII Parks), which reads:
 - "A board of commissioners, to be known as the "Board of Parks and Recreation" or "Park Board," shall be elected as hereinafter provided, and shall consist of seven members or such other number as the Council may by by-law prescribe. The Board has the legal capacity to exercise the powers bestowed on it and to enforce those powers and the exercise thereof by actions, proceeding or prosecution.";
- 5. The Park Board looks after 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, and a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sport playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas, among other services and facilities;
- The City of Vancouver is the only municipality in Canada with an elected park board, with the exception of the Cultus Lake Park Board which is made up of five elected Commissioners (i.e., three elected from the Cultus Lake Park jurisdiction and two elected from the City of Chilliwack jurisdiction);
- 7. Vancouver's Auditor General (AGO) recently released a performance audit report of the revenue management practices of the Park Board. The audit determined that while some processes were used to inform fee-setting, the Park Board did not operate an effective framework for achieving revenue-related objectives for its revenue-generating assets and services;

- 8. The AGO's audit report further noted that the Park Board's overall funding structure, as set out in the *VC*, requires it to obtain City Council approval for all expenditures, including the expenditure of funds generated from revenue-generating activities. The audit found that while the Park Board has strategies to guide the delivery of parks and recreation services, it had not proactively engaged with City Council to align its priorities with available funding;
- 9. Vancouver's parks, recreation, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved sustainably and in good working order for future generations;
- 10. The Park Board, for most practical intents, functions like any other department of the City, albeit as a separate entity with significant independent authority through its elected board:
- 11. Over the years, the Province has amended the VC numerous times to accommodate the changing needs and priorities of the city. Some amendments have been significant while others have been consequential and/or incidental to other legislation introduced by the Province: and
- 12. In recent years it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in governance structure is not only needed, it is the only viable path forward to an efficient and effective parks and recreation service for the people of Vancouver.

THEREFORE BE IT RESOLVED

A. THAT Council formally request that the Province of British Columbia amend or repeal section 485 of the *Vancouver Charter* ("*VC*") to remove the requirement for an elected board of commissioners, variously referenced in legislation and elsewhere as the "Board of Parks and Recreation" and/or "Park Board", including any and all consequential and/or incidental amendments required to the *VC* and/or other related legislation, including that any and all legal obligations of the Park Board be assumed by the City, and


FURTHER THAT the legal capacity to exercise the powers currently bestowed on the Park Board under the *VC*, and the authority to enforce those powers, shall be devolved to and bestowed upon Council, and the delivery of parks and recreation services shall be administered by the City in accordance with Council direction, and

FURTHER THAT, in accordance with the above, Council formally request that the Province of British Columbia amend the process for revoking and/or cancelling the designation of areas designated as permanent public parks of the City under the VC, notably under section 488 of the VC ("Parks in care of Board"), to a unanimous vote of all Council members, along with provisions for a public referendum.

B. THAT a Parks and Recreation Transition Working Group ("PRTWG") (Type D advisory body) be convened to facilitate the smooth transition of responsibility for park and recreation services, from the current oversight by an elected Park Board to the oversight of Council, and

FURTHER THAT the PRTWG shall have a time-limited mandate of six (6) months to coordinate the ongoing engagement and relationships with park and recreation stakeholders, supported by City staff, and be comprised of the Mayor, the Mayor's Chief of Staff, two City Councillors appointed by the Mayor, a current Park Board Commissioner appointed by the Mayor, and up to six (6) members of the public appointed by the Mayor, with Terms of Reference for the working group to be determined by the Mayor in consultation with, and under the advisement of, the City Manager and the General Manager of Parks and Recreation.

Q&A Document

Q1: How does the council justify this change as a 'new era' when many citizens believe the current system serves well?

We're not just entering a new era; we're leading it. While our parks are indeed well-loved, we have the opportunity to manage them even better. This is about enhancing what we cherish. This change will make our parks and recreation centers shine brighter as the treasures they truly are.

Q2: Critics are concerned this change could lead to commercialization of park spaces. What are the safeguards against this?

The separate structure, while unique, has sometimes resulted in duplicated efforts and delayed responses to the community's needs. By streamlining processes, we can address these inefficiencies, leading to more cohesive management and better service delivery.

Q4: There are concerns about transparency and accountability with this restructuring. How do you address these?

Transparency and accountability are core values of this process. The creation of the Parks Advisory Committee is a testament to our dedication to these principles. It will ensure a diverse range of voices is heard and represented during this transition.

Q5: Will people be losing their jobs with this change?

As with all organizational changes the City makes, we will endeavour to minimise impacts on our staff. While the detailed planning and analysis is yet to be done, we will strive to absorb staff changes through attrition wherever possible.

Q6: How will the council involve the public in this significant change to ensure it aligns with the citizens' vision for their parks?

Public involvement is central to this process. The establishment of the Parks Advisory Committee will ensure that citizens' voices are not just heard but are instrumental in shaping the future of our parks. This change is being made with community collaboration at its heart.

Q7: How will this transition affect current projects and plans already in place by the park board?

All ongoing projects and plans will be thoughtfully reviewed. We are dedicated to honouring our commitments and ensuring that these projects align with the improved management structure to better serve our community.

Q8: What financial benefits can the public expect to see from this change, and how will these be measured?

By integrating the park board into our city's governance, s.13(1), s.17(1)

This is a direct financial benefit to taxpayers and will be tracked and reported to ensure accountability and the effective use of these funds.

Q9: How can the council guarantee that this change will enhance, rather than reduce, the quality of park services?

The council has already demonstrated its commitment to enhancing park services with initiatives like the revival of the Stanley Park train. By aligning with other major Canadian cities' efficient practices, we will continue to build upon these improvements.

Q10: What measures are in place to ensure that the restructuring process itself will be managed effectively and without excess cost?

We are proceeding with a carefully planned, step-by-step approach, adhering to all legal and legislative requirements. This strategic management will ensure that the restructuring is as cost-effective as possible while achieving the desired outcomes for our parks.

Q11: Is this restructuring a response to allegations of mismanagement within the park board? How do you respond to those who see this as a punitive measure?

The move towards a new era of parks management in Vancouver is about proactively seeking ways to enhance our park system for all Vancouverites. We recognize the hard work and dedication of the park board, however this is a strategic decision to align with efficient practices seen in other major cities across Canada, ensuring our parks are managed in the most effective and sustainable way. The decision is made with the future in mind, considering how we can best serve our community's needs and preserve our green spaces for generations to come.

Q12: Where did the cost savings estimate come from?

This is a preliminary order-of-magnitude estimate, and with formal Council direction in place, staff will be working over the coming months to undertake a detailed analysis of cost and efficiency savings.

Vancouver Mayor Ken Sim Seeks Amendment to the Vancouver Charter to Remove the Elected Park Board

Vancouver, **B.C.**, **December 6**, **2023** – Mayor Ken Sim announced this morning that he is bringing forward a motion asking the Province to remove the requirement for an elected Park Board under the Vancouver Charter.

To accomplish this change, Mayor Sim will be introducing a motion at next Wednesday's Council meeting requesting that the Province amend and repeal the relevant sections of the Vancouver Charter, and for the legal powers currently held by the Park Board to be transferred to City Council.

Mayor Sim's motion states that in recent years, "it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in the governance structure is not only needed, it is the only viable path forward to efficient and effective parks and recreation services for the people of Vancouver."

"Make no mistake about it. Vancouver's parks, recreation services, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved indefinitely for future generations," said Mayor Sim. "The commitment I'm making to the people of our city today includes establishing stronger protections around any changes to our parks. This will be a new era for parks and recreation in our city."

Vancouver is the only municipality in the entire country with an elected park board. In every other city in Canada, parks and recreation services are managed directly by a parks and recreation department under the direction of their respective city councils.

Recently, Vancouver's independent Auditor General released a performance audit of the Park Board's revenue management practices. The audit determined that the Park Board did not operate an effective framework for achieving revenue-related objectives. Moreover, it found that the Park Board was not proactively engaging with City Council to align its priorities with available funding, despite the fact that all Park Board expenditures require the approval of City Council.

Vancouver's park and recreation assets include 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sports playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas among other services and facilities.

Mayor Sim's motion also calls for the creation of a Parks and Recreation Transition Working Group to facilitate a smooth transition of responsibility for park and recreation services from the current oversight by the Park Board to the oversight of City Council. The working group would be in place for six months to coordinate ongoing engagement and relationships with park and recreation stakeholders. It would be supported by City staff through the City Manager's Office.

Amendment to the Vancouver Charter

Submitted by: Mayor Ken Sim

WHEREAS

- 1. The City of Vancouver, including the Vancouver Board of Parks and Recreation ("Park Board"), is primarily created and governed by the *Vancouver Charter (VC")*, a provincial statute enacted in 1953 that incorporates the City of Vancouver;
- 2. The *VC* sets out the statutory powers and authorities which govern the City of Vancouver, and provides a range of powers and responsibilities different from those of other communities governed primarily by the *Community Charter* ("*CC*") and the *Local Government Act* ("*LGA*");
- 3. The *VC* governs how the City operates, what by-laws Council can enact, and how budgets are determined. Under the *VC*, Council has the authority to enact by-laws to regulate such things as noise and land use, to buy and sell property, to collect certain taxes, to approve expenditures, and to take on debt, give grants, and hire and discharge employees;
- 4. The Park Board is established by section 485 of the *VC* (Part XXIII Parks), which reads;
 - "A board of commissioners, to be known as the "Board of Parks and Recreation" or "Park Board," shall be elected as hereinafter provided, and shall consist of seven members or such other number as the Council may by by-law prescribe. The Board has the legal capacity to exercise the powers bestowed on it and to enforce those powers and the exercise thereof by actions, proceeding or prosecution.";
- 5. The Park Board looks after 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, and a large public recreation

- system of 24 community centres, swimming pools, rinks and arenas, sport playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas, among other services and facilities;
- 6. The City of Vancouver is the only municipality in Canada with an elected park board, with the exception of the Cultus Lake Park Board which is made up of five elected Commissioners (i.e., three elected from the Cultus Lake Park jurisdiction and two elected from the City of Chilliwack jurisdiction);
- 7. Vancouver's Auditor General (AGO) recently released a performance audit report of the revenue management practices of the Park Board. The audit determined that while some processes were used to inform fee-setting, the Park Board did not operate an effective framework for achieving revenue-related objectives for its revenue-generating assets and services:
- 8. The AGO's audit report further noted that the Park Board's overall funding structure, as set out in the VC, requires it to obtain City Council approval for all expenditures, including the expenditure of funds generated from revenue-generating activities. The audit found that while the Park Board has strategies to guide the delivery of parks and recreation services, it had not proactively engaged with City Council to align its priorities with available funding;
- 9. Vancouver's parks, recreation, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved sustainably and in good working order for future generations;
- 10. The Park Board, for most practical intents, functions like any other department of the City, albeit as a separate entity with significant independent authority through its elected board;
- 11. Over the years, the Province has amended the *VC* numerous times to accommodate the changing needs and priorities of the city. Some amendments have been significant while others have been consequential and/or incidental to other legislation introduced by the Province; and
- 12. In recent years it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in governance structure is not only needed, it is the only viable path forward to an efficient and effective parks and recreation service for the people of Vancouver.

THEREFORE BE IT RESOLVED

A. THAT Council formally request that the Province of British Columbia amend or repeal section 485 of the *Vancouver Charter* ("*VC*") to remove the requirement for an elected board of commissioners, variously referenced in legislation and elsewhere as the "Board of Parks and Recreation" and/or "Park Board", including any and all consequential and/or incidental amendments required to the *VC* and/or other related legislation, including that any and all legal obligations of the Park Board be assumed by the City, and

FURTHER THAT the legal capacity to exercise the powers currently bestowed on the Park Board under the *VC*, and the authority to enforce those powers, shall be devolved

to and bestowed upon Council, and the delivery of parks and recreation services shall be administered by the City in accordance with Council direction, and

FURTHER THAT, in accordance with the above, Council formally request that the Province of British Columbia amend the process for revoking and/or cancelling the designation of areas designated as permanent public parks of the City under the *VC*, notably under section 488 of the *VC* ("Parks in care of Board"), to a unanimous vote of all Council members, along with provisions for a public referendum.

B. THAT a Parks and Recreation Transition Working Group ("PRTWG") (Type D advisory body) be convened to facilitate the smooth transition of responsibility for park and recreation services, from the current oversight by an elected Park Board to the oversight of Council, and

FURTHER THAT the PRTWG shall have a time-limited mandate of six (6) months to coordinate the ongoing engagement and relationships with park and recreation stakeholders, supported by City staff, and be comprised of the Mayor, the Mayor's Chief of Staff, two City Councillors appointed by the Mayor, a current Park Board Commissioner appointed by the Mayor, and up to six (6) members of the public appointed by the Mayor, with Terms of Reference for the working group to be determined by the Mayor in consultation with, and under the advisement of, the City Manager and the General Manager of Parks and Recreation.

Vancouver Mayor Ken Sim Seeks Amendment to the Vancouver Charter to Remove the Elected Park Board

Vancouver, **B.C.**, **December 6**, **2023** – Mayor Ken Sim announced this morning that he is bringing forward a motion asking the Province to remove the requirement for an elected Park Board under the Vancouver Charter.

To accomplish this change, Mayor Sim will be introducing a motion at next Wednesday's Council meeting requesting that the Province amend and repeal the relevant sections of the Vancouver Charter, and for the legal powers currently held by the Park Board to be transferred to City Council.

Mayor Sim's motion states that in recent years, "it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in the governance structure is not only needed, it is the only viable path forward to efficient and effective parks and recreation services for the people of Vancouver."

"Make no mistake about it. Vancouver's parks, recreation services, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved indefinitely for future generations," said Mayor Sim. "The commitment I'm making to the people of our city today includes establishing stronger protections around any changes to our parks. This will be a new era for parks and recreation in our city."

Vancouver is the only municipality in the entire country with an elected park board. In every other city in Canada, parks and recreation services are managed directly by a parks and recreation department under the direction of their respective city councils.

Recently, Vancouver's independent Auditor General released a performance audit of the Park Board's revenue management practices. The audit determined that the Park Board did not operate an effective framework for achieving revenue-related objectives. Moreover, it found that the Park Board was not proactively engaging with City Council to align its priorities with available funding, despite the fact that all Park Board expenditures require the approval of City Council.

Vancouver's park and recreation assets include 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sports playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas among other services and facilities.

Mayor Sim's motion also calls for the creation of a Parks and Recreation Transition Working Group to facilitate a smooth transition of responsibility for park and recreation services from the current oversight by the Park Board to the oversight of City Council. The working group would be in place for six months to coordinate ongoing engagement and relationships with park and recreation stakeholders. It would be supported by City staff through the City Manager's Office.

Motion:

Amendment to the Vancouver Charter

Submitted by: Mayor Ken Sim

WHEREAS

- 1. The City of Vancouver, including the Vancouver Board of Parks and Recreation ("Park Board"), is primarily created and governed by the *Vancouver Charter (VC")*, a provincial statute enacted in 1953 that incorporates the City of Vancouver;
- 2. The *VC* sets out the statutory powers and authorities which govern the City of Vancouver, and provides a range of powers and responsibilities different from those of other communities governed primarily by the *Community Charter* ("*CC*") and the *Local Government Act* ("*LGA*");
- 3. The *VC* governs how the City operates, what by-laws Council can enact, and how budgets are determined. Under the *VC*, Council has the authority to enact by-laws to regulate such things as noise and land use, to buy and sell property, to collect certain taxes, to approve expenditures, and to take on debt, give grants, and hire and discharge employees;
- The Park Board is established by section 485 of the VC (Part XXIII Parks), which reads;
 - "A board of commissioners, to be known as the "Board of Parks and Recreation" or "Park Board," shall be elected as hereinafter provided, and shall consist of seven members or such other number as the Council may by by-law prescribe. The Board has the legal capacity to exercise the powers bestowed on it and to enforce those powers and the exercise thereof by actions, proceeding or prosecution.";
- 5. The Park Board looks after 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, and a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sport playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas, among other services and facilities;
- 6. The City of Vancouver is the only municipality in Canada with an elected park board, with the exception of the Cultus Lake Park Board which is made up of five elected Commissioners (i.e., three elected from the Cultus Lake Park jurisdiction and two elected from the City of Chilliwack jurisdiction);
- 7. Vancouver's Auditor General (AGO) recently released a performance audit report of the revenue management practices of the Park Board. The audit determined that while some processes were used to inform fee-setting, the Park Board did not operate an effective framework for achieving revenue-related objectives for its revenue-generating assets and services;

- 8. The AGO's audit report further noted that the Park Board's overall funding structure, as set out in the *VC*, requires it to obtain City Council approval for all expenditures, including the expenditure of funds generated from revenue-generating activities. The audit found that while the Park Board has strategies to guide the delivery of parks and recreation services, it had not proactively engaged with City Council to align its priorities with available funding;
- 9. Vancouver's parks, recreation, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved sustainably and in good working order for future generations;
- 10. The Park Board, for most practical intents, functions like any other department of the City, albeit as a separate entity with significant independent authority through its elected board;
- 11. Over the years, the Province has amended the *VC* numerous times to accommodate the changing needs and priorities of the city. Some amendments have been significant while others have been consequential and/or incidental to other legislation introduced by the Province: and
- 12. In recent years it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in governance structure is not only needed, it is the only viable path forward to an efficient and effective parks and recreation service for the people of Vancouver.

THEREFORE BE IT RESOLVED

A. THAT Council formally request that the Province of British Columbia amend or repeal section 485 of the *Vancouver Charter* ("*VC*") to remove the requirement for an elected board of commissioners, variously referenced in legislation and elsewhere as the "Board of Parks and Recreation" and/or "Park Board", including any and all consequential and/or incidental amendments required to the *VC* and/or other related legislation, including that any and all legal obligations of the Park Board be assumed by the City, and

FURTHER THAT the legal capacity to exercise the powers currently bestowed on the Park Board under the *VC*, and the authority to enforce those powers, shall be devolved to and bestowed upon Council, and the delivery of parks and recreation services shall be administered by the City in accordance with Council direction, and

FURTHER THAT, in accordance with the above, Council formally request that the Province of British Columbia amend the process for revoking and/or cancelling the designation of areas designated as permanent public parks of the City under the VC, notably under section 488 of the VC ("Parks in care of Board"), to a unanimous vote of all Council members, along with provisions for a public referendum.

B. THAT a Parks and Recreation Transition Working Group ("PRTWG") (Type D advisory body) be convened to facilitate the smooth transition of responsibility for park and recreation services, from the current oversight by an elected Park Board to the oversight of Council, and

FURTHER THAT the PRTWG shall have a time-limited mandate of six (6) months to coordinate the ongoing engagement and relationships with park and recreation stakeholders, supported by City staff, and be comprised of the Mayor, the Mayor's Chief of Staff, two City Councillors appointed by the Mayor, a current Park Board Commissioner appointed by the Mayor, and up to six (6) members of the public appointed by the Mayor, with Terms of Reference for the working group to be determined by the Mayor in consultation with, and under the advisement of, the City Manager and the General Manager of Parks and Recreation.





Vancouver Mayor Ken Sim Seeks Amendment to the Vancouver Charter to Remove the Elected Park Board

Vancouver, **B.C.**, **December 6**, **2023** – Mayor Ken Sim announced this morning that he is bringing forward a motion asking the Province to remove the requirement for an elected Park Board under the Vancouver Charter.

To accomplish this change, Mayor Sim will be introducing a motion at next Wednesday's Council meeting requesting that the Province amend and repeal the relevant sections of the Vancouver Charter, and for the legal powers currently held by the Park Board to be transferred to City Council.

Mayor Sim's motion states that in recent years, "it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in the governance structure is not only needed, it is the only viable path forward to efficient and effective parks and recreation services for the people of Vancouver."

"Make no mistake about it. Vancouver's parks, recreation services, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved indefinitely for future generations," said Mayor Sim. "The commitment I'm making to the people of our city today includes establishing stronger protections around any changes to our parks. This will be a new era for parks and recreation in our city."

parks and recreation services are managed directly by a parks and recreation department under the direction of their respective city councils.

Recently, Vancouver's independent Auditor General released a performance audit of the Park Board's revenue management practices. The audit determined that the Park Board did not operate an effective framework for achieving revenue-related objectives. Moreover, it found that the Park Board was not proactively engaging with City Council to align its priorities with available funding, despite the fact that all Park Board expenditures require the approval of City Council.

Vancouver's park and recreation assets include 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sports playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas among other services and facilities.

Mayor Sim's motion also calls for the creation of a Parks and Recreation Transition Working Group to facilitate a smooth transition of responsibility for park and recreation services from the current oversight by the Park Board to the oversight of City Council. The working group would be in place for six months to coordinate ongoing engagement and relationships with park and recreation stakeholders. It would be supported by City staff through the City Manager's Office.

Amendment to the Vancouver Charter

Submitted by: Mayor Ken Sim WHEREAS

- 1. The City of Vancouver, including the Vancouver Board of Parks and Recreation ("Park Board"), is primarily created and governed by the *Vancouver Charter (VC")*, a provincial statute enacted in 1953 that incorporates the City of Vancouver;
- 2. The VC sets out the statutory powers and authorities which govern the City of Vancouver, and provides a range of powers and responsibilities different from those of other communities governed primarily by the Community Charter ("CC") and the Local Government Act ("LGA");
- 3. The *VC* governs how the City operates, what by-laws Council can enact, and how budgets are determined. Under the *VC*, Council has the authority to enact by-laws to regulate such things as noise and land use, to buy and sell property, to collect certain taxes, to approve expenditures, and to take on debt, give grants, and hire and discharge employees;
- 4. The Park Board is established by section 485 of the VC (Part XXIII Parks), which reads;
 - "A board of commissioners, to be known as the "Board of Parks and Recreation" or "Park Board," shall be elected as hereinafter provided, and shall consist of seven members or such other number as the Council may by by-law prescribe. The Board has the legal capacity to exercise the powers bestowed on it and to enforce those powers and the exercise thereof by actions, proceeding or prosecution.";
- 5. The Park Board looks after 250 public parks and beaches, including Stanley Park, VanDusen Botanical Garden, Bloedel Conservatory, and a large public recreation system of 24 community centres, swimming pools, rinks and arenas, sport playing fields, playgrounds, fitness centres, three championship golf courses, street trees, and marinas, among other services and facilities;
- 6. The City of Vancouver is the only municipality in Canada with an elected park board, with the exception of the Cultus Lake Park Board which is made up of five elected Commissioners (i.e., three elected from the Cultus Lake Park jurisdiction and two elected from the City of Chilliwack jurisdiction);
- 7. Vancouver's Auditor General (AGO) recently released a performance audit report of the revenue management practices of the Park Board. The audit determined that while some processes were used to inform fee-setting, the Park Board did not operate an effective traffer of Cachie with the revenue management practices of the Park Board and the audit determined that while some processes were used to

- 7. objectives for its revenue-generating assets and services;
- 8. The AGO's audit report further noted that the Park Board's overall funding structure, as set out in the *VC*, requires it to obtain City Council approval for all expenditures, including the expenditure of funds generated from revenue-generating activities. The audit found that while the Park Board has strategies to guide the delivery of parks and recreation services, it had not proactively engaged with City Council to align its priorities with available funding;
- 9. Vancouver's parks, recreation, and cultural assets are prized by Vancouverites and visitors alike and must be protected, maintained, and preserved sustainably and in good working order for future generations;
- 10. The Park Board, for most practical intents, functions like any other department of the City, albeit as a separate entity with significant independent authority through its elected board;
- 11. Over the years, the Province has amended the *VC* numerous times to accommodate the changing needs and priorities of the city. Some amendments have been significant while others have been consequential and/or incidental to other legislation introduced by the Province; and
- 12. In recent years it has become abundantly clear, given the poor state of Vancouver's parks, recreation services, and infrastructure, that a fundamental change in governance structure is not only needed, it is the only viable path forward to an efficient and effective parks and recreation service for the people of Vancouver.

THEREFORE BE IT RESOLVED

A. THAT Council formally request that the Province of British Columbia amend or repeal section 485 of the *Vancouver Charter* ("*VC*") to remove the requirement for an elected board of commissioners, variously referenced in legislation and elsewhere as the "Board of Parks and Recreation" and/or "Park Board", including any and all consequential and/or incidental amendments required to the *VC* and/or other related legislation, including that any and all legal obligations of the Park Board be assumed by the City, and

FURTHER THAT the legal capacity to exercise the powers currently bestowed on the Park Board under the *VC*, and the authority to enforce those powers, shall be devolved to and bestowed upon Council, and the delivery of parks and recreation services shall be administered by the City in accordance with Council direction, and

FURTHER THAT, in accordance with the above, Council formally request that the Province of British Columbia amend the process for revoking and/or cancelling the designation of areas designated as permanent public parks of the City under the VC, notably under section 488 of the VC ("Parks in care of Board"), to a unanimous vote of all Council members, along with provisions for a public referendum.

B. THAT a Parks and Recreation Transition Working Group ("PRTWG") (Type D advisory body) be convened to facilitate the smooth transition of responsibility for park and recreation services, from the current oversight by an elected Park Board to the oversight of Council, and

FURTHER THAT the PRTWG shall have a time-limited mandate of six (6) months to coordinate the ongoing engagement and relationships with park and recreation stakeholders, supported by City staff, and be comprised of the Mayor, the Mayor's Chief of Staff, two City Councillors appointed by the Mayor, a current Park Board Commissioner appointed by the Mayor, and up to six (6) members of the public appointed by the Mayor, with Terms of Reference for the working group to be determined by the Mayor in consultation with, and under the advisement of, the City Manager and the General Manager of Parks and Recreation.
