SUBJECT: Q4 2024 public engagement schedule

Dear Mayor and Council,

The purpose of this memo is to provide a high-level overview of upcoming City-led public engagement projects in Q4 2024, excluding stakeholder engagement activities. For the upcoming quarter, public engagement efforts are planned for October and November. This leaves space for a seasonal break in December, which is a busy time for many people.

The following table is meant to offer an approximation of engagement timelines for Q4; exact dates for each project are determined closer to the launch date. Generally, projects are open for input for three to four weeks from their launch date.

Week of	Project	Description
Oct. 1	South Asian Canadian Discrimination (ACCS)	The South Asian Canadian community will share their experiences of discrimination and racism in Vancouver and suggest actions for the City to take within its jurisdiction.
Oct. 7	Portside Greenway (ENG)	Engagement will gather input on two possible design options proposed for the Wall Street section of the Portside Greenway.
Oct. 14	Personal Emergency Preparedness (CMO)	Coinciding with Shakeout BC, this survey will assess the public's level of emergency readiness



		and identify barriers related to emergency preparedness, to help inform City efforts.
Oct. 20	Urban Indigenous Engagement (CMO)	In-person event for Urban Indigenous community members seeking input on draft Urban Indigenous engagement principles (as part of UNDRIP implementation), plus opportunity to provide input on City projects in a culturally appropriate format.
Nov. 4	Vancouver Plan: Villages (PDS)	As part of Vancouver Plan implementation, the City is gathering feedback on proposed "village" boundaries and community assets for 19 small-scale commercial areas throughout the city.
Nov. 18	Granville Street Planning Program (PDS)	Engagement will seek feedback on a draft plan for the area, covering land use, zoning, urban design, public spaces, transportation and signage.

For additional context, engagement is typically led by project teams within each department with support from Civic Engagement and Communications. A summary of engagement findings will be shared with Council by way of Council reports produced by each department.
