This memo provides an update on the Vancouver sign project as identified in the <u>Council motion</u> brought forth in the Standing Committee on City Finance and Services meeting on March 13, 2024.

## Background

As identified in the Council motion, the success of the temporary Vancouver sign in Coal Harbor has shown the number of benefits that a permanent sign, situated in a prominent location, would have for the city.

Over the last few months, staff have been working with partners including, Destination Vancouver, Vancouver Hotel Destination Association, Vancouver Convention Centre and the Downtown Vancouver Business Improvement Association to scope partnership opportunities, locations, funding sources and implementation timelines. Community partners are highly supportive and have shown a willingness to contribute resources to the project, dependent on the ultimate site selected.

Staff have also initiated a referral process with Musqueam, Squamish and Tsleil-Waututh Nations to gauge their interest. Staff have begun discussions with interested Nations' staff on partnership opportunities, with the over-arching project goal to increase local Nation's visibility.



Site selection criteria being considered for a permanent Vancouver sign include:

- A sense of place with a connection to iconic Vancouver backdrops including, the ocean, mountains and other city landmarks.
- Ease of access and visibility including locations close to transit, bike and pedestrian infrastructure and tourism connectivity.
- Partner support including, site ownership, funding, ongoing operations and maintenance, and tourism and branding opportunities.
- Space to safely accommodate large groups of people, while easily fitting a large sign into a photo frame.
- Access to infrastructure including utilities, seating, and washrooms, among others.

As the project scope is further refined, budget and funding sources are being identified. Based on research on other signs throughout Canada and the world, capital costs for permanent signs range from, approximately \$200,000 for a smaller, low complexity sign, to \$1,000,000+ for a complex sign with custom programmable elements. Ongoing operations and maintenance considerations and costs are also being considered.

## Next Steps

The City project team will continue to refine the partnership opportunities and roles, site selection and project costs. The local Nations referral is ongoing and scoping for opportunities will continue concurrently and be integrated into the partner scoping process.

A full update to Council detailing partnership opportunities, project budget and funding contributions, local Nations involvement, approach to ongoing operations and maintenance, and project timelines is anticipated in early 2025.
