The Streethome Stool (below) symbolizes the interconnected domains that must be strengthened to meet unmet needs of vulnerable individuals and foster a thriving community. These domains build on essential requirements like food, clothing, and shelter. Just as an unstable stool with missing or compromised legs is precarious, individuals with lived experiences or at-risk of homelessness need a robust set of tailored services to ensure they are fully supported.

To enhance this support, Streethome's Strategic Framework will guide our work to 'sturdy the Stool'. This will essentially involve a dual approach - connecting individuals with evidence-based and effective support services and promoting accessible housing models that incorporate a comprehensive range of required services.

At Streethome, we truly believe that transforming lives begins with knowledge and understanding. Our commitment to well-researched business cases has become the cornerstone of our mission to address issues related to homelessness effectively with our **innovative and evidence-based** initiatives. Each study we produce is more than just a document; it's a powerful tool that illuminates the complexities of the pressing issues and guides our work toward sustainable solutions.

Over the years, we have meticulously analyzed various initiatives that are aimed at combating the problems that lead to and stem out of homelessness. Taken together, our business cases provide a more complete picture of findings that, considered in isolation, can be truly misleading.

For example, several of our business cases document that a substantial portion of the population of individuals living with homelessness in Vancouver self-report problematic substance use. There is also strong evidence that individuals who transition into supportive

housing and living alone have a remarkable success rate in maintaining their homes after one year; yet, problematic substance use continues to be a challenge for many of these same individuals and can contribute to increased risk of homelessness.

We have learned to take a step back and remain open to finding additional pieces to the puzzle. Our most recent business case documents

the findings that everyone's connections with their community, whether family, friends, and other social supports, can play a key role in successfully addressing the array of needs for many individuals.

Such apparently disparate findings have helped us shift our focus to the **'whole person'**; a broad approach that seeks to understand a 'generic recovery journey' (i.e., from mental illness, homelessness, unemployment, problematic substance use, loneliness, poverty, etc.), and a need to address the physical, emotional, intellectual, spiritual, social, economic, and vocational needs of the individual.

A 'whole person' approach emphasizes the importance of **self-help and self-motivation** to improve the quality of life, leading to more meaningful roles within the broader community. We have also found that homelessness services need to be compelling - attract the engagement of those seeking support as well as provide a sense of belonging and camaraderie. It is only by coming together that

lives are changed and promising futures are restored.

We keep collaboration at the heart of everything we do. Hence, we actively engage with local governments, service providers, and, most importantly, the individuals who are at-risk or have lived experience of homelessness. Their voices and their stories are crucial to our understanding and inform our approach. These integrated approaches empower individuals to rebuild their lives, addressing not merely the symptoms of homelessness but also the underlying causes behind it.

As we look to the future, our unwavering commitment to business cases and new information fuels our drive for innovation. We are dedicated to continuous learning and exploring innovations that can further enhance our understanding of the issues related to homelessness and **effective interventions**. Our goal is to share these insights widely, advocating for data-driven solutions that can inspire worthwhile action and change.

### ADDICTION RECOVERY COMMUNITY HOUSING (ARCH)

A promising model for a 2.5+ year recovery housing pathway that would ensure smooth transitions and continued housing and care between withdrawal management, treatment, recovery, and community reintegration.



### CHOSEN FAMILY PODS (CFP)

A more affordable option for individuals that enhances personal safety, reduces carbon footprint, addresses isolation and loneliness, and enables sharing lives and mutual support.



### DELANCEY STREET BC

An adaptation of an evidence-based 2-year vocational training model that promotes life skills, prosocial behaviour, and successful transition from prison to fully contributing citizens.



In a city where the skyline is ever-changing, one thing remains constant: our deep-rooted need for connection - connections that were traditionally formed around families and were shared within the walls of family homes. But what if the concept of home went beyond the four walls? What if home was where you found your chosen family?

Imagine a community where every door you knock on opens to a friend, a confidant, a supporter. A place where the bonds of kinship are forged not by blood, but by choice. This is the vision behind **Chosen Family Pods (CFP)** - homes that are designed to foster connection,

resilience, and shared support among people who might not share a last name, but share a common need: the need for belonging.

A 'Chosen Family Pod' essentially means consciously choosing to live with 'family members' who are either: friends, fellow students, co-workers, relatives, or even ex-partners to form a bond that is like blood; and share each others' lives. It comes with advantages that include camaraderie, a sense of belonging, safety, and social support. This starkly contrasts with a landlord, property manager, or another third party renting individual bedrooms to different people who know nothing about each other and are strangers. It is probably more appropriate to describe CFP as **interdependent housing**.

It is a model that provides its members with an opportunity to access more affordable rental housing and informal supports

when confronted with life's challenges. Some might also affectionately refer to CFP as **'supportive housing lite'**. These living spaces are carefully designed to encourage interaction among members, whether it is through communal kitchens where residents can share meals and stories, or through lush gardens that become the backdrop for social gatherings and moments of tranquility. Chosen Family Pods offer something that traditional Single Room Occupancy (SRO) apartments often lack: a built-in support system.

For some, the idea of shared spaces may evoke a sense of discomfort or apprehension. The notion of having less privacy is a valid

concern. But, shared spaces within CFP are **not about compromising privacy** they are about enhancing community life. In a world where isolation can be as harmful as any physical ailment, these family pods offer a communal remedy. Whether it is about the comfort of knowing someone is always nearby, or the joy of sharing everyday moments with people who genuinely care about you, living in a CFP means coming home to family.

While the success of this innovation is yet to be tested - it entails risk - within this risk lies the **true brilliance of CFP: adaptability**. These units can be designed with the flexibility to convert into traditional family homes should there be a need in the future. For now, these pods aren't just houses; they are catalysts for community, and truly the need of the hour.

Given that we live in times where urban loneliness is on the rise, building CFP poses an unprecedented chance to back a housing model that encourages a healthier, more resilient society – where individuals thrive. Moreover, this will help alleviate the housing crisis and also **reduce the strain on social services** by creating environments where people look out for one another.

Chosen Family Pods are more than just another solution to prevent unnecessary displacements; they're a proactive step towards a future-proof society. They represent communities where everyone has a place to belong, and where the ties that bind us are chosen and cherished.

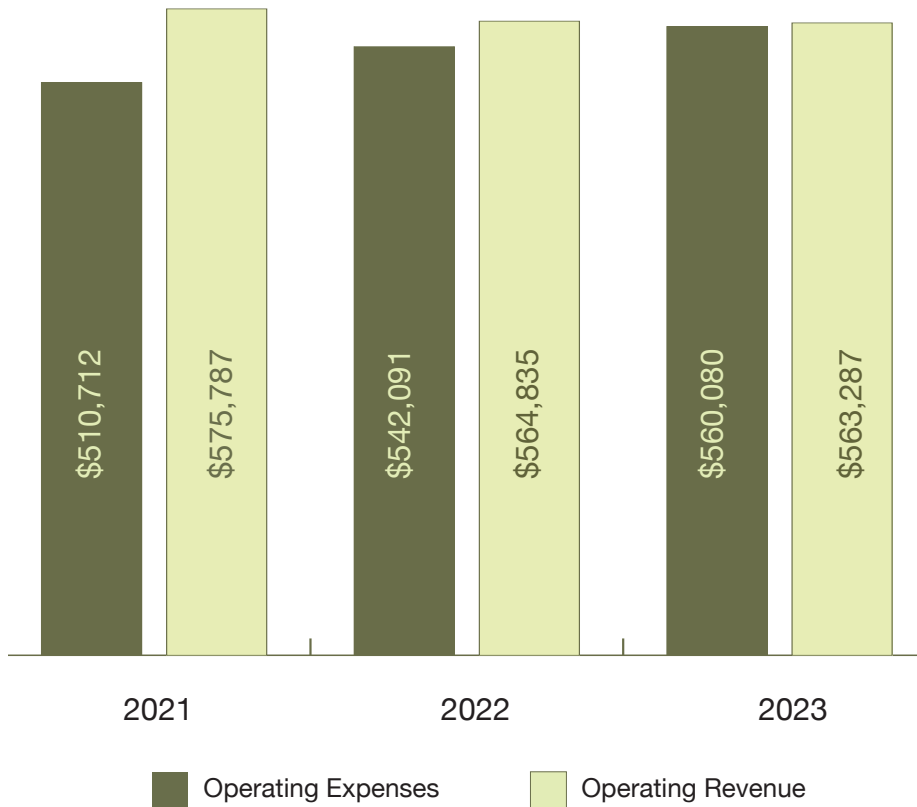
This isn't just about building houses in which to reside; it is about building a sense of belonging that every person truly deserves. So, let's make this vision a reality, one chosen family at a time.

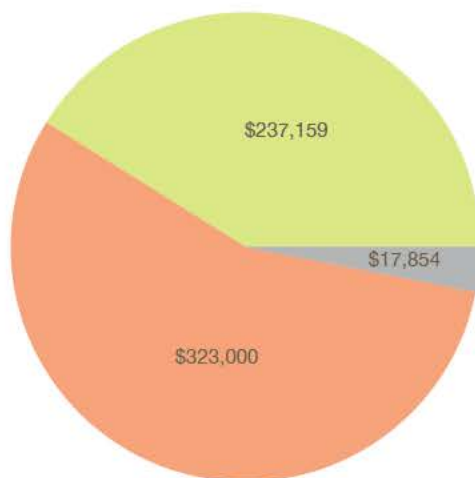
## OPERATING EXPENSES & REVENUES

We recognize that mental health and addiction support are critical in stabilizing lives. We remain committed to finding solutions that meet the needs of vulnerable citizens, while at the same time addressing the public's concern over street disorder and public safety.
