The purpose of this memo is to introduce Council to the new Finding Below Market Rental Housing Webpage.

## **OVERVIEW**

The City has launched a new webpage to help renters more easily find below-market rental housing. The site features an interactive map that highlights all under-construction and completed apartment buildings offering below-market units resulting from the City's Below Market Rental (BMR) Policy. Each listing includes detailed contact information, allowing renters to connect directly with building managers about vacancies or waiting lists.

Although the City doesn't manage waitlists, the new webpage makes it easier to find affordable housing by providing a simple, user-friendly way to explore below-market rental options across



Vancouver. This tool will help residents more easily navigate the rental market and find affordable homes.

For several years the City has actively encouraged the development of below-market rental housing to address a significant gap for individuals who do not qualify for non-market housing but struggle to afford market-rate rentals. These units, offered by private developers in exchange for increased building density, are permanently secured at below-market rates, ensuring long-term affordability even when tenants move out.

Key features of below-market rental housing include:

- Permanently secured below-market rents.
- At least 35% of units are two- and three-bedroom homes.
- Affordability is maintained through legal agreements with private developers.
- No ongoing subsidies are required.
- Costs are cross-subsidized by the market-rate rental portion of each building.

The City has approved a significant number of below-market rental projects, including:

- 6 projects that have reached completion
- 15 projects currently under construction
- 37 projects that have received rezoning approval but not yet commenced construction.
- Furthermore, there are 55 rental projects undergoing an active rezoning.

In total, approximately 660 BMR units are either complete or under construction, and approximately 2,050 BMR units are in the development pipeline.

The newly launched <u>webpage</u> is another tool in the city's broader effort to make housing more accessible and affordable for all residents.
