Q: Referring to slides 8 and 38 [in the council briefing deck]. Slide 8 reads that for large buildings we have adopted EL2 and EL3 of the Zero Carbon Step Code but after hearing feedback we shifted the compliance path to EL3. What are staff proposing to shift from? I think based on assumptions in Appendix D it is shifting from EL2 currently for large buildings to EL3. So in other words, Recommendation A is proposing more stringent regulations than we have in place today, correct? Or is there more nuance to this change around large buildings.

A: Your understanding is correct; Recommendation A is proposing more stringent emissions regulations for low-rise (3 storeys and under) and high-rise residential (above 6 storeys) than what is currently in place. The rationale for this proposed increase in the Zero Step Code level for those building forms is to provide an option for builders who prefer an electrification pathway and to mitigate the GHG impacts of Recommendation B. This addresses both the council direction to continue to manage and lower emissions from our building stock as well as the council direction to enable natural gas. The proposed change for high-rise residential is also consistent with a VBBL update that Council approved in principle back in May 2022 to come into effect in 2025.

The table below provides a summary of Vancouver's current requirements and the requirements proposed in the Recommendations in the November 26h Council report. Under the Zero Carbon Step Code, the City's current requirements are roughly equivalent to Level 3 for low-rise (3 storeys and under), mid-rise (4-6 storeys) and all commercial buildings, and Level 2 for high-rise residential (above 6 storeys). Recommendation A proposes moving to the Level 4 (highest level) of the Zero Carbon Step Code for low-rise residential and moving to Level 3 for high-rise residential. The other building types (mid-rise and commercial) are unchanged from the current requirements.

Staff explored moving to Level 4 (highest level) for mid- and high-rise residential and all commercial, as per Council direction in 2023, but based on industry feedback are recommending Level 3 instead (to allow some gas to be used for "peaking" events such as during extremely cold days).
