SUBJECT: Q1 2025 public engagement schedule

Dear Mayor and Council,

The purpose of this memo is to provide a high-level overview of upcoming City-led public engagement projects in Q1 2025, excluding stakeholder engagement activities.

The following table is meant to offer an approximation of engagement timelines for Q1; exact dates for each project are determined closer to the launch date. Generally, projects are open for input for three to four weeks from their launch date.

This quarter's schedule is planned around the Vancouver School Board's spring break (March 17-28), recognizing that this is a busy time for many families. A number of engagements are planned for early April after school is back in session and following the April 5th municipal byelection.

Week of	Project	Description
Jan. 27	Rupert-Renfrew Area Plan (PDS)	Staff will be sharing proposed final draft directions, focusing on land use near station areas, opportunities for additional ground-oriented retail, and public realm.



Feb. 3	Granville Street planning program (PDS)	This second phase of engagement will seek feedback on proposed draft policies for the planning area, including proposed amendments to land use, public space and transportation plans.
Feb. 10	Liquor establishment operating hours (DBL)	Engagement will provide an opportunity for the public to share their views on operating hours for liquor establishments (e.g. bars, clubs) in Downtown and non-Downtown areas.
Feb. 17	Killarney Northeast traffic calming (ENG)	As part of the City's Neighbourhood Traffic Management Program, engagement will gather feedback on traffic calming, local access, and street use priorities for E 45 th Ave.
Feb. 24	City-initiated rezoning in areas of Broadway and Cambie (PDS)	The public will have the opportunity to learn more about proposed City-initiated rezoning for the Broadway Plan and Cambie Corridor Plan areas, and to provide feedback through the City's Shape Your City rezoning portal.

In addition to the projects listed below, there is a planned Park Board engagement for W.C. Shelley Park and Burrard Slopes Park.

For additional context, engagement is typically led by project teams within each department with support from Civic Engagement and Communications. A summary of engagement findings will be shared with Council by way of Council reports produced by each department.
