Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of January 15, 2025 under the *Freedom of Information and Protection of Privacy Act* for:

- 1. Record of the tree maintenance program on Trinity Street near 2452 Trinity Street from June 1, 2024 to November 7, 2024; and
- 2. Record of the removal of trees, and trees planted after November 7, 2024 to January 15, 2025, on Trinity Street near 2452 Trinity Street.

All responsive records are attached. Some information in the records has been severed (blacked out) under s.22(1) of the Act. You can read or download this section here: http://www.bclaws.ca/EPLibraries/bclaws_new/document/ID/freeside/96165_00.

Park Board staff have advised our office that there are no records in relation to the planting of trees after November 7, 2024. Tree plantings are triggered automatically once the location is ready for planting. The referenced location currently has a stump which needs to be removed prior to planting. Stump removal and planting across the city take place in chronological order.
