Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of January 27, 2025 under the *Freedom of Information and Protection of Privacy Act (the Act)* for:

Records containing a current list of community gardens and dog parks on private and/or leased land in City of Vancouver. Specifically, parcels currently classified by the BC Assessment Authority as Class 8 (recreational or park) for a community garden or dog park, including street address, PID number, owner and/or operator.

All responsive records are attached.

Please note the following:

- Page 1 is a list of dog parks on leased lands. The City and Vancouver Board of Parks and Recreation (Park Board) does not track dog parks on private land.
- Page 2 is a list of Community gardens on City owned property and street right of way.
- Page 3 is a list of Community gardens on Park Board property.

The staff from the Social Policy and Projects Division confirms the City no longer (consistently) updates community garden data on private property. This is because many of these projects are temporary in nature and are often installed and disassembled without the knowledge of the Park Board.

Under Part 5 of the Act, you may ask the Information & Privacy Commissioner to review any matter related to the City's response to your FOI request by writing to: Office of the Information & Privacy Commissioner, info@oipc.bc.ca or by phoning 250-387-5629.

If you request a review, please provide the Commissioner's office with: 1) the request number (2025-061); 2) a copy of this letter; 3) a copy of your original request; and 4) detailed reasons why you are seeking the review.
