Dear Mayor and Council,

Please see the attached memo from Lon LaClaire. A short summary of the memo is as follows:

- The City will replace and upgrade approximately 250 meters of 750mm diameter combined sewer main that runs through Memorial West Park with higher capacity separate pipes for stormwater and sanitary waste. The project scope is part of a large multi-year program to renew approximately 12km of aging combined sewer infrastructure in the Dunbar West catchment area.
- Construction will commence in July and is expected to substantially complete in Q1 2026.
- Trenchless construction methods will be used, minimizing the disruptions to the park users and facilities. Noise and vibration will be monitored during construction and are expected to be minimal.
- The City will use advance notification letters, project signage, website updates, email support, a designated community liaison, social media, and stakeholder meetings to keep the residents and businesses informed on construction.

SUBJECT: Memorial West Trenchless Sewer Upgrade Project – Sewer Infrastructure
Upgrade at Memorial West Park

Starting in July, the City will be using trenchless construction methods to renew critical sewer infrastructure along Highbury Street alignment through Memorial West Park from West 31st Avenue to the lane south of West 33rd Avenue. Staff have a comprehensive communication plan to ensure that residents, park users, businesses, and key stakeholders are well informed on the temporary impacts as the work progress until the completion of the project, which is expected in Q1 2026. A project scope map is shown on page 3.

Project Context and Background

Approximately 88% of the combined sewer infrastructure in the Dunbar West catchment area is over 90 years old and in poor condition. As a result, there is large multi-year program to renew approximately 12km of aging combined sewer infrastructure with separated sewer mains in the

Dunbar West area bounded by Camosun Street (West), Dunbar Street (East), W 15th Avenue (North), and W 37th Avenue (South).

One of the key projects in this program is the Memorial West Trenchless Sewer Upgrade (MWTSU) project, which will replace and upgrade approximately 250 metres of 750mm diameter combined sewer main that runs through Memorial West Park, along Highbury Street alignment. The combined sewer main will be replaced by higher capacity separate pipes for stormwater and sanitary waste.

Project Benefits

Separating the combined sewer main helps advance the City's Healthy Water Plan objectives to reduce pollution from our sewer and drainage system, as separating sanitary flows from the combined system reduces the potential for combined sewer overflows. Additionally, this work will increase the sewer and drainage system capacity to accommodate population growth and future climate conditions. The new infrastructure will have a life expectancy of 100 years.

Public Communications

Project Delivery team and the dedicated specialist from Civic Engagement and Communications are coordinating communication for the project. Project impacts will be communicated to the stakeholders according to the Project Communication Plan. Communication strategies for this project include:

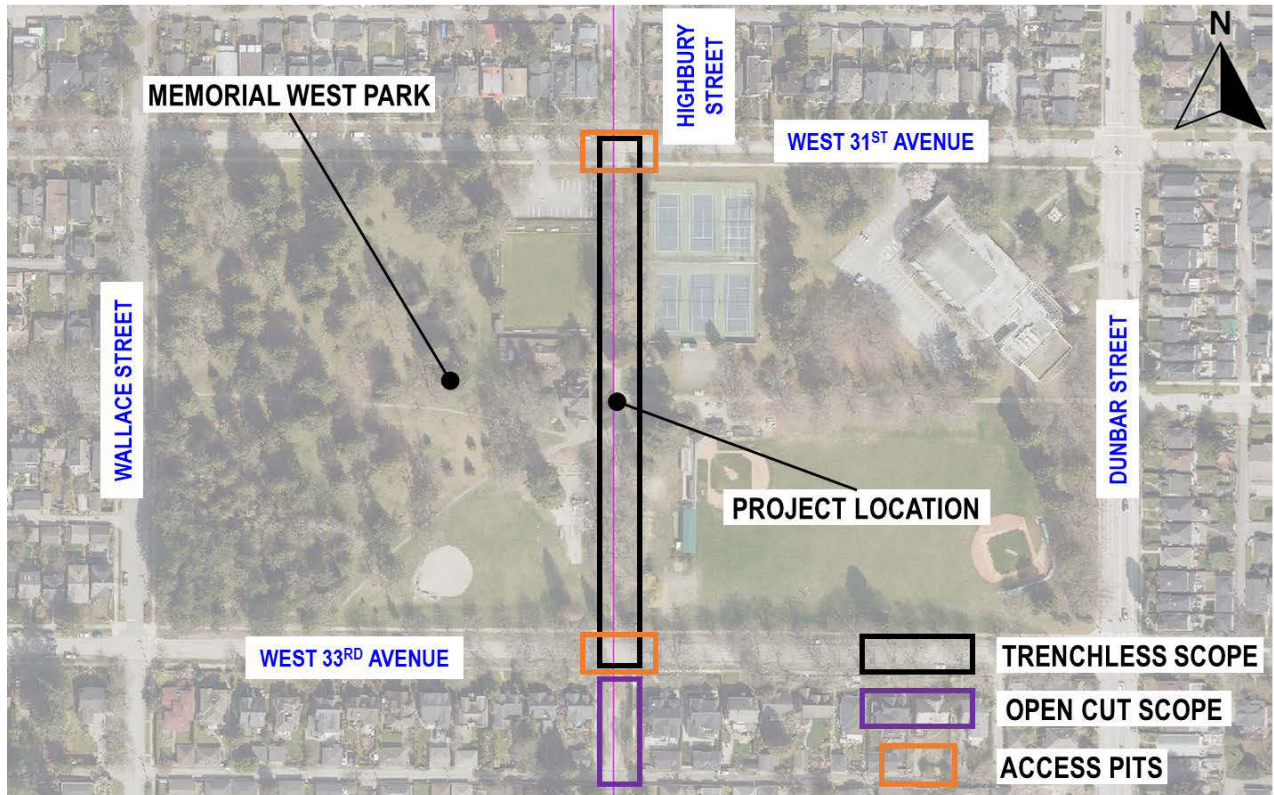
