## **PURPOSE**

The purpose of this memo is to provide updates on the "Sustainable School Food Funding" motion (May 7, 2025).

## **BACKGROUND**

On May 7, 2025, Council approved a <u>motion</u> for *Sustainable School Food Funding*, reaffirming support for a Universal Healthy School Food Program. The motion contained several directions, including that Council reaffirm its support for a Universal Healthy School Food Program and that the mayor advocate to Senior Government for equitable, sustainable funding to support VSB students facing food insecurity. It also directed staff



to allocate resources from contingency to restore City funding to the VSB school food programs at a level consistent with prior support (\$325,000 annually) for the 2025/26 school year; and, to work with VSB staff to clarify how school food program funding is being allocated and spent, given that funding is now being received from all three levels of government.

Between the 2015/16 and 2024/25 school years, the City of Vancouver allocated funds to the VSB's "Food4Schools" meal program totalling \$2.8M in response to a gap in funding for school food programs. The funding situation has recently changed, with the BC Government's *Feeding Futures* Fund providing BC schools \$214M over three years (2024-2026), from which the VSB has received approximately \$5.6M annually. Additionally, the National School Food Program (NSFP) provides BC schools \$39.4M over three years (2025-2027), of which \$125,725 was allocated to the VSB for the 2024/2025 school year.

#### **DISCUSSION**

Restore City Funding: Funds from the City's operating budget have been identified to extend the VSB funding for one additional school year (September 2025 – June 2026). City staff will bring an allocation recommendation in the next Community and Social Service Grants report to Council, expected November 2025. Subject to Council's approval, shortly thereafter, the VSB will be provided a new grant agreement to be signed that will enable the payment to proceed.

Secure Alternative Funding: On June 23, 2025, the VSB passed a motion directing their staff to report back on barriers and fundraising efforts to achieve a Universal School Food Program.<sup>1</sup> In July 2025, City staff met with VSB staff to offer support for VSB-led advocacy efforts to senior government for increased funding allocations for the VSB's school food programs. City staff provided the VSB with information or analysis to contribute to developing the case for greater funding to Vancouver schools.

Clarify School Food Funding Utilisation: The VSB's 2025-2026 Financial Plan includes a summary of spending from the Provincial Feeding Futures and the.<sup>2</sup> As part of the previous grant agreement, the VSB is required to provide a financial statement at the end of each school year, detailing how City funds were spent and summarising the program's annual outcomes which the VSB has completed (e.g., in 2024-2025 the program served 424 meals

per school day across 17 schools at a cost of \$8.58/meal).<sup>3</sup> The 2025-2026 grant agreement will include this requirement, with additional provisions to confirm spending of the Provincial and Federal funding allocations.

## **NEXT STEPS**

The Community and Social Service Grants report to Council, expected November 2025, will include a recommendation for Council to approve a grant to the VSB of \$325,000 to fund the "Food4Schools" Program for the 2025-2026 school year. If approved by Council the payment to the VSB will be provided shortly thereafter.

Beyond the 2025-26 school year, future year grant recommendations related to the School Food Program will depend on outcomes of VSB efforts to secure alternative funding.
