Re: Request for Access to Records under the Freedom of Information and Protection of Privacy Act (the "Act")

I am responding to your request of March 6, 2025 under the *Freedom of Information and Protection of Privacy Act* for:

Record of the maintenance and replacement of a slide at Aberdeen Park, including the dispatch of temporary barriers, as well as the procurement and installation of the new slide. Date range: June 1, 2024 to March 5, 2025.

Please note, Park Board staff have advised that the playground at Aberdeen Park was installed by contractors in 2009. The Park Board is currently unable to source a replacement slide as the original company no longer makes the same style of slide; however, the Park Board continues to try and locate a similar piece of playground equipment as a replacement that would meet the standards set by the Canadian Playground Safety Institute Standards.
