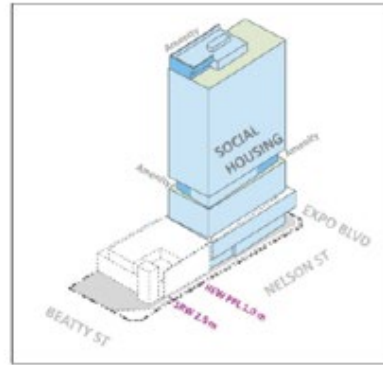
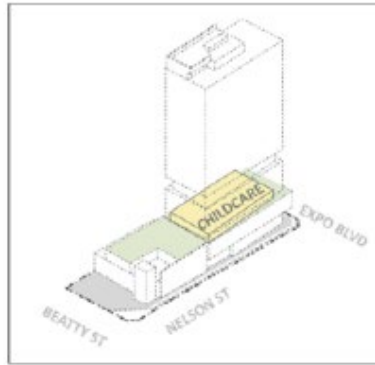
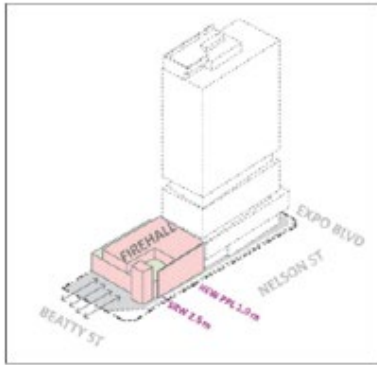
Artist Fees: \$10,000 per artist

Deadline for application: January 4th, 2026 at midnight

Eligibility: Open to artists from xʷməθkʷə́yəm, Skwxwú7mesh Úxwumixw, and səliłwətał Nations

Background

The City of Vancouver is delivering a 28-storey mixed-use building that will include 283 social housing units, a firehall and a childcare facility to serve the Northeast False Creek community. The building is located on a single site measuring 2,882 square meters in area (31,024 sf), and bounded by Beatty Street, Nelson Street, and Expo Boulevard. The development project is considered under the False Creek North Official Development Plan and the Northeast False Creek Plan and set to be delivered for Summer 2028.



The Opportunity

The City of Vancouver's Public Art Program has identified a public art opportunity for three variations of a design to be incorporated at three separate entrances for the building: residential entrance, firehall entrance and childcare facility entrance.

This call is to select three artists, one from $x^w m \theta k^w \acute{a} \acute{y} \acute{a} m$, $S_k w \acute{x} w \acute{u} 7 m e s h$, and $s \acute{a} l i l w \acute{e} t \acute{a} \acute{t}$, to create three separate designs that can be integrated into the exterior ground's infrastructure at three separate entryways using graphic tiles. Fabrication and installation are the responsibility of the City of Vancouver's project team, including associated costs. The selected artist will be required to meet the design specifications below:

1.) *Housing Entrance:*

Dimensions of the artwork: 100 square feet

1.) Firehall Entrance:

Dimensions of the artwork: 90 square feet

2.) Childcare Entrance:

Dimensions of the artwork: 80 square feet

Eligibility

This call is open to artists from Vancouver's local Nations xʷməθkʷəy̓əm, Skwxwú7mesh and səliwətał Nations.

For the purposes of this call, the definition of an artist is a regular practitioner who:

- has completed basic academic training in art or an apprenticeship with an accomplished practitioner in the field, or
- maintains an artistic practice and has publicly shared an independent body of their work for at least two years, or
- is recognized as an artist by arts and culture peers within their community

Submitted applications will be reviewed for eligibility and completeness by City Staff with qualifying applications moving forward to the selection panel for adjudication.

Submission Requirements and Guidelines

Applicants may only submit one Expression of Interest, whether applying individually or as part of a team. The following must be submitted to qualify for consideration:

1. **Contact information:** full name, pronouns, email and phone number
2. **Identity Statement:** a brief statement that identifies your Nation affiliation and any intersectional identities such as gender, disability, etc. (Applicants are only required to share to the extent of their comfort level).
3. **Artist Bio:** (max. 2 paragraphs) a short synopsis of your art practice and any former training
4. **Sample Artwork:** 4–6 images of your artwork, with brief descriptions. Previous public art experience is welcomed, but not mandatory. Accepted formats: JPG, PNG, PDF
5. **Statement of Interest:** (300-500 words) Why are you excited about this project? What does public art mean to you, and how might your participation positively impact your community?

Application and Selection Process

Applications will go through an Expression of Interest (EOI) process, wherein the adjudication panel will select three artist (one from each local Nation) based on their portfolio of past works to enter the stages of creating three separate designs for the three

exterior ground entrances to the housing, firehall, and childcare facility of the building located at 95 Nelson Street. Support will be provided by technical advisors from the project team. The stages of creating the artwork and their deliverables are:

- Detailed Draft Design: A draft digital design showing artwork to 75% for project team to review.
- Concept Proposal: Narrative document outlining approach to the commission, showing examples or rough sketches of what the final work will look like.
- Final Design: Delivery of digital files to the project team.

The overall project timelines are determined by the timeline of construction, estimated to be complete in summer 2028. It is anticipated that the final designs for the entrances will be completed by summer 2026.

Applications will be evaluated by representatives from x^wməθk^wəyəm, S^kwxwú7mesh, and səliwətał. Panelists will be selected based on previous experience with Public Art and Public Realm design.

Criteria for Selection of Artists

The adjudication panel will score applications based on:

- Demonstrated strength and creativity through past work
- Demonstrated ability to produce and present artwork
- Indicated capacity to meet the technical demands of digital design
- Shows meaningful connection to the project and its community impact.
