

Available Funding Programs For Cultural Organizations

Planning/Capital Grants for Cultural Spaces

City of Vancouver Cultural Infrastructure Grants

This Program provides for support for cultural space planning, acquisition, renovation and development. Grants are made to Vancouver-based non-profit cultural groups to undertake projects that strengthen their ability for space development and operation. The maximum level of support from all City of Vancouver sources (including sources such as the Park Board) is 50% of total project cost. Vancouver-based, registered, non-profit cultural societies in good standing with the Province of British Columbia Registrar of Companies may apply. Societies must have been in existence delivering programs and services for a minimum of one fiscal year. Existing cultural space, as applicable, must be owned by the organization, or secured through a long term lease (minimum 10 years which may include renewable terms totaling 10 years).

The CCSF seeks to improve physical conditions for artistic creativity and innovation. It is also designed to increase access for Canadians to performing arts, visual arts, media arts, and to museum collections and heritage displays. The Fund supports the improvement, renovation and construction of arts and heritage facilities, and the acquisition of specialized equipment as well as conducting feasibility studies.

Non-profit arts and heritage organizations incorporated under Part II of the *Canada Corporations Act* or under corresponding provincial or territorial legislation. Provincial/territorial governments, municipal or regional governments, and their agencies, as well as First Nations and Inuit equivalent governments, are also eligible. Federal organizations and federal Crown corporations are not eligible for funding.

This program is funded through a federal-provincial bi-lateral agreement and administered through the Ministry of Municipal Affairs and Housing. The Community, Culture, and Recreation (CCR) Program supports cost-sharing of infrastructure projects in communities across the province including Local governments, including band councils, and non-profit organizations (large projects).

The Enabling Accessibility Fund is a federal Grants and Contributions program that supports community-based projects aimed at improving accessibility through the renovation, construction, and retrofitting of buildings.

From installing automated door openers, constructing a universally designed office or retrofitting a washroom with an accessible toilet, grab bars and taps, the Enabling Accessibility Fund works to enable Canadians with disabilities to participate in their community and the economy.

Since its creation in 2007, the program has funded over 2,200 projects across the country and has improved accessibility for thousands of Canadians.

Capacity and Sustainability Program is designed to assist arts and cultural organizations planning to undertake specific activities that will increase their capacity and contribute to long term sustainability.

The program is intended to assist organizations that can demonstrate a high degree of critical self-reflection. A competitive submission will include analysis of the organization's stage in its life cycle, details of the specific impacts of the current environment, realistic assumptions and explanation of the anticipated results, including the knowledge gained through the project.

A partnership with the City of Vancouver (Cultural Services and social Policy) provides full bursaries for not-for- profit arts or not-for-profit community/social service organizations who are existing City of Vancouver grant recipients or who are primary tenants of City-owned or controlled spaces to attend workshops on board development, performance management and human resources recruitment, as well as longer term Advanced Learning Labs: Executive, Governance and Leaders. An eligible organization may participate in up to four learning opportunities per year (with a maximum of one advanced learning lab).

Other Financial Help
