

# Building Safer Communities Program (BSCP) Vancouver YOUTH ENGAGEMENT PROJECT GRANTS

#### **General Overview of BSCP Vancouver Grants**

The City of Vancouver Youth Safety and Violence Prevention (YSVP) Strategy outlines a comprehensive approach to enhancing the safety and well-being of youth in Vancouver. It aims to address root causes of youth violence and identify community responses that effectively prevent its occurrence and recurrence. Developed as part of the Building Safer Communities Program, the YSVP Strategy primarily focuses on early violence prevention efforts that promote individual and community well-being, safety and belonging in the city. The Strategy sets out a plan to create safer spaces and empower young people and communities to develop and implement solutions.

To support the implementation of Strategy, the City will be administering the Building Safer Communities Vancouver Grants Program between 2023 and 2026. Grants will be available via three unique streams: **Stream 1)** Youth Safety and Violence Prevention Program Grants; **Stream 2)** Organizational and Youth Sector Capacity-Building Grants; and **Stream 3)** Youth Engagement Project Grants.

#### **Objectives of the Building Safer Communities Program Vancouver Grants**

The BSCP Vancouver grants have three primary objectives:

- To develop and deliver early violence prevention programs that address risk factors associated with gun and gang violence.
- To build the capacity of youth-serving organizations to deliver early violence prevention and intervention programs and establish community-based wraparound service models.
- To increase a sense of safety and belonging through youth projects that enhance protective factors for youth violence.

# What are the focus areas for BSCP Vancouver grants?

The focus areas for the BSCP grants are identified in the Youth Safety and Violence Prevention Strategy. The YSVP Strategy is guided by a *vision of a city where youth feel safe, supported, connected, healthy and free of violence.* Focused primarily on upstream early violence prevention efforts and some downstream treatment interventions, this strategy promotes community-based solutions to youth violence.

There are five focus areas and key priorities proposed for collective action. Applications must demonstrate alignment to one or more focus areas and clearly explain how the proposed initiative addresses the priorities included in the Strategy.

We recommend reviewing the <u>Strategy</u> to ensure your application is grounded in its focus area and respective priorities. The strategy also features in the research insights that may assist in developing a strong case for funding.

In addition, the Building Safer Communities Program Vancouver will be implementing an outcomes-focused approach to evaluation. If your grant application is successful, grantees will be required to complete an annual grant report and participate in evaluation activities with the support of the City's evaluation consultant.

#### **Basic Eligibility Criteria**

- Be a registered non-profit society, community service, co-op or social enterprise wholly owned by a non-profit and in good standing with the Registrar of Companies; OR, be a registered charity, in good standing with the Canadian Revenue Agency; OR, be a First Nations Band:
  - Please note that if you are not registered as one of the above you may partner with a fiscal sponsor that is a registered non-profit society or registered charity in order to meet this requirement.
- Demonstrate accommodation, welcoming and openness to people of all ages, abilities, sexual orientation, gender identities (including trans\*, gender-diverse and two-spirit people), ethnicities, cultural backgrounds, religions, languages, under-represented communities and socio-economic conditions in its policies, practices and programs, except in instances where the exclusion of some group is required for another group to be effectively targeted;
- Have an independent, active governing body composed of volunteers. The bylaws must have provisions that no staff member can be a voting member of the board or executive;
- Be in compliance with the Canadian Charter of Rights and Freedoms and the British Columbia Human Rights Code;
- Have the demonstrated functional capacity and sufficient resources to deliver the programs or work to which the City is being asked to contribute; and,
- Deliver the funded program in Vancouver, to Vancouver residents or to Vancouver based non-profits.
- Note: Youth Engagement Project Grants must be supported by an organization that meets all above eligibility criteria.

# Stream 3: Building Safer Communities Program (BSCP) Youth Engagement Project Grants

BSCP Youth Engagement Project Grants aim to increase a sense of safety and belonging among Vancouver youth through youth-led projects that build leadership and social-emotional skills that prevent youth violence. Initiatives must incorporate a peer-to-peer approach to project implementation. Projects should focus on addressing factors that reduce the likelihood of youth becoming victims of violence or engaging in violent behaviours.

Proposed projects must align to at least one of the five focus areas area identified in the City of Vancouver Youth Safety and Violence Prevention Strategy. Applicants should clearly explain how the project addresses the priorities included in the Strategy.

A youth-friendly version of this information package and application will be available in November 2023.

Grant type: 1 year project grant, up to \$10,000 per grant Call for applications: January 2024 and January 2025

Applications open: January 8, 2024 Deadline to Apply: February 5, 2024

#### **Funding Guidelines:**

BSCP Youth Engagement Project Grants must:

- Be a youth-led initiative;
- Deliver a project to improve youth safety and well-being in local communities or neighbourhoods by strengthening protective or reducing risk factors associated with youth safety;
- Address issues identified by youth that affect safety, well-being and belonging in Vancouver:
- Have a host non-profit organization to support the administration of the grant. (If the
  youth group does not have a host organization please contact a planner at
  socialpolicygrants@vancouver.ca.)
- Project must be completed by December 2024
- Programming must occur in the city of Vancouver

#### Eligible expenses:

Funds may be used for expenses that relate directly to the proposed project:

- Professional and consultant costs
- Recruitment and training costs
- Costs associated to conferences
- Travel, accommodations and related expenses
- Rental fees for venues
- Project supplies and materials
- Translation and simultaneous interpretation costs
- Meals and refreshments for participants in activities or workshops related to the project
- Honoraria
- Culturally appropriate expenditures, including gifts for community feasts, ceremonies and ceremonial meals, gatherings and circles (for a maximum of \$100 per gift expenditure).

## Ineligible expenses:

- Capital equipment;
- Administration and staff costs for the host organization
- Activities that take place outside of the project or expenses incurred prior to the approval
  of the project.

## **How to Apply:**

#### Deadline to apply is February 5, 2024

All applications will be accepted via email at socialpolicygrants@vancouver.ca

Note to the host organization: Administration of the grant including completion of grant agreement, payment and reporting must be done through VanApply under the host organization's account. If your organization does not already have an account in VanApply, you will be asked to create one if the grant application is successful.
