WHAT IS THE RESIDENTS REQUIRING ASSISTANCE STICKER FOR?

Why should I use a sticker?

The residents requiring assistance sticker is a part of a voluntary program.

This program allows residents who may need assistance during an emergency evacuation to make their needs known to building management and the fire department. A list of residents requiring assistance is placed in the building's Fire Safety Plan box, which can be accessed by the fire department during emergencies.



HOW IT WORKS





- 1. Residents who require assistance during evacuation are encouraged to:
- Inform their building manager and request to be added to the list of persons requiring assistance.
- Review the emergency procedures in the building's Fire Safety Plan.
- Prepare a Personal Evacuation Plan tailored to their needs.
- See Evacuation Planning for people with disabilities on preceding page.
- Participate in fire drills at least once per year (with or without alarm bells).

2. Fire Safety Plan (FSP) Box

- A sticker (see image above) should be placed on the outside of the FSP box located in the building lobby.
- The List of Residents Requiring Assistance should be placed inside the FSP box, taped to the back of the box cover (See image above).
- If there is no FSP box, the building manager should be advised to purchase and install one.
- The FSP box should be secured with a padlock. The building manager must retain the key to update the list as needed.

3. Annual Review

The following should be reviewed and updated at least once per year:

- The List of Residents Requiring Assistance
- The building's Fire Safety Plan
- Each individual's Personal Evacuation Plan

In addition to annual review, the list of people requiring assistance should be kept up-to date when there are new occupants and/or a resident's ability level changes.
