## 2. Vancouver Heritage Register Upgrade Project

Emiliee Lawrence, Heritage Planner, led the review of a presentation titled "Vancouver Heritage Register Upgrade" and highlighted:

- The Vancouver Heritage Register (VHR) recognizes the diversity of Vancouver and the need to protect its assets
- The City of Vancouver (City) recognizes registers are colonial tools that have perpetuated the erasure of Indigenous peoples
- Registers prioritize architectural values over cultural and social values
- Previous registers utilized a material-based approach to conservation
- Three main pillars of the project:
  - Understanding
  - Planning and managing
  - Sharing
- The VHR is a preliminary tool for the identification and recognition of heritage values
- The VHR reflects the culture and heritage of Vancouver
- History of the VHR
- The VHR has 2,400 listings:
  - Buildings are the most prevalent
  - Streetscapes
  - Landscape resources
  - Archeology sites
- The purpose of the project is to change or upgrade the VHR to be able to identify, embrace and celebrate a broad range of places with social cultural and historic values, based on principles and reconciliation, diversity and equity
- The project is in Phase 1:
  - Expectation that a report will be submitted to Council for approval in 2023
- The project's draft goals and guiding principles are aligned with the Vancouver Heritage Program.

Discussion ensued on:

- Requested feedback from the community regarding structures included in the VHR
- Community consultations have begun with First Nations
- The three local First Nations will specify structures and sites to be included in the VHR
- Challenges with identifying intangible areas of heritage
- Potential for identification of archeological discoveries
- The importance in recognizing other immigrant cultures
- Various groups will be consulted regarding content to be included in the VHR.
