# **Background**

At the Council meeting on November 16, 2021, Council passed the following motion:

THEREFORE BE IT RESOLVED THAT Vancouver City Council direct staff to prepare a suitable amendment to the City's *Procedure By-Law* No. 12577 to the effect that rising to speak at regular Council meetings shall be optional and at the discretion and preference of individual members of Council;

FURTHER THAT staff be directed to report back by the end of Q1 of 2022 on the specific history, circumstances, and reasons whereby members of Council have been – and are currently – required to rise in order to speak at regular Council meetings, with the intent being to document this information as a matter of civic historical and cultural interest.

This memo provides an update and response to this motion.

### **Procedure By-law Amendment**

The first paragraph of the motion directs staff to prepare an amendment to the *Procedure By-law* to provide that rising to speak at Council meetings be optional. The by-law amendment will be included in the list of by-laws for Council's consideration at the March 1, 2022, Council meeting. The proposed language strikes section 6.2 which currently reads:

## Speaking

- 6.2 When questioning or speaking, a Council member must:
  - (a) rise unless a disability prevents the Council member from doing so;
  - (b) wait for recognition from the Chair;
  - (c) only address the Chair; and
  - (d) only speak to those matters referred to in and permitted by this by-law.

and replaces it with:

## Speaking

- 6.2 When questioning or speaking, a Council member:
  - (a) may rise if the Council member chooses to do so;
  - (b) must wait for recognition from the Chair;
  - (c) must only address the Chair; and
  - (d) must only speak to those matters referred to in and permitted by this by-law.

#### History of rising to speak at Council meetings

This section of the memo is in response to the second paragraph of the motion which directed staff to report back by the end of Q1 of 2022 on the specific history, circumstances, and reasons whereby members of Council have been – and are currently – required to rise in order to speak at Council meetings, with the intent being to document this information as a matter of civic historical and cultural interest.

City of Vancouver Archives staff reviewed a number of Council Procedure By-laws including By-law 32 (1887), By-law 516 (1905), By-law 2439 (1937), By-law 3792 (1959), By-law 7253 (1993), By-law 8554 (2002), By-law 9756 (2008) and By-law 12577 (2019). The first Procedure By-law 32 (1887), states "Every member previous to his speaking to any questions, or motion shall rise from his seat and shall address himself to the Mayor or other Presiding Officer." Council members have been rising to speak at Council meetings since the very beginning. This direction carries through all subsequent revisions of the Procedure By-laws.

By-law 9756 (2008) is the first Procedure By-law that mentions Council members do not need to rise to speak at a Standing Committee meeting (Section 13.4 of Section 13: Standing, select, and Council Committee procedures). By-law 9756 (2008) was amended by By-law 12577 (2019) and retained the direction that a Councillor does not need to rise to speak at a Committee meeting (Section 5.7 and 5.12). This provision has not been affected by subsequent amendments to By-law # 12577.
