## 1. Environmental Branch Reviews

Please remember that Environmental Branch review still requires hard copy drawings with appropriate seals and stamps. Please distribute two original copies to the 5<sup>th</sup> floor reception desk at the Crossroads building, 507 W Broadway. When the Environmental team have reviewed and applied their stamps, they will deliver the originals to the Building Review Branch to be included in the permit package.

### 2. DCC WORKSHEET

TransLink has introduced a new DCC that the City will start collecting on their behalf in January. Any CP who may have already submitted the old form, must resubmit this new form if their BP is not issued prior to January 15, 2020. Translink wants more specific area break-downs than Metro Vancouver so the combined form is more detailed than the previous version. DCC clerks will use the area calculations to determine the fees payable to the two agencies. The process for CP projects hasn't changed - fill out the new form and submit with CP stamp to DCLCoordinator@vancouver.ca Reminder: the Use definitions do not match VBBL major occupancy classifications. #### 4. <u>VBBL2019</u>

The printed version of the VBBL2019 will be open for ordering starting early January please check <u>Queens Printer website</u> to order.

#### 5. <u>REFUND OF PERMIT FEES</u>

Reminder: As indicate with the new expanded language of the VBBL2019 under Division C, Article 1.6.4.5 - a <u>WRITTEN REQUEST</u> for your refund now has a 90 day time limit. Please remember to request your refund within 90 days following the issuance of the FINAL occupancy permit.

#### 6. <u>REMINDER</u>

Please remember to put the proper development permit (DP) number on your application forms when submitting your application on line. Information is critical to the completeness check and it would be appreciated that all forms, detailed descriptions and information pertinent to your project are there. #### 7. CP COURSE 2020 Reimbursement cost for your staff

It has been brought to our attention that there is a possibility of a grant for any of your staff who plan to take the CP course. Contact WorkBC about the grant if you are the employer to apply on behalf of your students. The students must be hired after training has been completed. The provincial training grant will reimburse as much as 60% back.
