## Community Update #1 – July 2014

### Chinese Society Building Grant Program

As one of the Quick Starts to implement the DTES Plan, staff are developing a matching grant program for Chinese Family Clan and Benevolent Societies in Chinatown. On July 8, 2014 Council heard a presentation, considered the staff report, and referred it to the Standing Committee meeting the following day to hear from speakers. After Council heard from speakers and read letters, it approved the recommended grant program and strategic support for the rehabilitation of the Chinatown Society heritage buildings. A consultancy will be undertaken as part of this work in partnership with the Chinatown Society Heritage Building Association. ### Single Room Occupancy (SRO) Hotel Strategy

Improving conditions for SRO tenants is a key housing goal of the DTES Plan. The Chief Housing Officer now has the ability to approve Single Room Accommodation By-law permits for upgrades to non-market SROs and these upgrades can be further supported through \$5,000 per door grants to non-profit operators. Staff are also in the process of developing the call for proposals for the \$40,000 grant to a non-profit with expertise in mediating landlord/tenant conflict and assisting through the Residential Tenancy Branch arbitration process. It is anticipated that the call for proposals will go out in late summer with a recommendation to Council on the successful applicant in early fall. ## Mayor's Task Force on Mental Health and Addictions

The Task Force has been meeting since December and includes several members from the former DTES LAPP committee (community agencies and low-income caucus) as well as people with lived experience, government, health authorities, community agencies, the Vancouver Police Department and academic leaders. Examples of a few of the actions specifically focused on the DTES include:

- Engaging partners in discussions for an Aboriginal Healing and Wellness Centre as part of a Vancouver Urban Aboriginal Wellness Strategy;
- Creation of a community 'Dialogues' project to raise awareness of poverty and stigma;
- Piloting transformative education sessions with BIAs as part of Good Neighbour Program;
- Enhancing peer navigator roles for people pre/post crisis; and
- Enhancing youth engagement and range of services in partnership with Inner City Youth, Ray-Cam Co-operative Centre, Watari, and other key partners.

A report including a full summary of key principles and actions to guide the next phase of work will be delivered to Council in July (available on the website prior to the Council date). ## Community-based Monitoring

In response to Council direction, we are currently researching community-based monitoring models to learn more about best practices from other cities. This will help develop and shape how we monitor the pace and impact of neighbourhood change in the DTES.

## Joint Business Improvement Association Survey

Ongoing engagement with local businesses is key to many of the local economy actions in the DTES Plan, and is important to shape and support the economic health and future of our communities. Working in collaboration with the Chinatown, Hastings Crossing, and Strathcona Business Improvement Associations, a neighbourhood-wide joint-BIA survey of businesses is currently underway. This survey will help further our understanding of the characteristics of the local businesses that make up our neighbourhood and help to identify linkages and opportunities for partnership, local procurement, business-to-business networking, and much more.

## Community Economic Development Strategy

In response to the Council mandate, work has begun on developing a Community Economic Development strategy to complement the Local Economy chapter of the DTES Plan. Earlier this spring the City of Vancouver, in partnership with Simon Fraser University and Hastings Crossing Business Improvement Association, held a series of six strategic sessions to explore the various components and approaches of Community Economic Development strategies. This learning opportunity has provided a strong foundation and good direction for the CED strategy going forward. This summer, we will begin targeted outreach with a range of stakeholders and the broader public to ensure everyone has the opportunity to be involved and share their input.

## DTES Street Market and Street Vending

We have begun work on finding a more permanent location for the DTES Street Market for safer survival vending, and opportunities for sale of locally-produced arts and crafts, which is one of the quick-start actions concerning survival vending in the DTES.
