Harmony Cornwell, Chair, called the meeting to order at 4:08 p.m.

1. Introductions and Welcome

The Chair acknowledged the unceded ancestral territories of the Musqueam, Squamish, and Tsleil-Waututh First Nations and thanked them for having care for this land.

- 1. Recognizes and supports the work to upgrade the Vancouver Heritage Register to be able to identify, embrace and celebrate a broad range of places with social, cultural and historic values, based on principles of reconciliation, diversity and equity; and
- 2. Requests ongoing periodic engagement and clarification on opportunities for involvement by Committee members, specifically related to the conservation of the Gastown Historic District (HA-2).

3. 23 West Cordova Street – Blood Alley Square Mural Project

The Chair reviewed the proposed motion for the mural project in Blood Alley Square, 23 West Cordova Street.

THAT the Gastown Historic Area Planning Committee:

- Supports the proposed murals (two at ground level of north elevations, facing Blood Alley Square; one on east elevation facing Carrall Street on 23 West Cordova Street, the Blood Alley Mural Project (DP-2-22-00539), presented by 23 Cordova Holdings Inc.;
- 2. Requests that, in addition to the anti-graffiti coating, the murals are maintained and kept in good condition throughout their time on the building of 23 West Cordova Street; and,
- 3. Suggests that historical information (via plaque or QR code) be included to share the historical references depicted in the murals.

CARRIED (Abstained: Alyssa Myshok; Opposed: Jurian ter Horst)

Discussion ensued on:

- Concerns regarding the murals in Gastown
- Clarification regarding the interpretation of an abstention
- Historic areas of Vancouver are subject to differing regulations regarding building upgrades and renovations.

As a result of the discussion, the GHAPC members agreed to hold a second vote on the Blood Alley Square Mural Project.
