Home Owner Grants IMPORTANT UPDATE

Claim your home owner grant online at gov.bc.ca/homeownergrant

Starting this year, the City of Vancouver can no longer accept home owner grant applications. Instead, you must submit your application directly to the Province at: gov.bc.ca/homeownergrant
Be sure to apply for your grant before the property tax due date to avoid late payment penalties.

BEFORE CLAIMING YOUR GRANT

When claiming your grant at gov.bc.ca/homeownergrant, you will need to enter your **Jurisdiction** and **Roll Number**. This information can be found on the remittance stub of your property tax notice.

NOTE: Your Access Code or Folio Number are not required to claim your grant, you will only need this information when paying your tax notice.

AFTER CLAIMING YOUR GRANT

After you get confirmation that your grant submission was successful, it may take 3-4 business days for your City of Vancouver tax account balance to update. Ensure that you have arranged for payment of the balance (reduced by your eligible grant amount) before the property tax payment due date.

Your property tax notice indicates the remaining **TOTAL TAXES DUE**, based on the grant claimed:
