# **PROJECT UPDATE**

Over the last few months the impacts of COVID-19 have been felt throughout our community. During this time, the City of Vancouver has followed public health orders and introduced physical distancing measures to slow the spread of COVID-19. These measures have resulted in the city-wide suspension of in-person public engagement events, such as open houses, workshops, and pop-up activities. As a result, the Jericho Lands planning team cancelled public engagement events planned through the spring and summer 2020.

In light of these cancellations and current physical distancing measures, the Jericho Lands planning team has been looking at alternative ways of engaging community members and keeping you informed of project updates. This newsletter is one of them! This issue includes:

# About the Jericho Lands Planning Program

The policy statement is being developed at the request of the landowners, a joint venture partnership between the Musqueam Indian Band, Squamish Nation, and Tsleil-Waututh Nation ("MST") Partnership and Canada Lands Company ("CLC").

The Jericho Lands Policy Statement is being created in consultation with the community, landowners, and other stakeholders before being presented to Council for consideration.

# WHAT IS A POLICY STATEMENT?

A policy statement is a guiding document that establishes principles, objectives, and policies relating to a range of topics. These include:

- Reconciliation;
- Mix of Uses;
- Density, Building Types and Heights;
- Mobility;
- Sustainability and Infrastructure;
- Ecology, Parks and Open Space;
- Community Amenities; and
- Devial and and Discourse

The Jericho Lands planning program was launched in March 2019. It is a comprehensive planning process which will lead to the creation of a policy statement to guide future development of the Jericho Lands. Development Phasing

Once adopted by Council, the Jericho Lands Policy Statement will inform future rezoning and redevelopment of the site.

# WHAT WE HAVE HEARD SO FAR...

Phase 1 of the Jericho Lands planning program was an information gathering phase. It was an opportunity for City staff and the landowners to listen to your ideas, concerns and aspirations, while learning about key issues and opportunities for the future Jericho Lands.

Since launching the planning program, the City's project team and the landowners have co-hosted a variety of public engagement events. At these events we have connected with thousands of community members. City staff have analysed the public feedback and summarised the findings in a series of documents. Below are the "Emerging Themes" we initially shared in fall 2019. A more detailed summary of what we have heard so far is available on our new project web page (shapeyourcity.ca/jericho-lands).

The Phase 1 public feedback has been used to inform the development of the draft Guiding Principles (see page four) and will continue to inform future discussions as the planning process moves forward.

# **EMERGING THEMES**

The emerging themes are a high-level summary of the Phase 1 public feedback. They are intended to provide a brief snapshot of what we have heard so far.

#### RECONCILIATION

A desire to support the Musqueam, Squamish, and Tsleil-Waututh Nations in their stewardship of the Jericho Lands. Support for reflecting the full history of the site, including how members of the Nations lived and continue to express their culture today. Interest in exploring opportunities to embed Musqueam, Squamish and Tsleil-Waututh identity and traditions, into building and design elements, site planning, sustainable practices, public spaces and names, as well as in supporting cross-cultural connections and understanding.

## HOUSING OPTIONS

Interest in creating a variety of housing forms and types, including family-oriented and senior appropriate homes. Strong support for more housing options which are affordable to low-income residents such as social housing, as well as opportunities for purpose-built rental, student, and middle-income housing. Strong support for low-rise buildings with some interest in mid-rise and varied interest in high-rise forms of development. A desire for buildings to respond to the site's topography and for future development to be considerate of transitions to the surrounding community.





# **GREENSPACE & PUBLIC SPACE**

Strong support for retention of some of the greenspaces, mature trees, and open spaces that currently exist on the site. Interest in exploring opportunities for naturalisation, reintroduction of native plant species, introduction of pollinators, and daylighting of historical streams. Interest in creating a variety of parks and public spaces that accommodate rest and reflection. public gathering, and that are child and dog-friendly. A desire to respect the unique topography of the site and frame public views of the water, North Shore Mountains, and downtown, especially those experienced from Trimble Park.

### **SUSTAINABILITY**

Support for constructing buildings that use sustainable methods and practices. Green building techniques, energy efficiency, and conservation are seen as the primary means of reducing the environmental impact of future development. Interest in emphasizing sustainable modes of transportation to reduce dependency on cars and supporting a shift to emissions-free vehicles. A desire to utilise green infrastructure, naturalise open spaces, and support local food and agricultural production. The importance of sustainable energy systems and provision of exceptional recycling systems and/or facilities is recognised. A desire to consider the future impacts of climate change and technology advances in site design.

#### **COMPLETE COMMUNITY**

Support for creating a neighbourhood with a mix of residential, commercial, and job spaces. The provision of smallscale, locally-serving, retail and services, as well as communal spaces accessible via walking and cycling is desired. An interest in creating a fine-grained street pattern, a variety of building designs, and for construction materials to be of high-quality. Buildings with shared social spaces are supported. There is also a desire for new commercial development to complement existing local businesses in Point Grey Village and other local commercial areas.

Strong interest in creating new and/ or improving community amenities, including a community centre, indoor and outdoor recreational facilities, and a library. The provision of more childcare facilities and the renewal of existing and/or development of new schools on site is desired. Interest in continuing existing community programming and providing a range of options for children and seniors. Support for community gardens, communal and/or public gathering spaces, and arts and cultural

#### **CONNECTIONS**

Support for improved access to and through the site by providing enhanced connections to the water, adjacent parks, and the broader city. Interest in improving the pedestrian environment along and across West 4th Avenue. A desire to create a network of accessible pedestrian and bicycle-friendly routes through the site, as well as to improve the existing transportation network by enhancing bus service and exploring community shuttle options. Interest in reducing dependency on cars by creating a car-lite community. Broad interest in providing a SkyTrain station on or near the site, as part of an extension to UBC.











# Reflect and respect the past, present and future legacies of the Musqueam, Squamish and **Tsleil-Waututh**

The past, present and future of the Musqueam, Squamish and Tsleil-Waututh people guide their connections to the land and ongoing stewardship of the Jericho Lands. Generations of history at ?əy'alməx<sup>w</sup>/ ly'álmexw and the cultural values and identity of the three Nations are integral to the redevelopment of the Jericho Lands with nature at the centre. Indigenous values, reconciliation and intergenerational and intercultural exchange and gathering will be embedded as founding principles in the design and expression of the Jericho Lands policies.

# **Respect the** Land

The Jericho Lands will be a world leader in sustainability and ongoing environmental leadership. The site design will embrace the ecological legacies and unique existing features, like the ridgeline, urban forest, and wildlife habitat, melding these with watershed thinking to explore recreating streams and managing rainwater. Development and infrastructure will complement this setting and respond to the broader climate emergency. Interlinked, successional systems should work in unison to support biodiversity, ecological corridors, and replicate regenerative natural systems. Resilient design will reduce the risks from climate change and sea level rise while allowing for adaptation over time.



All people will feel welcome on the Jericho Lands. The site will create a robust network of spaces expressing Indigenous values and history in their design and function, with indoor and outdoor places for people to gather, with parks and outdoor space ranging from wild spaces to urban plazas. The Lands will be designed for equity and inclusion, supporting a multitude of artistic and cultural practices that help bind the neighbourhood together. Public spaces will be intergenerational and multicultural, supporting social resilience and connections as part of a healthy, thriving community.

# Cohesive Community

The Jericho Lands will be a transformational space, seamlessly interweaving nature and city together as a new community hub. The Lands will integrate with the surrounding neighbourhoods, re-energizing nearby high streets, and tying the ridge to the sea. Future residents will be part of a vibrant community with opportunities to live, work, play, learn, shop and create within a short walk or easily accessible by transit. Arts and culture will be tangible, with opportunities for creation, display and performance. New public amenities and facilities will be hubs of social connection and activity, reinforcing the role of the Jericho Lands within the neighbourhood and city.

These draft Guiding Principles are based on community feedback, City of Vancouver objectives and policies, and the landowners' aspirations. The Guiding Principles will provide high-Jericho Lands Policy Statement.

# Design for the **Future**

Change and growth on the Jericho Lands is a long-term project that will be at the forefront of innovation and adaptation. The site will be designed for resiliency and adaptive to changes in climate, mobility and how we live, work and build. Innovative building methods and materials will form the foundation for a green and sustainable future. This low carbon community, embodying a passive approach that embraces the natural world, will mark the Jericho Lands as a visionary blend of ecological and urban systems.



Enhance access and mobility with more options and opportunities for people to move easily within the Jericho Lands, surrounding neighbourhoods, parks, city and region. Future rapid transit will anchor the site and bring people to this special location, linking it to the broader city and region. The unique terrain of the Lands will shape movement patterns, corridors and connections and build a network for green mobility by foot, bike and transit. These networks will connect to the surrounding neighbourhoods, tying them together and reinforcing safe, healthy places for wellness and gathering. Innovation and emerging technologies are opportunities to minimize car dependence, rethink parking strategies and reduce carbon emissions.



The Jericho Lands is a place of gathering. The past, present, and future of the Lands and of Vancouver are an opportunity to create a place that evolves as time passes and will meet the needs of generations to come. Its location - along the ridge to the sea, connected by transit, and between the largest job centres in the province - will complement the unique Indigenous cultural experience of the Jericho Lands, making it a unique space. The Jericho Lands will be a global precedent, learning from emerging best practices to show how a new form of city building and urbanism will take root and grow into a unique community.

#### A Place to Call Home

The Jericho Lands will provide substantial new housing, with a range of options for households of different incomes, ages and needs, from students to families to seniors, while creating opportunities for intergenerational living and learning. Different households and building types will be integrated, sharing common spaces and amenities integrated into the buildings and offering social connections and community. Residences will be designed with wellness and inclusiveness in mind, with spaces adaptable to needs that change over time.

# A WORD FROM THE LANDOWNERS

The landowners team has grown. In late 2019 they hired Cultural Liaisons from the MST Nations, and at the beginning of 2020, they retained Urban Strategies Inc. (USI) to lead their design team. As the project moves forward USI will work collaboratively with City staff, members of the MST Nations, the community, and other interested groups to develop a site concept for the Jericho Lands.

#### **MEET THE DESIGN TEAM**

The joint venture partnership is pleased to introduce our cultural

Urban Strategies Inc (USI), is honoured to have been selected by the joint venture partnership of Canada Lands Company (CLC) and the Musqueam Indian Band, Squamish Nation, and Tsleil-Waututh Nation Partnership (MST) to lead the preparation of a master plan to inform the City of Vancouver's Jericho Lands / ?ayalmaxw / Iyalmexw Policy Statement planning process.

USI is a global planning and urban design firm based in Toronto, well-known for their innovative approach to planning and design as demonstrated in projects such as Mirvish Village and Reimagine Galleria in Toronto, LeBreton Flats in Ottawa, and Surrey City Centre. The project team combines deep local understanding of the site and national and international planning, design and engineering expertise. The core team includes: Formline Architecture, a Vancouver-based Indigenous design firm specializing in environmentally and culturally-sensitive architecture; PFS Studio - Landscape Architects; and Hariri Pontarini Architects - all celebrated Canadian design professionals with whom Urban Strategies has collaborated successfully across multiple projects.

The design team recognizes that the 90-acre Jericho Lands / ?əyalməxw / Iyalmexw is a culturally and spiritually significant place for the MST Nations. Jericho presents an opportunity for the three Nations to express their fundamental connection to the land, while bringing forward new opportunities for prosperity for future aenerations.

#### **DEVELOPING A DEEPER UNDERSTANDING OF THE SITE AND TOPIC EXPLORATIONS**

Since being retained the design team has worked to develop a baseline understanding of the site through technical reviews, engagement with the cultural liaisons, review of Phase 1 feedback, and analysis of City policies.

In the coming months, they will work with the City project team to share a series of 'topic explorations'. The teams will work with the MST Nations' communities, broader community, and interested groups to seek input on these explorations, build a deeper understanding of the Jericho Lands, and the opportunities it presents. Indigenous values will be embedded in all aspects. The topic explorations are anticipated to include:

• Considering the role of the Jericho Lands within the city and region; Designing with nature and ecology;

- Fostering livability and social well-being;
- Increasing connectivity;
- Supporting a resilient and low-carbon future; and
- Understanding water systems and green infrastructure.

The topic explorations will build on the feedback received during Phase 1 of the planning program and the draft Guiding Principles. They will provide important input into the development of a site concept

#### **JERICHO LANDS PROJECT TIMELINE**

The Jericho Lands planning program is a multi-year process with multiple phases that will result in the development of a policy statement.

Once the policy statement is approved by Council, the landowners will be required to submit a rezoning application. On a project of this size, multiple phased applications are anticipated. The rezoning process will include multiple opportunities for public consultation.

#### **TOPIC EXPLORATIONS AND DEVELOPING A SITE CONCEPT**

In the coming months, the landowners' design team will work with the City project team to develop and share the topic explorations. Information will be shared on the project web page and opportunities will be provided for you to give your feedback on the materials.

The topic explorations will provide an important input into public engagement activities provisionally scheduled for



the fall 2020. These engagement events will seek to develop an early site concept for the Jericho Lands.

Given the evolving nature of the current public health emergency, the structure of these events will respond to the public health orders in place at that time.
