

**Leisure Access Program** 

## Self-Refer Application 2025–2026

Leisure Access provides **residents of the City of Vancouver with low-income** access to recreation programs & services at a reduced cost. Includes pools, fitness centres, rinks, and community centres.

# Four options are available when completing a Self-Refer application.

Fully complete the application form and include proof of address dated within 90 days.

1. You are a resident with low-income and do not receive income assistance or support from a non-profit or government agency. Your combined family net income (line 23600) on your / your family's 2024 tax year Proof of Income Statement(s) is at or below:

### 2. Child Disability Benefit (CDB)

You have a child (age 0–17) who qualifies for the Child Disability Benefit. Attach your Canada Child Benefit notice (base year 2024), showing the CDB. CDB serves as income verification.

### 3. Disability Tax Credit (DTC)

You, your spouse, or dependent (18+) qualify for the Disability Tax Credit. Include your 2024 tax year Proof of Income Statement (not Notice of Assessment) for each applicant. Your combined family net income is at or below:

#### 4. Employment Insurance (EI)

You currently receive EI. Include your/ your family's 2024 tax year Proof of Income Statement(s) (not Notice of Assessment), Service Canada letter showing start/end dates and benefit rate. Staff will calculate your projected net income. It must be at or below:

# Terms and Conditions (subject to change)

## Definitions

**Family:** 1 or 2 adults (married or common-law) and dependents age 17 or younger. Grandparents, relatives, and dependants aged 18 and older complete a separate Leisure Access application.

**Proof of Address:** Must be dated within 90 days. Acceptable documents include utility bills (e.g. cable, gas, hydro, internet, phone), bank / credit card statements, or a lease agreement.

### Income Eligibility: To qualify for options 1, 3 and 4 your combined family income is:

- Line 12100 (Interest & Investment Income): at or below \$1,000
- Line 12600 (Net Rental Income): at or below \$2,000
- Line 12700 (Capital Gains): at or below \$2,000
- Line 23600 (Net Income): at or below eligibility threshold (page 1)

#### You are not eligible if:

- You live outside the City Vancouver or use a P.O. Box / UPS address
- Your income is above the eligibility thresholds
- You live in UBC or University Endowment Lands
- You are an entrepreneur or investment class immigrant

#### How to get your Proof of Income Statement

- 1. Online: Search "CRA My Account for Individuals"
- 2. By Phone: Call 1-800-267-6999 and press  $1 \rightarrow 1 \rightarrow 1$ You'll need your Social Insurance Number, date of birth, and income reported on line 15000 from your 2024 tax return.

#### **Random verification process**

Applications are randomly selected for verification. You may need to provide documents to verify declared income. Failure to respond within 45 days may result in Leisure Access cancellation.
